## ROUSE RECEIVES PRESIDENTIAL MEDAL OF FREEDOM



James W. Rouse, a 1937 graduate of the School of Law, was awarded the Presidential Medal of Freedom, the nation's highest civilian honor, at a ceremony at the White House on September 28. Rouse, who founded the Rouse Company and retired as its chief executive in 1979, now heads the Enterprise Foundation, a publicly supported nonprofit organization that he also founded to finance and rehabilitate housing for the poor and to bring economic opportunities to impoverished communities. The School of Law extends its most sincere congratulations to this remarkable visionary.

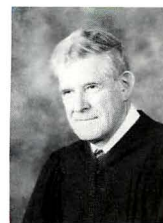
