Virtually everybody we talked to about this project had great things to say about it. Gifford credits three alumni leaders with turning on that light: Frank B. Burch Jr. '74, Chair of the law school campaign; Paul D. Bekman '71, Co-Chair; and Joe Hardiman '62, Chair of the School of Law's Board of Visitors and also Chair of the capital campaign for the University System of Maryland.

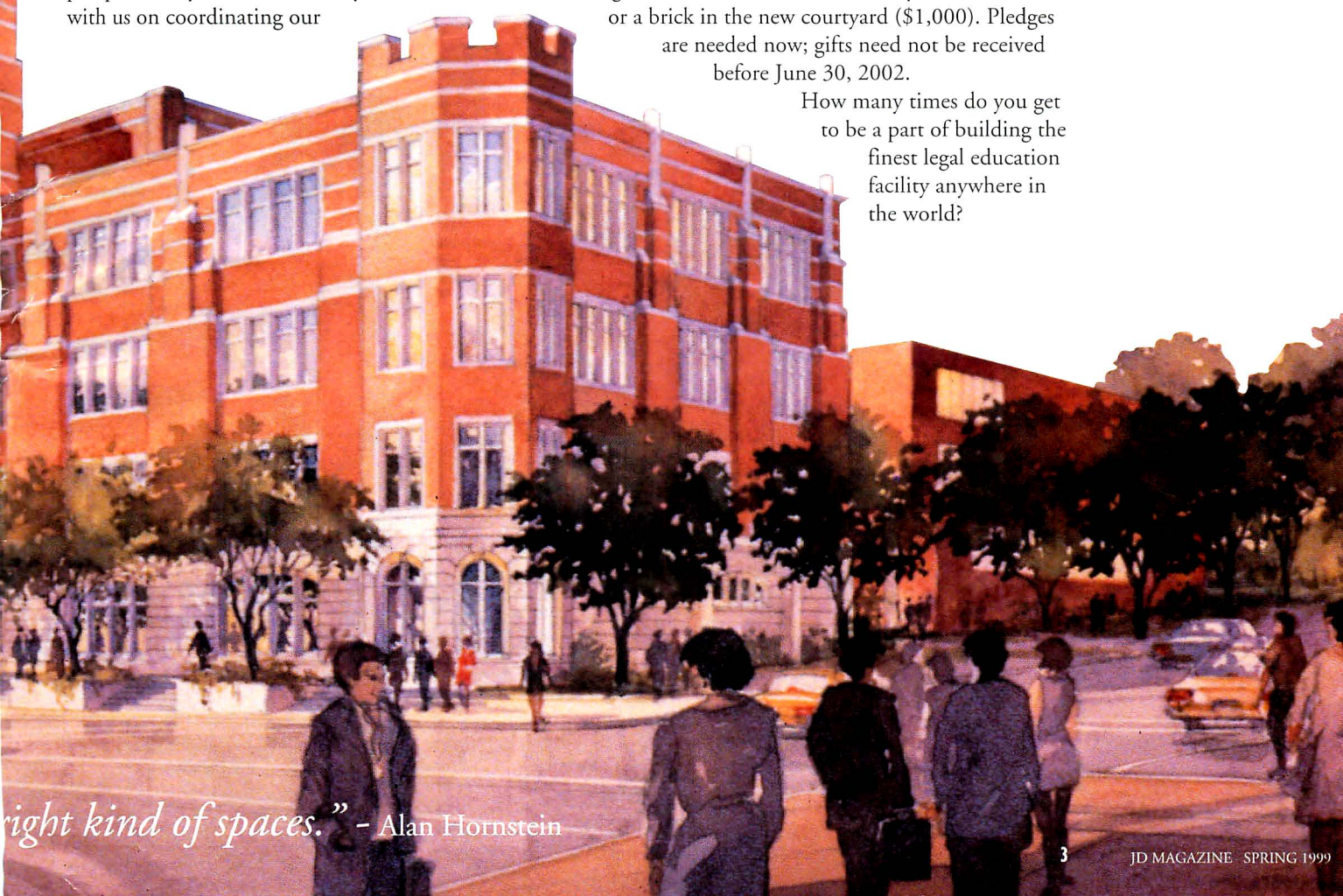
"All three have taken ownership of this effort," Gifford says. "They have personally solicited prospects, they've worked closely with us on coordinating our

strategy. Without their work, we would not have a new building."
