The authors inadvertently pasted the anti-spike plots for the ">70 years" group instead of the pseudo-neutralising antibody plots (pages 808–809) to Fig. 5A and B. These plots replicate the ">70 years" group in Fig. 4A and B on pages 806–807. The authors have confirmed that the error does not affect the

interpretation of the results and the rest of the paper, and the plots for the "<70 years" group in Fig. 5 are correct. The revised Fig. 5 contains the correct plots for pseudo-neutralising antibody data has now been updated in the original publication. The authors would like to apologise for any inconvenience caused.
