1. What library holdings already exist in relevant subject categories, including supporting collections from HELIN. How much money is now allocated in the program area?

The content of this course is interdisciplinary covering two major emphases in the University curriculum and correspondingly in the Library's collections. There are extensive holdings of books both in URI's own collection and those in the other HELIN libraries which can be easily obtained by URI students.

There are also extensive listings of articles in the *Environment Abstracts*, *Sustainability Science Abstracts* and *Sociological Abstracts* databases all of which are suitable for research in a 300 level course. The Library's SerialsSolution software provide links to full text content (where available) from all of these databases. In addition there are listings in the *Academic Search Complete* database which is the Library's "flagship" database for undergraduate research.

The non-print media collection contains a number of films that are appropriate to this topic.

Due to the interdisciplinary nature of the content and its existence already in the curriculum, funding for resources for this course would come from existing funds in the appropriate subject areas.
