This fall, three alumnae are coming home to RWU Law to join me. Drawing on their own student experiences and their outstanding legal practices, they will lead our flagship experiential programs to provide our students with hands-on, practical learning opportunities.



Katie Ahern '07 joins RWU Law in fall 2015 as Director of the Start-up Business Clinic, where students work directly with nonprofit and small-business clients to gain practical transactional lawyering skills. This clinic involves direct client interaction and involvement with the nonprofit and small business community in Rhode Island, and teaches students to represent clients in business-related transactions. Katie returns to RWU Law with tremendous experience from a large Rhode Island Law firm. Prior to directing the clinic, she served as an associate at Hinkley, Allen & Snyder where her legal practice focused on all areas of federal, state and local tax matters affecting businesses, individuals, governmental entities and tax-exempt organizations. She has an LL.M. in taxation from Boston University School of Law and teaches business-law classes at the University of Rhode Island. Katie is a 2011 recipient of the *Providence*

Business News "Forty Under 40" award and a 2015 Super Lawyers Rising Star. Last year, she served as the interim director of the business clinic and is back this year in a permanent capacity.



Jenna Hashway '11 returns to RWU Law as Professor of Legal Practice, our legal research and writing program, and Director of the Judicial Externship Program that places law students in the chambers of federal and state court judges for academic credit including the Rhode Island Supreme Court and the United States Court of Appeals for the First Circuit.
