During World War I, Mrs. Sharpe joined the American Red Cross and went to France as a volunteer canteen worker in 1917.


Married in 1920 to Henry Dexter Sharpe, Rhode Island industrialist and philanthropist,

she came to Providence and through an avid interest in gardens and design, became an amateur landscape artist. For the past twenty years Mrs. Sharpe has landscaped the grounds of Brown University, as well as church and library grounds in Providence, St. Louis, and Athens, Greece.

Brown University honored her with a degree in 1950 and she was awarded the Montague Medal for Civic Achievement by the Garden Club of America. Together with her son, she was granted The Roger Williams Award for distinguished service to the city by the Greater Providence Chamber of Commerce. The Providence Art Club has also bestowed upon her the Benson Medal.

Formerly a Director of the Garden Club of America, Mrs. Sharpe has won two citations from the Federated Garden Clubs. She is a member of the International Committee of the New York Museum of Modern Art; a Director of "Impact R. I." for city beautification, and a Director of the Providence Preservation Society.



THE VERY REVEREND WIL-LIAM PAUL HAAS, O.P. President of Providence College

The Very Reverend William Paul Haas, O.P., is a native of New Jersey. The son of Mr. and Mrs. Joseph J. Haas, he was educated at the West Side High School in Newark and Seton Hall Preparatory School in South Orange. After being graduated from Providence College with an A.B. Degree in 1948, he went on to receive the S.T. Lr. Degree at the Pontifical Institute in Washington, D. C., in 1954. In 1962 he earned his Ph.D. at the University of Fribourg in Switzerland. He was ordained at Washington, D. C., in 1953.

Father Haas taught Theology and Philosophy at Emmanuel College; Philosophy of Education at the Oblate Seminary in Natick, Massachusetts; Contemporary Thomism at the Harvard Catholic Club; and Philosophy at Providence College. He inaugurated a special program of religious studies at Purdue while on the faculty of Notre Dame and conducted courses in Contemporary Christian Thought at the St. Thomas Aquinas Center for Catholic Students. He was also Professor of Contemporary Theology at Wabash College in Indiana. In 1965, he became President of Providence College.

An author, he has written on "The Contemporary Arts" and contributed to learned journals and religious publications. His Ph.D. dissertation on "The Conception of Law and the Unity of Peirce's Philosophy" was published by the University of Notre Dame Press.

His paintings have been exhibited in New England and the Middle West.

A former Regional Chairman of the Catholic College Teachers of Sacred Doctrine, Father Haas is a Director of the Packard Manse Center for Ecumenical Studies, the Rhode Island Philharmonic Orchestra, and International House of Rhode Island. He serves as a member of the Commission on Liberal Learning of the Association of American Colleges, the American Society for Aesthetics, the Butler Hospital, and the Advisory Council on Extension and Continuing Education of the U. S. Department of Health, Education and Welfare.





He is married to the former Frances Council of Durham, North Carolina. The couple has one married daughter.




The Good-Citizenship Award: This award will be presented to James T. Hilliard of 16 Stratford Road, Norwood, Massachu-


The Roger W. Babson Award: The Babson award will go to Alphonse S. Lucarelli of 40 Cliff Avenue, Cranston, Rhode






The Bryant College Award: Brian D. Drought of 58 Sycamore Drive, East Greenwich, Rhode Island, will receive this award. He will receive a se-

### The Very Rev. William Paul Haas, 0.P.

Father Haas became the eighth president of Providence College on July 1, 1965. At the time of his appointment by the Very Rev. Robert L. Every, O.P., Provincial of the Dominican Province of St. Joseph and president of the Providence College Corporation, on March 15, 1965, Father Haas was 37 years old, the youngest man ever named to the post.

Father Haas was born in Newaik, N. J., on May 31, 1927 and received his early education there. His parents, Mr. and Mrs. Joseph J. Haas, now live in Belleville, N. J.

A graduate of Providence College, class of 1948, Father Haas was ordained to the priesthood in 1953 and the next year earned the degrees of Licentiate and Lectorate in Theology at the Pontifical Institute in Washing-

He was assigned to the faculty of Emanuel College, Boston, where he taught philosophy and theology from 1954-1960. During this time he also taught at the Oblate Seminary in Natick, Mass., conducted a three-semester course for the Harvard Catholic Club in problems of contemporary Thomism, and served a term as regional chairman of the Society of Catholic College Teachers of Sacred Doctrine.

He also participated in the original conference at Packard Manse, a center for ecumenical studies in Boston.

In 1962, Father Haas received his Doctorate in Philosophy from the University of Fribourg, Switzerland, where he studied under Professor I. M.

Bochenski. On returning from Europe, he taught philosophy at Providence College for one year.

He joined the faculty of Notre Dame University in 1963 in order to inaugurate the special program in religious studies in cooperation with Purdue University. This program was designed to offer Purdue students the opportunity to take courses in contemporary Christian thought for credit from Notre Dame transferable to Purdue. This endeavor was widely acclaimed as a promising experiment in the delicate area of state education and the formal study of theology.

In 1964, Father Haas also served as visiting professor of contemporary theology at Wabash College, Crawfordsville, Indiana. He was the first Catholic priest ever to teach at this non-sectarian liberal arts col-

In addition to numerous articles in professional journals, Father Haas has published two works, one of the philosophy of Charles Sanders Peirce (The Conception of Law and the Unity of Peirce's Philosophy, The University of Notre Dame Press, 1964), and the other on art, (The Contemporary Arts, The Thomist Press, 1965).

An accomplished artist, Father Haas has exhibited paintings in New England and in the Mid-West.

In 1966, President Johnson appointed Father Haas to the National Advisory Council on Extension and Continuing Education. He also serves on the Association of American College's Commission on Liberal Learning.

Father Haas serves on the Board of Directors of the Rhode Island Philharmonic Orchestra and is a member of The American Society for Aesthetics and of Packard Manse Center for Ecumenical Studies, Boston.






