



COLLEGE MOURNS LOSS OF JEANNETTE CARROLL JACOBS

RECORD ENROLLMENT FOR BRYANT'S 94TH YEAR

More than 700 Freshmen arrived on the campus of Bryant College beginning Tuesday, September 4, bringing the total campus population to 1,600 day school students. This group constituted one of the largest freshman classes ever to enter Bryant.

This year's entering class includes students from twenty-three states and twelve foreign countries including Ireland, Japan, Israel, Korea, the British West Indies, Canada, Greece, and the South American Countries.

In view of this demonstrated desire for higher education in the specialized field of business, it appears certain that the College facilities will continue to be taxed at near capacity.

The Evening Division under the di-rection of Professor Joseph L. Santos has an enrollment of approximately 500 students and is offering degree and diploma programs in many varied fields.

Immediately upon election the abovenamed officers will be installed in their offices, and their term will continue for one year except for the president who is elected for a two-year term.

The Bryant College family deeply mourns the sudden passing of Jeannette Carroll Jacobs, beloved wife of the President, on August 15. As the "First Lady" of the campus, Mrs. Jacobs was revered by faculty, students, and staff. She leaves a great empty space behind her, not only for her enormous contribution to our College life, but in the hearts of all who knew her.

This gracious and gentle lady, who stood devotedly and charmingly by our President's side, was intimately associ-ated with Bryant College for forty years. Before her marriage to Dr. Jacobs in 1933, she was a member of the Bryant College faculty and also held the post of College Publicity Director.

Acting Career

As Jeannette Carroll she had a long and glamorous career as a dramatic actress. She toured the country in many well-known dramas and her interesting experience in the theater was the subject of a full-page feature story by the woman's editor of the Providence Evening Bulletin. Her "stately bearing" and "queenly carriage" were then described as evidences of her fine theatrical training. A leading lady with the re-nowned Albee Players in Pawtucket and Providence, she is vividly remembered by a whole generation of theatergoers in this community. All of her friends here on the campus enjoyed her tales of theatrical road shows and the many interesting anecdotes about "theatregreats" of those days.

A native of Providence and a graduate of Hope High School and the Stanhope-Wheatcroft Dramatic School in New York City, Mrs. Jacobs came to Bryant College as a secretarial student upon leaving the stage. Upon her graduation, she became press manager and it was from this post she gravitated to advertising work.

Know Your Faculty



Dean Elmer C. Wilbur

Dean Wilbur, a native of Rhode Island, is active in a dual capacity at Bryant as Dean of Admissions and Dean of Men. He was graduated from Bryant College in 1913 and entered the Springfield YMCA College to prepare for work in the Young Men's Christian Association. For seven years, he was General Secretary for the YMCA. The Dean completed his studies for the Bachelor of Science in Education degree at Boston University. Later, he received his Master of Commercial Science degree from Bryant. He is also a member of Phi Delta Kappa, an honorary fraternity based on leadership, scholarship, and research.

Dean Wilbur has devoted more than thirty-five years to education, as a teacher and supervisor in both private and public schools. He is a past president of the New England Business Teachers' Association and the Rhode Island Business Education Directors' Club. The Dean has also authored textbooks and many magazine articles on educational subjects.

During World War I, the E. I. duPont deNemours Company employed Dean Wilbur as Village Activities Director. He acted as Industrial Secretary for eleven associated industries of Staten Island Sound until 1921 when the Dean joined the Bryant faculty as head of the Secretarial and Teacher-Training Departments. In 1926, he was appointed chairman of the Business Education Department for the Central High School of Providence, R. I. Dean Wilbur rejoined Bryant in 1946 as Dean of Men.

Widely respected in religious groups, Dean Wilbur was president of the United Protestant Layman's Organization and is affiliated with the United Church Men.

On the personal and informal side, the Dean considers himself a "Gentleman Farmer." He is well known to the Bryant family for his exploits with his tractor on the "Restful Ridge Farm" usually involving valuable crops of "rocks and stones." The fruit of his labors is most properly described as a sprained back.

Dean Wilbur is a serious student of classical philosophy and is also well known, especially to his five grandchildren, for his homespun New England philosophy. Many Bryant students have been "exposed" to his clever wit and good humor. The Dean is respected among antique enthusiasts for his superb collection.

Famous for the friendly smile and warm friendship offered every visitor to his office, Dean Elmer C. Wilbur was recently described by a Bryant graduate as "a good friend to the Bryant man always ready with a good joke and a pleasant speech."

From there he went to Northeastern where he received his Bachelor of Science degree. He took his Master of Arts degree at Columbia University where he also started studying for his doctorate. He finished his studies and received his Doctorate at American International College. He also received an honorary degree from Columbia University.

Dr. Powers served as Director of the National Cost Accounting Association and is a member of the American Association of Commercial Teachers and New England Association of Commercial Teachers. Dr. Powers was mentioned several times in different editions of "Who's Who" for his outstanding work in the business education field.

Now that he has left Bryant, Dr. Powers plans to do some farming on his 335 acres up in Canterbury, New Hampshire. He also plans to keep active in the tax field.

Parkos Appointed to Alumni Post



Gregory T. Parkos of Newport has been appointed Alumni Secretary and Director of Student Activities at Bryant College, it was announced by Dr. Henry L. Jacobs, president.

Mr. Parkos was graduated from Bryant College, magna cum laude, in 1950. He attended Boston University and received his Master's Degree in Business Administration in 1951. While doing graduate work at Boston University, he held a fellowship as graduate assistant to the chairman of the Business Management Division, as substitute instructor and research assistant.

He was subsequently assigned by the armed forces as Special Agent with military intelligence, heading the New England anti-subversive squad. On release from the Army, he lectured on "Operational Techniques of the Communist International".

In March, 1954, he was appointed an officer in the Foreign Service of the Department of State and was stationed for more than two years at the U. S. Embassy in Athens, Greece. He comes to Bryant from the State

He comes to Bryant from the State Department, where he last held the position of Chief of the Escapee Division of the International Refugee Program in Greece.

College, past president of the Business and Professional Women's Club, a charter member and past president of the Providence Woman's Advertising Club. She was the first woman to be appointed vice-president of the Advertising Federation of America and a member of the national board of directors. In 1931, at the International Conference of Federated Advertising Clubs in Berlin, Germany, she was elected President of the Woman's Advertising Clubs of the World.

In 1935 she was appointed Chairman of the Women's Division of the Providence Community Chest Drive and in 1936, she was one of four women appointed by Mrs. Franklin Delano Roosevelt to a National Committee of Mobilization for Human Needs. In this capacity, she was invited to the White House in 1936 for a reception and meeting of this important committee.

President Truman appointed her in 1951 to the Assay Commission, the group that gathers at the U. S. Mint to witness the assaying of silver content of coins in Philadelphia.

The Administration Offices of the College were closed the day of her funeral, out of respect of her memory. The former Gregg Hall on Young Orchard Avenue, a woman's dormitory, was renamed
