Commencement

The 103rd commencement exercises honored seven prominent citizens with honorary degrees.

The principal speaker at commencement, The Very Reverend William Paul Haas, O.P., President of Providence College, received the Doctor of Science in Business Administration degree. Like degrees were conferred upon Jack L. Wolgin, Chairman of the Board, Sunasco Company, Inc., of Philadelphia, and C. Robert Yeager, President of the L. G. Balfour Company of Attleboro.

A Doctor of Science degree was awarded to Rupert C. Thompson, Jr., Chairman of the Board, Tex-

tron, Inc.

Receiving the degree of Doctor of Humane Letters were Mrs. Mary Elizabeth Sharpe, a Providence civic leader, and John Nicholas Brown, President of the Counting House Corporation in Providence.

President and Publisher of *The Providence Journal-Bulletin*, John C. A. Watkins, received the degree

of Doctor of Letters.

The College was honored to have Dean Nelson J. Gulski '26 carry the Harriet E. Jacobs Memorial Mace in the Class Day and Commencement procession. Dean Gulski marked a forty-year association with Bryant College this year.

The Classes of '68 and '70

Orientation of 750 new students has proceeded without the hazing and hoopla of earlier years. Our freshmen seem more serious of purpose, and under the supervision of Student Senate leaders have been absorbed into a working organization that should add spark and sparkle to their classes.

Surrounding them are changes that even the Class of '66 did not see. The new Student Activities building is open, although certain finishing touches were delayed by a strike of painters in Rhode Island. A new building has been completed adjacent to 100 Charles Field Street as an up-to-date living-study facility for 252 men.

Dining Services

A most significant change in the operation of the dining service was announced by the Board of Trustees late in August. The College has turned over the operation of the dining hall and snack bar to ARA Slater, a nationally known food management service. This step relieves the College of the heavy responsibility of operating the dining service. All of the students are benefiting by a wider selection and quantity of food. Each resident student receives three meals a day, with unlimited "seconds" on all menu items except steak and lobster.

Financial Aid Officer

A student financial aid officer, Thom P. Brown, has been appointed by President Jacobs to coordinate loans, grants, scholarships, and work programs for all students. Mr. Brown was formerly associated with Industrial National Bank. He resides in Swansea, Mass., with his wife, Cynthia, and their two children.

New Property

New property has been purchased on Hope Street, across from the Library, to house the offices of the Evening Division and the Development Office. Other recent acquisitions have been two houses at 84 and 86 Benevolent Street.

The rapid development of the College in the past five years is indicated by the amount of expenditure for new property and facilities, which is \$3,924,000. Alumni Annual Giving is playing an important role in the total

progress of the College. The Fund reported \$22,184.69 received from alumni as of August 19. The number of donors has increased greatly. A final report is to be sent to all alumni.

What Lies Ahead?

Enrollment at the College will level off at 2,000 students.

The program of student activities, athletics, and other student services—health, counselling, seminars—will be increased to meet needs.

A graduate school, frequently rumored in past years, will be under active consideration by a study committee to be appointed by President Jacobs in 1967. The scope of such a graduate program has not been decided; however, it is possible that a major field of study would be hotel management or hospital administration.

The Study Committee will also have the task of preparing two plans of action for coming years. Each will require a consideration of whether Bryant College will expand and grow within its present physical boundaries or move to a new location. As this Study Committee progresses, reports will be printed in the alumni newsletter.
