# An inside look into ROTC at Bryant

It is 5:30 Monday morning and most of campus is sleeping soundly. Thirteen Bryant students including Cadet Matt Gallagher and Cadet Tyler Donovan, are waking up, getting ready, and heading to Providence College for physical training. Approximately 70 other cadets from universities and colleges, including Johnson and Wales University, UMass Dartmouth, Brown University, Providence College, Rhode Island College, and the Community College of Rhode Island, join Bryant's cadets at Providence College three times a week for physical training led by Lieutenant Colonel Kevin Kugel. Three times a week the men and women of the Patriot Battalion are up and working hard before most students realize the sun has

One group of mostly junior cadets was flown to a different location for a situational training exercise after being briefed on the procedures of the helicopters. Procedures included the proper way to approach the helicopter, how to handle rucksacks, what to do if one is air sick, entering the aircraft and exiting as well.

Once the brief training was complete, and the first group was dropped at their training location, the Black Hawks headed back to campus to do short fifteen minute flights with the younger cadets to get them introduced to aviation.

Earlier in the day Wednesday Battalion Commander Gallagher and Cadet Donovan explained the ROTC program, how they Aviation Unit after graduation.

Both Gallagher and Donovan strongly recommended that anyone who may be considering ROTC try out the class first and see if it is for them. There is no commitment expected of anyone trying out the program and each non-contracted cadet's level of participation is up to them. The leadership classes are a great opportunity whether or not one has an interest in contracting with the program.

In addition to their morning work outs, the Army cadets are also required to go to their military science class each Wednesday afternoon, which is why everyone always sees Bryant cadets in their uniforms on Wednesdays. Also, once a semester the Patriot Battalion has a weekend training session that involves learning different topics such as land navigation, medical training, and simulated mission scenarios.

Many times the cadets are flown to the training location by UH-60 Black Hawk helicopters, but on Wednesday, two black hawks came to Bryant's campus to complete training with the cadets. Battalion Commander Gallagher, a senior at Bryant University, commented that this training exercise, which was planned by the senior cadets, is a win-win training opportunity because both parties receive valuable training during one session.

On Wednesday the entire Battalion of approximately 85 cadets assembled on Bryant's practice Rugby field to get got involved, and what they will be doing upon graduation from Bryant.

Gallagher applied to be in ROTC and received a scholarship as a senior in high school. This means that he came into Bryant already committed to the program and the Army. When Battalion Commander Gallagher graduates from Bryant he will owe the Army four years of active duty which he will begin at Fort Benning, Georgia in June as a 2nd Lieutenant.

Cadet Donovan, a sophomore at Bryant University, came into the program without committing, but instead began by taking a military science class as an elective and going to physical training. In December of his sophomore year Donovan was offered a scholarship similar to Gallagher's and he accepted it, thereby committing to six years of reserve duty with the Rhode Island National Guard 126th

For 5 years, William Winsor Elementary School in Smithfield has been associated with the U.S.- China Institute and Confucius Institute established itself a Confucius Classroom to educate and inform its students about many aspects of China. On March 22, William Winsor Elementary school arranged a closing ceremony for its after school enrichment program, in which its students learn about various aspects of Chinese culture, like its language, and different regions in China.

The closing ceremony started as the faculty and staff involved with the program introduced congratulated around 20 children taking part in this valuable opportunity the elementary school has offered. After the brief introduction, Ziqin (Brian) Zhang 14' who has been involved in the after school program beautifully preformed a piece of traditional Chinese classic music by using Gu-zheng, a 3000-year-old traditional Chinese musical instrument. # **Bryant science majors - have hope**

Growing up on the Island of Borneo and moving to Colorado at the age of fourteen, I have had much exposure to many different cultures and perspectives. My father works in the oil industry as a geophysicist and greatly influenced my decision to pursue a bachelor of science in environmental science.

Many individuals hold the perception that having an environmental degree will equate to very few opportunities, but this perception is in fact untrue. Over the past two and half years, majoring in environmental science has led me to countless opportunities at Bryant University. The interdisciplinary aspect of this field has caused me to work in many different settings and meet wonderful passionate individuals all working in this industry.

Environmental science presents a multi-faceted approach of looking at the world and because of this one can specialize in their specific interests. For example, I work as a laboratory research assistant at the Laboratory for Terrestrial Environments at Bryant University. Working with Professor Qin Leng, I have been working to establish the "Bryant Botanical Club" (BBC) which aims to systematically identify, label, map, and archive all plant species on campus as well as establish a herbarium for education, research, and better management of the botanical resources.

While I have specialized in plants, other students and members in the lab have conducted numerous projects specializing in analyzing fossil and modern plant and animal material to study the effects of climate change. Some projects have already resulted in successful papers accepted by national and international professional conferences (for example, the Geological Society of America annual meetings) and one of them has been published in a high-profile international journal "Palaios". All papers have students as the senior authors.

Working as a laboratory research assistant and attending speaker series has opened many doors into the environmental industry. I attended a speaker series on the

environmental problems, the trend towards sustainability has significantly increased over the last decade. A global shift has occurred towards better quality of life, energy needs, and awareness of resource constraints. Major companies and corporations have begun to incorporate sustainability initiatives into their business. The view that waste is an acceptable component of the business process is quickly changing. Companies now realize pollution prevention commonly known as "P2" will pave the way of the future. These global trends have caused an increase in the number of jobs for individuals with environmental and sustainability degrees.

After years of working towards the goal of a greener campus, Bryant set forth last summer to achieve "Bronze" status in the STARS program of the Association for the Advancement of Sustainability in Higher Education (AASHE), which was reached last December (Information about STARS is available at https://stars. aashe.org/).

As part of the ongoing effort to become greener, the Bryant University Sustainability Committee has been formed, chaired by Gaytha Langlois, Professor of Environmental Policy, and Brian Britton, Associate Vice President ....and comprising representation from a large number of university departments, including students, faculty, and staff. The immediate goals of the committee will be to formulate a mission statement and sustainability plan for the university.

Surveys of sustainability awareness have been conducted, courses and modules are now available in academic departments, expanded goals for energy efficiency are in place, and more effective waste management programs are underway. The University is again enrolled in the annual national contest, Recyclemania, with high hopes for improving our standing this year (See Bryant's scores at the website http://recyclemaniacs.org/ scoreboard/participating-schools/ list?node\_id=13475). ## Hunger vs. Habit

What is Hunger? True hunger is a physiologic response we are all born with. Our body will tell us when we need energy; it tells us when we are full. The only good example I can give, is, think of a baby. Babies cry when they are hungry, and spit or throw food back when they are full. Can you relate?

Let's take a look at the body's physiologic need for energy. The body will digest and utilize the energy (food) you give it with in 3 or 4 hours after eating. You must refuel with-in the three or four hour time frame, for your body to function optimally.

Whether or not you listen to your body is another story. Hunger cues differ from person to person, but a few ways hunger may present itself could be: headache, moodiness, quick temper, fatigue, and cravings. It is up to you to determine your own body's cues. If you continue to ignore those cues the penalty will result in poor performance; academically and athletically.

What is Habit? Habit is eating when you are not physiologically hungry

- It is when you are grabbing for food after you just ate
- It is overeating on un-necessary calories
- It is eating due to emotional stresses:
- Exams, loneliness, relationship problems, family issues etc.
- Habit also rears with certain associations, for example, the movies. As soon as you walk into the theater it automatically triggers the desire for popcorn, even if you don't want it, or even if you just had a meal

The bottom line is: until you identify your habits, poor nutrition will follow you through your lifetime. Nip it now!

When you think you are hungry, take the "apple" test: ask yourself, would I eat an apple right now? If the answer is yes, than you are hungry, if the answer is no, then you are not hungry. This is when you determine what it is that's causing the want for food and tackle the issue instead of using food as a way out. P.S. the apple test can be anything good for you. If you don't like apples, substitute the food item for something else (NOT JUNK FOOD).


# Alex Barbosa

# The Venue's 30 Hour Famine is a success

Margaret Mead once said: "never doubt that a small group of thoughtful, committed citizens can change the world; indeed, it's the only thing that ever has."

This past weekend at Bryant University, a small group of students a part of the organization, "The Venue," made small steps towards doing just that. Showing their support for the humanitarian organization World Vision, the small group of determined students went thirty hours with no food. From 3:00 PM on Sunday March, 31st, to 9:00 PM on April 1st, thirty students experienced a small taste of the pains, discomfort and longing that millions of children across the world face day in and day out.

According to World Vision's website, hunger kills 13,000 children each day.

Hunger is a concept and feeling that many Americans do not have to experience very often – if at all. In fact, in the past twenty years, the food portions in America have actually grown. It's no secret that other countries view Americans as gluttonous, obese eating machines, and really, if you look at the figures, who can blame them? According to ABCNews, in the past twenty years alone, "Hamburgers have expanded by 23 percent; A plate of Mexican food is 27 percent bigger; Soft drinks have increased in size by 52 percent; Snacks, whether they be potato chips, pretzels, or crackers, are 60 percent larger."

Too often, I believe, Americans take food for granted. The incessant complaints about the poor quality of food at college dining halls (and I'll admit, I'm among the complainers sometimes), the poor quality of food, and people up in arms about New York City's Mayor trying to ban soda larger than 16oz., are just a few of the many ways in which Americans fail to realize the many ways in which we are blessed. Perhaps it is these little things: a group of students denying food consumption for just thirty hours, a simple reminder that there are so many, many people who are less fortunate than us – that bring things back into perspective, remind us that each day, every hour, somewhere a child is hungry, and dying.

Of course it cannot be expected that the world will be changed instantly, or that all hunger issues will be resolved. But, when simple, small acts of kindness like The Venue's 30 Hour Famine are undertaken, it should serve as a reminder to all of us that there is always hope for a brighter future. We should all take these moments to reflect upon the ways we are fortunate. For 30 dollars you could enjoy a movie and snacks, or you could buy a nice new pair of jeans. For 30 dollars you could enjoy a nice dinner out at a restaurant, or visit the aquarium. Or for just 30 dollars, you could feed a young child for a month. While we may not be able to change the world and fix all the pains and maladies in an instant, if we all work together we could bring hope and promise to many children.

In the past four years, various branches of The Venue throughout Smithfield have raised between 17 and 18 thousand dollars for World Vision's 30 Hour Famine. Although it is only the first year that The Venue has been an organization on Bryant University's campus, the organization has already managed to raise approximately \$900 from proceeds of the 30 Hour Famine (that's about 16 children that will be fed for one month!). Speaking with the young go-getter and leader of The Venue, Evan Smith, it was plain to see the passion and love for the work The Venue does. Evan says that the best part of The Venue is seeing how people grow. Every Monday night, The Venue holds religious services, and Evan says that when new students join, they are often timid and shy, but after a few weeks of attending services, he already notices significant growth and change in the individuals. Evan has high hopes for The Venue and the 30 Hour Famine. As a sophomore here at Bryant, he sees the potential for great growth and development of the organization and hopes that next year the 30 Hour Famine will attract even more students to join the cause towards ending world hunger. So keep your eyes open, and next year let's (as a Bryant community) bring awareness to the horrible issue of world

# Biz Snipz: the current happenings of the business world

Early Wednesday morning Israeli warplanes hit targets in the Gaza Strip in response to rocket fire toward Israel. This was the first air strike launched by Israel since the informal cease-fire ended cross-border fighting between Israel and Gaza. Palestinian officials reported that no one was hurt and no damage was reported in northern Gaza despite the Israeli military issuing a statement that they targeted "two extensive terror sites" with "accurate hits".

This was the first attack since President Barack Obama's visit two weeks ago. There has not been any responsibility placed on a specific, part however the Israeli military says it holds Gaza's Islamic Hamas rulers responsible for any attack against the Jewish state.

Rocket strikes have been rare since the ceasefire was reached last November. The agreement was created following eight days of considerable violence where over 1,500 rockets were fired leaving 175 dead with a multitude of damage.

The housing market is in full blown recovery mode. Housing numbers from March show that the S&P Case-Shiller Index is rising more quickly on an annual basis since 2006. In the past 12 months home sales have experienced year-over-year price increases and new home sales have increased by 29% from a year ago.

In a new study released by PulteGroup which interviewed generation Y renters (ages 18 to 34) they found that 65% of respondent's intentions to buy homes had increased over the past year. Additionally, 52% of millennials indicated a desire to own and build equity. There are approximately 90 million living members of the generation Y group making them the largest demographic group in United States history.

This provides an opportunity that could create a housing boom larger than anything the country

has ever seen. While 98% of millennials said they would be living with someone, the most important feature to them was the layout of their new home. Some 69% of respondents desired an open kitchen and family room space for entertaining purposes. These are promising signs but Jonathan Miller, President and CEO of Miller Samuel says, "It's still very early in the process". "The idea of people living with their parents because they can't afford to go out on their own has been a problem since the credit crunch began five or six years ago". In addition, he remarks on how millennials are faced with record high rent rates.

Nevertheless, most people of this generation are first time owners which means they do not have to worry about selling another home or coming from a home that has lost significant value. Thus making the housing market more accessible to them.

2012 was a very rough year for J.C. Penney and CEO Ron Johnson. Their store sales were down 32% in the fourth-quarter in addition to the retailers losing over \$4 billion in sales in the 2012 fiscal year. The current trading price for JCP is \$14.43, less than half of its value before Johnson became CEO in 2011.

Following the year of poor performance, J.C. Penney is cutting Johnson's pay by 97% to \$1.9 million. 97% sounds much more significant than it actually is. His expected salary was to be \$3.375 million in 2012, but the real money came with the stock options of more than \$50 million which they used to lure him away from Apple. In comparison Kevin Mansell, CEO of Kohl's, made \$7.8 million in 2012.

JCP has suffered through heavy controversy since Johnson has come aboard. He first tried to do away with sales but subsequently brought them back after customers complained. Later he set out to redesign and completely modernize the company's stores but ended up leaving many stores in a frozen time zone of construction. He also introduced a three-tier pricing model which turned out to be too confusing to customers. On top of all of this, they are currently engaged in a costly legal battle with Macy's over signing a deal with Martha Stewart Living Omnimedia to carry its home products.

However, Johnson was not the only one feeling the compensation crunch. JCP's senior management was granted no bonuses or raises last year. There has been no sympathy for Johnson as he has failed in every performance related task. The real sympathy lies with stockholders who have lost significant money since Johnson's arrival.

The first reports from the Alpha Magnetic Spectrometer, a \$2 billion cosmic ray detector on the International Space Station has brought back some considerable results. It has found the first significant hint of dark matter, the mysterious substance that is believed to hold the cosmos together but has never been directly observed or proved.

The ray detector was first sent into space two years ago and it has gathered evidence of a new physics phenomenon that could be the strange and unknown matter, an international team at the European particle physics laboratory near Geneva announced Wednesday.

Samuel Ting, Nobel-winning physicist and team leader, said he expects a more conclusive answer within months. The data being collected will be analyzed at the European Organization for Nuclear Research, also known as CERN, which is located along the French-Swiss border.

The first results from the detector are substantial, because dark matter is thought to make up a quarter of all matter in the universe. Deciphering the mystery of dark matter could help scientists better understand the make-up of our universe and more importantly, what holds galaxies together.

# This is madness

The victors are certainly entitled to bragging rights and elevated respect until the following March. This is all of course a reference to the event known as "March Stock Mania." The corporation with the bragging rights this year is Google. CNN Money has said that this is the latest in Google's accolades for this year after their 52-week low last June (since which their shares have soared up 45% to get higher than \$840 in March). The way that this type of tournament is won, is with the votes of "readers," indicating investor confidence. At the end of it this year, Google beat Exxon Mobil with 56% of the vote, getting revenge for when Exxon knocked them out in the Final Four of last year, according to CNN Money.

"Hasbro, Caterpillar, Microsoft, and the former defending champion Apple (first time this was not in the finals).' Given the intense Apple vs. Google rivalry, it should come as no surprise that of all these, Apple was the toughest to defeat (according to CNN Money Google got by with 53% of the vote). Actually, Apple's stock has fallen from an all-time high by almost as much as Google's has risen from a 52 week low (they are now at a fourteen month low), and Google's Android has a significantly larger smartphone market share than Apple's iPhone, as reported by CNN Money. With all this said, there is one piece of good news for these companies. Hedge funds still hold financial stocks in high regard, but these were all defeated in the first round. That means that it is increasingly possible that these (hedge funds) will be a new piece of the market these companies can target. There is also a saying that "the only constant is change." This is the perfect way to describe the stock market's natural variability, which ultimately means we cannot use any one day to predict what will happen the next day, as is true for almost everything about life.

## **Professor Michael Roberto's** Blog : Engaging your high performers

Forbes reported this week on a startling new study by Leadership IQ, a company that does a great deal of work on the assessment of employee engagement. The firm examined data from 207 companies on employee performance as well as employee engagement. According to Forbes:

'In 42% of the companies, the employees who do the worst job are the ones who feel the most "engaged." At the same time, the middle and high performers in those firms feel disconnected from their jobs and not very motivated to come to work every day."

The article, by Susan Adams, does a very nice job of explaining many of the reasons for this result. Adams, drawing on a conversation with Mark Murphy (Leadership IQ CEO), argues that the lack of a true meritocracy causes disengagement among high performers. Company leaders aren't having the difficult conversations with low performers, and they are not properly recognizing the best employees. I cannot argue with that finding; it seems quite reasonable. I would argue, however, that one other cause may exist for this alarming finding. Many companies simply are not investing effectively in leadership development for their top performers. Notice that I did NOT say that they are not investing ENOUGH. Many companies are spending a great deal of money on leadership development programs and processes. However, many organizations are not spending that money WISELY.

The companies that Google had to defeat to get to the finals were:

We see a litany of problems in many companies: Too many one-off events exist. Too many programs lack cohesion. Too many leadership development events lack clear criteria for determining who should be involved or invited. Far too little followup exists after programs are delivered.

Until firms start designing more effective leadership development activities, and begin spending their resources more effectively, we won't see engagement rise significantly for the highest performers.

# Sweeping them off their feet -Bulldogs blank FDU in weekend series

It wasn't an easy start to the season for Bryant's baseball team. Losing six of their first seven games, the Bulldogs seemed to be heading on a downward spiral. However, they must have reached the bottom after that, because since then, the only place they have gone is up. After some tough losses to some of the nation's best baseball teams, Bryant is climbing to the mountaintop, and they may not stop until they

reach the top of the NEC. The Bulldogs have gotten back to their winning formula, winning nine games in a row since the March 22 game against Mount St. Mary's. The team's secret to their success has been their brooms, as they have been successful at Mount St. Mary's and Fairleigh Dickinson. During their win streak, Bryant has outscored its opponents 76-17, including a shutout in their first matchup against St. Mary's. With their dominant pitching and a fiery offense, the Bulldogs have established themselves as legitmate contenders, and the

rest of the conference has began to take notice.

Bryant showed its dominance this past weekend, sweeping FDU off their feet in four games in two days. The Bulldogs had control of the entire series, winning their games by an average of nearly six runs, including a 12-3 beat down in the series finale. Game 1 of the series began with a with a hot start with the bats for Bryant. Led by shortstop Dan Muscatello's four RBI's and third baseman Kevin Brown's homer in the ninth, the Bulldogs never seemed to cool down, defeating the Knights easily 9-1.

In Game 2, Kevin Brown was once again the offensive powerhouse for the Bulldogs, knocking in five runs including his second long ball in as many games. Despite FDU responding with two runs of their own in the third, Bryant was no match at the plate, especially with the help of strategic sacrifice flies in the fourth and fifth innings.

If a Bulldog fan missed the games on Friday, that person could have gone out and seen something similar in Saturday's doubleheader. The Bulldogs were once again victorious in Game 1, but this time, they were able to get the win with dominance from their pitching. Southpaw John Healy has had an unbelievable start to the season thus far, and it continued on Saturday.

In five innings of work, he only surrendered one run and earned the victory to continue his undefeated season (4-0). Of course, Healy could depend on his team behind him for run support, as he had a comfortable 7-1 victory. Bryant's offense was led by outfielder Carl Anderson, who went a perfect 3-3 at the plate with 3 RBI.knocked in 122 runs in the early going of this year, not wasting any opportunity that presents itself on the diamond. Their

The Bulldogs saved the best for last; in Game 2 they scored the most runs they ever had in the entire series. Carl Anderson continued his historical weekend by tacking on three more hits to his stat line. He went a remarkable 6-8 from the batters box on Sunday alone. Bryant kept bats going in the fourth, knocking in seven runs in just that inning. Centerfielder Daniel St. George got the ball rolling with one of his three runs batted in. After that, the Bulldogs put on quite the offensive clinics, including designated hitter Aj Zarozny bringing two runners home. Pitcher Craig Schlitter

knocked in 122 runs in the early going of this year, not wasting any opportunity that presents itself on the diamond. Their .371 OBP and .352 slugging percentage keeps their offense going, and allows the team to keep momentum going in their favor.

The team's pitching staff has been unbelievable here in the opening weeks of the season. They have posted 3 shutouts to go along with a .277 ERA. By scoring this many runs and sending batters back to the dugout, they are simply outperforming their opponents.

Not only have the Bulldogs won nine games straight, but they are making themselves a legitmate contender in the NEC. Bryant is currently 14-9-1, with an undefeated conference record

Hello baseball fans and welcome to the 2013 MLB season! After months of off-season and preseason news, the regular season of America's pastime sport can final begin. Last year was an historical year for Major League Baseball. It increased the number of playoff teams from eight to ten teams and added a brand new Wild Card Round to the MLB playoffs.

Last off-season was also eventful, including the news of the Blue Jays offseason moves and the Houston Astros move from the National League Central to the American League. No one knows what the new and exciting 2013 season will hold for its longtime fan base. The opening day for the 2013 MLB season began on March 30, when the Texas Rangers traveled to take on their newest divisional rivals, the Houston Astros. Coming off one of their worst seasons last year with a 55-107 record, the Astros came into this game with a clean slate. The remaining players of the Yankees' lineup were mostly un-heard of minor leaguers. Ever hear of Ben Francisco and Laynce Nix? They were the DH and third baseman for the Yankees on Opening Day. # Quarterback carousel, signal callers change addresses

In a pass-happy league, in the NFL, having a dominant quarterback can make or break a franchise. The gunslinger a team has under center can be the difference between a Super Bowl and not making the playoffs. A team wants to make sure that they have found the right guy to carry not only their franchise, but an entire city on his shoulders. The NFL is dominated through the air, and the quarterbacks are the clear-cut leaders of this attack.

This past week several NFL teams decided their quarterbacks were leading them in the wrong direction.

In what has been one of the busier off-seasons in recent memory, the wheeling and dealing continued as several teams decided to move on without their quarterbacks. Just this past week, there have been three major moves that hope to bring some NFL offenses to stardom. After investing all of their faith in failed experiments, owners have decided to take a different path, with new quarterbacks in their offenses.

The Oakland Raiders snagged all NFL headlines with their surprise deal this past Monday. Looking for a new face for their franchise, Oakland landed a deal with the Seattle Seahawks for quarterback Matt Flynn. The Raiders agreed to send a 2013 fifth-round pick and a 2014 conditional draft pick for the young gunslinger. Flynn, who had the potential to be one of the best young quarterbacks in the league, signed a 3 were 25 million dollar contract

signed a 3 year, 25 million dollar contract with Seattle last offseason. However, after being outperformed by rookie quarterback Russell Wilson, the only place Flynn saw the field from was the bench, making only a few appearances in blue and green. The potential for Flynn is still extremely high. As a Packer in 2011, against the Lions, he set franchise records by throwing for 480 yards and 6 touchdowns. Keep in mind; he set these records for a franchise with a rich quarterback history, including Bart Starr, Brett Favre, and Aaron Rodgers. The Raiders hope he can bring this arm to the silver and black, as they have had thirteen different starting quarterbacks since Rich Gannon in 2004.

Many of these recent quarterback moves are attempts for once futurestars of this league to resurrect their disappointing careers. After two years in Arizona, quarterback Kevin Kolb will look to get his career back on track in the AFC East with the Buffalo Bills. After cashing in on a huge 64 million dollar

contract with the Cardinals, it's safe to say it wasn't money well spent on Kolb. In just two years, he posted an unimpressive 83.6 quarterback rating, and failed to bring Arizona to the playoffs. With him under center, the Cardinals became the first team to allow a quarterback to get sacked eight times in three straight games. A former second round pick with the Philadelphia Eagles, Kolb will have a chance at redemption with Buffalo.

on the teams, but this quarterback carousel could determine what other teams do in the next couple of weeks.

First, by trading for Flynn, the Raiders are almost certain to deal quarterback Carson Palmer. The leading candidate to land him is the Arizona Cardinals if Palmer agrees to take a pay cut. Despite a disappointing tenure in Oakland, Palmer to the Cardinals could put an immediate spark in an offense that has been desperate

The Bills are extremely thin at the quarterback position after cutting former starting quarterback Ryan Fitzpatrick. Kolb could have an extremely high chance to start to try to jumpstart not only his career, but Buffalo's 25th ranked passing game.

The final quarterback move this week was a little bit more under-the-radar than the others. The Cleveland Browns traded quarterback Colt McCoy to San Francisco. In the deal, the Browns will give the 49ers their sixth round pick in exchange for San Francisco's fifth and seventh round picks. At one time, Colt McCoy was thought to be the future of Cleveland's offense. However, McCoy had a lackluster career in Cleveland, tossing 21 touchdowns to 20 interceptions with a 74.8 quarterback rating.

In San Francisco, McCoy will be second string behind superstar quarterback Colin Kaepernick. Many fans might see this move by the 49ers as not the important. However, McCoy gives them a solid backup option if Kaepernick gets hit with the famed sophomore slump next season. Even if McCoy can play well in his limited playing time and show flashes of potential, other teams may want to bring him in for a potential starting role. Also, the move is quite an upgrade for McCoy, as he now is playing for a championship instead of the first overall pick in Cleveland.

Not only do these moves have impact

for someone that can get the ball to receiver Larry Fitzgerald.

Also, with the draft in a few weeks, quarterbacks finding new homes could have an impact on teams' draft strategies and could ultimately decide who teams pick. One of the main players it could affect is West Virginia's Geno Smith. At the beginning of the off-season, Smith was projected to be the first overall pick. Now, although he is still the number one ranked quarterback in the draft, Smith might not be selected until the eighth or ninth pick.

So many teams have settled their quarterback dilemma that Smith could be passed up until later on the first round. However, with his credentials and potential, there are still many teams in the first round that could take a gamble on this talented young quarterback. The Philadelphia Eagles, Arizona Cardinals (if they don't land Palmer), Buffalo Bills, and even the Jacksonville Jaguars are all potential landing spots for Smith. Then again, the Raiders could always pull a draft day surprise and draft him with the number three pick.

All these moves not only change the franchises themselves, but also the league around them. If a team wants to win in this league, the first step is having a quarterback that can lead a squad to those wins. These moves at quarterback could get these franchise to begin moving in the right direction to a championship.

## A northeast showdown: Celtics vs Knicks rivalry

Nothing beats a good old fashion New York and New England sports rivalry and basketball is no exception to the rule. This rivalry will focus on the long time Atlantic division rivals, the New York Knicks and Boston Celtics. These teams have been at odds with each other since the very beginning of the NBA and are two of the three remaining teams from the original 1946 NBA; the third one is the Golden State Warriors.

These two teams are the oldest rivals in the NBA and have played against each other more times than any other NBA matchup. In 451 regular season games against each other, the Celtics are currently winning the series over the Knicks 276-175 and in 61 playoff games the Celtics are also winning the series 34-27. In fact, the entire rivalry has definitely been one-sided for the Boston Celtics. The Celtics have a total of 17 NBA Championships and have clearly dominated the majority of their rivalry with the Knicks. who only have 2 championships. However, this is clearly the past and has no bearing on how the two teams stack up this year in the 2012-13 NBA season. The most recent game these two teams played was last Sunday, when the Boston Celtics team traveled to Madison Square Garden to take on the New York Knicks. At the time the Celtics were struggling and had recently come off avoiding a seven game losing streak. Despite the long losing streak, the team was still in 7th place with a modest 38-34 record. The Celtics are really like the old dogs of the Eastern Conference because they use the experience of the team's older veteran players, like Paul Pierce and Kevin Garnet, to win games rather than relying on youth. This trait especially became apparent after the team lost its star point guard Rajon Rondo. Coming into the game for the Knicks was almost a completely different story. The Knicks came into this game on a seven game winning streak and were leading the Atlantic division. The team was in second place in the Eastern Conference, only behind the Miami Heat, with a

45-26 record. The Knicks are a team that lives largely by the three point shot but can also score in the paint and play fantastic defense.

They are led by all-stars Carmelo Anthony and Tyson Chandler, and have a fantastic bench that includes Jason Kidd and JR Smith. To top it all off, the Knicks had just recently won a game against the Celtics in Boston 100-85.

The highly anticipated Easter game between the Celtics and the Knicks turned out to be an absolute snorer as the Knicks manhandled the Celtics and soundly won by the final count of 108-89. Carmelo Anthony led the Knicks with 24 points and 10 rebounds but the team had many offensive outlets that night. Six Knicks scored in doublefigures, including Chris Copland, Raymond Felton, and J.R. Smith, who all combined for 55 points. At first the game seemed close; by the end of the first quarter the Knicks only had a 28-23 lead. It was in the second quarter, however, where the Knicks ran away with the game. The Knicks managed to outscore the Celtics 37-25 in the second quarter, including a half-court buzzer beating three-pointer by Raymond Felton to give the Knicks a 65-48 halftime lead. From there, the Celtics couldn't do anything offensively and simply dug a hole too deep for them to climb out of. Of all 89 of the Celtics' points, 51 were scored by Jeff Green and Paul Pierce. In fact the Celtics' bench was outscored by the Knicks bench 50-32. Worst of all, the Celtics shot just 28% from the arc while the Knicks shot 52%. With this win, the Knicks have finally won the season series against the Boston Celtics 3-1. It's the first time this has happened since the 2003-04 season. Since the Easter win, the New York Knicks are still on their winning streak. The Knicks (47-26) beat the Miami Heat 102-90, thanks in part to Carmelo Anthony's 50 point game, and have won the season series against the Heat. They will travel to Atlanta to play the Hawks, play a home game against the Bucks, and travel to OKC to take on the Thunder. As for the Celtics (38-36), the team continues to struggle. After the loss to the Knicks, the Celtics ended up losing a road game to the lowly Minnesota

Timberwolves 110-100 and added to their miserable road record of 13-25. The Celtics are in luck, however, as they will play three of the worst teams in the Eastern Conference at home which include the Pistons, Cavs, and Wizards.

If the playoffs were to start today the Knicks would be playing the Celtics in the first round, a matchup that the Celtics have dominated over the last few decades. However, it is really unclear whether or not the Celtics can actually win such a series. # Air traffic control towers closing: Congress cuts on airplane safety

The debt of the United States federal government grows every day at an exuberant rate. Naturally, government officials and citizens alike endlessly debate about potential solutions to the problem. Usually, the bickering doesn't create any positive results and it has yet to generate a conclusive resolution.

When someone proposes cutting Medicaid or defense spending, people scream about how the funding for those programs is necessary and cannot be cut. When tax hikes are put on the table, people who oppose say the government is too big and that the deficit problem must be met with spending cuts. It seems that the country is so divided that no matter what is proposed, there will be enough of an opposition for it to be shot down. So what happens when all the sensible options are stopped in their tracks? Non-sensible options are used to fill their place.

On March 22, a list was released of all the air traffic control towers that will be closing in the near future as a result of Federal Aviation Administration (FAA) budget cuts. The budget cuts were part of the sequester which went into effect earlier this year after Congress failed to pass an alternative to the automatic cuts. Some \$85 billion was cut from the 2013 federal budget altogether and the FAA was forced to absorb \$637 million of that according to Forbes. The response by the FAA was to close air traffic control towers at lowand moderate-traffic airports across the United States.

Since this announcement has been made, I have been talking to my friends and family—and anyone else who would listen to my rants—about the appalling issue. One question that seems to pop up frequently is whether or not the closing of an airport's tower means that the airport itself will close. While the answer is no, it does mean that the airports are somewhat less safe than they currently are and have been.

An airport without a control tower is called an uncontrolled airport. This term might lead some to believe that the situation at these airports is chaotic and dangerous, but this is not the case. Aircraft flying within the airspace of uncontrolled airports communicate with each other over the common traffic advisory frequency (CTAF). On an airport's designated CTAF frequency, pilots report their tail number (aircraft identification), position, and intentions at certain intervals while they are within the airspace and moving on taxiways and runways on the ground. At controlled airports, air traffic controllers direct traffic on the ground and in the air to maintain sufficient separation between aircraft so as to minimize the chance of a collision.

Uncontrolled airports are considered safe, but they tend to be smaller airports with relatively low traffic levels, so there is some legitimacy to the argument that the closing of towers will not cause significant safety hazards. Theoretically, if all pilots within the airspace of an uncontrolled airport follow proper and safe procedure, the risk to individuals is minimal



(although still present, as is the case any time people board an aircraft). Nonetheless, no pilot is perfect and adding additional extra radio communications and collision-avoidance tasks makes airport operations more difficult and dangerous than they need to be.

The closing of air traffic control towers could be compared to the replacement of traffic lights with stop signs at 4-way intersections that tend to see moderate traffic levels. While it might not be considered blatantly dangerous to make this change, it does decrease the safety of everyone involved by putting traffic direction and separation in the hands of drivers. This comparison might make air traffic control cuts seem relatively unimportant, but a mid-air collision is much more likely to result in the death of pilots and passengers in both planes and of people on the ground than a lowspeed collision of two cars on the ground is.

With all of this considered, it does not seem logical, to me, for Congress or the FAA to allow these cuts to be made. In fairness, the cuts made by Congress were automatic and across-theboard, meaning that they did not specifically make cuts to the Department of Transportation, nor did they cut funding for the Department by more than anything else. As for the FAA, it insists that safety remains its top priority, according to CNN, and that they have no choice but to go ahead with the closings.

Some airports, however, are suing the FAA over the closings according to Fox News. The multiple cases have been combined into one.

Congress' failure to ensure that the FAA receives sufficient funds to maintain what is

considered to be the world's safest aviation network demonstrates its disregard for the value for human life. Despite the fact that the cuts were automatic, additional efforts should have been made to allocate resources to the Department of Transportation for the purpose of safety. The hit that the air traffic control system is taking is not only a threat to safety, but a signal to the country that something must change if the United States is to remain a major power. A country that cannot maintain its already lacking infrastructure is a decaying one.

With crumbling roads, unsafe bridges that threaten to collapse at any moment, and, now, an insufficient air traffic control system, the United States is falling rapidly behind the other industrialized countries of the world. More importantly, these cuts warn us of an apparent nationwide attitude that petty partisanship and a relatively small amount of money are more important than the lives that will be lost as a result.




# The new feminism

# **Fight back against digital distraction**

We all understand that electronic devices have changed our lives. The impact they have on the way we live has to rank right up there with the mastery of fire and discovery of the wheel

In talking with three women at a conference in California last month, I stumbled on a consequence of that electronic invasion that I had no idea even existed: e-nups.

What, you've never heard of e-nups? You've heard of prenups, prenuptial agreements, right? Those are agreements couples make before marriage to determine who will have what right under what circumstances to which portions of the partners' respective financial and

### other assets.

E-nups are agreements couples make before or during a marriage or relationship to regulate circumstances in which they will use cellphones, iPads, laptops, etc.

The need for an e-nup arises out of a couple's search for a strong interpersonal relationship and a life of shared meaning all in the face of the heaviest and most inventive assault on cerebral machinery and sensory engagement in the 10,000 years since humans started living in communities.

You've seen people text while driving. You've seen people steal a look at a cellphone at the movies, at a party, or most frighteningly while in an airplane when all devices are supposed to be shut down. I saw survey results once that indicated some people even peek at their cellphones during sex.

This section refers to situations when permission of others present is required before using a laptop or cellphone. The draft is particular about restrictions that will apply, and joint consultation required, when their daughter is with them. But other parts of the document propose flat restrictions on when electronic instruments can be used:

"We will not engage with our phones or work on our laptops at all in the following circumstances...

- during meals together When spending intentional time together (e.g., taking a walk, going to an event together, cuddling in bed)

In a confined space with others, even if it's "default time" (i.e., car, public transportation, elevator, etc.)"

Zoe and Kenny have been working on this agreement for nearly a year and are on their fourth draft. One of the other women I spoke with said she and her husband were considering making their agreement legally binding.

The agreements these couples are working on, and the commitments they entail, seek to reclaim from the digital onslaught a measure of direct, engaged communication and quality time in their lives as partners, parents and friends. I bet there are more couples


