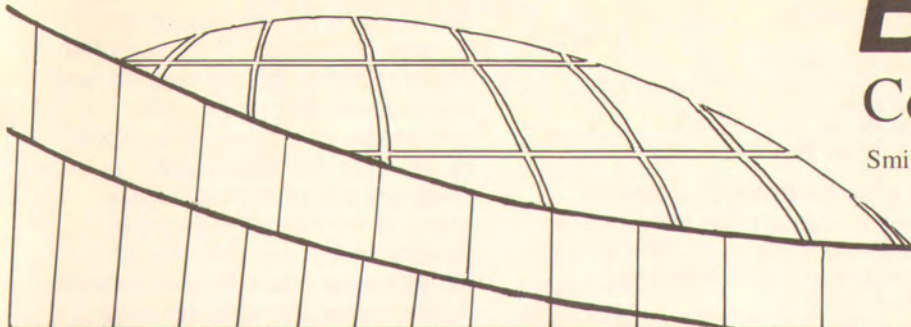

Bryant welcomes V.P., Public Affairs. For the past thirteen years, Miss Jacquelyn Low served as Vice President for Public Relations and Advertising for Cabot, Cabot & Forbes, Co., a national real estate firm. She was responsible for the planning, creation and execution of all promotional materials, advertising, public relations and publicity programs for the parent company, its four subsidiary organizations and hundreds of projects located throughout the country.

A graduate of Simmons College, she has been the recipient of a number of professional awards. Miss Low has also served as Director for various social service and civic organizations and is an accredited member of the Public Relations Society of America.

Old campus names reborn at Bryant. The Board of Trustees has voted to name the dormitories and townhouses on campus after individuals who have contributed so much to the history and development of Bryant College. Many of the names will ring a familiar bell to our alumni who attended the Hope Street campus: Appleby Hall, Stowell Hall, Allan Hall, Hoey Hall, Barber Hall, Scott Hall, Harriet Hall, Gardner Hall and Kilcup Hall. Another dormitory name will provide a link to the history of the Smithfield land on which the Tupper Campus is now situated. Mowry Hall will be named in honor of Capt. Joseph Mowry, the original settler of the property.

Professor Joan Marsella has been appointed by the Governor as a director of the Howard Industrial Corporation. A project of the Rhode Island Economic Development Council, the corporation is charged with locating new industry and increasing employment in Rhode Island.

Vice President for Student Affairs, Dr. Barry Fullerton, was named to a four year term on the Rhode Island Advisory Commission on Educational Television. Dr. Fullerton joins the 20 member board of broadly representative professionals in the area of education, cultural, religious and social interests in the state.

Welcome Speech to New Students

The opening convocation is always a time of mixed emotions for me. While everyone else has welcomed you, I am, in a sense, saying goodbye. Perhaps, then, it is more germane to examine what you really are and what Bryant really is, and what both of you can expect in the years ahead.

You are young, Bryant is old — entering its 115th year. You have gathered from 26 states and 5 foreign countries. You bring new and distinctive traditions, and you represent a variety of cultures and persuasions. While Bryant's academic offerings are constantly being modernized, her traditions are just dusty enough to merit your close examination. These traditions have passed the test of time.

Some of you may still wonder why you were admitted. If College Board scores were the sole measure, we could have replaced a significant number of you and raised the average score. We looked for more. Grades and scores simply do not tell us enough by themselves to separate the weak from the strong.

We assemble the best class we can, composed of those people that have the intellectual promise, and also those who have good academic potential combined with distinctive personal strengths. But, to be happy here you must be fundamentally interested in learning.

The selection process brings an intellectually and culturally diverse class to Bryant, but it cannot claim to have found and ranked all applicants by any single abstract standard. You were accepted in open competition. We had 3,400 applications for 980 spaces. We have no special tracks, no second class citizenship, no separate but equal notions. We have but one College. But what about your choice?

I think it should be clearly understood that fundamentally Bryant is an academic experience. Some people come here looking for clubs and activities, parties and athletics. We have all this and we are better for it; but you will be disappointed if that is your primary purpose for being here.

The only thing that college can offer — that is not available in other segments of the community at this time of your life — is academic activity.

Some of you come from superb high schools that have provided you with a superior academic background that would enable you to possibly bypass certain freshmen courses. Perhaps you come from parts of our society which has not given you exposure to all kinds of people in society.

At the same time, we have admitted people from inner city or rural areas that simply have not given students even average preparation. Yet, by the nature of their background, these new students come from situations which are enormously rich in life experiences. We have representatives in both categories. Bryant is better for it. You will be better for it. But it makes it difficult for a college to present a

curriculum and a social scene to satisfy both.

For those of you who have been well prepared — don't take your freshman year for granted. Challenge yourself. Don't just slip by, even if your background might allow you to coast.

For those of you not so well prepared — you are going to be scared. From the first round of exams you'll be depressed. You will wonder if you belong. I promise you that the Admissions Committee feels very sensitive about this. I must *emphasize* that no one has been admitted who cannot do the work.

After November, things will start to fall into line and you will grow, you will have widened your circle of friends, you will have learned to handle the challenge of academics. Your sophomore year will be better than your freshman year, your junior year will be better than the sophomore, and the senior year will be best of all.

Somehow the validity of learning has come under attack of late. No one can deny that knowledge can and has been misused, especially at times in business and in politics. But, because some learned leaders have been wrong, this problem will not be unsolved by unlearned future leaders. A regression to earthy, uncomplicated matters is not a suitable alternative to the intellectual. Do not be satisfied with minimum effort — even if it appears to be the "IN" thing to do. Remember, you must be ready to lead when your time comes.

The Admissions Committee selected you for your obvious qualities and is confident you will be successful. Ask questions. Ask for help from us all, and enjoy a potentially wonderful experience. We are pleased to have you with us.

The College Trustees recently voted to name the student housing buildings on the Smithfield campus. At present they are numbered. They chose names which once

identified buildings on the former Providence campus. In doing so, they renewed Bryant's ties to its proud past and recognized some of the individuals who contributed so much over the years in making Bryant College what it is today.

All of the structures to be "named" in Smithfield serve as student housing.

The names are as follows:

Townhouse A renamed **Appleby Hall**

Named in honor of R. Lucien Appleby '27, faculty member, Secretary and Treasurer, Vice President of Bryant College 1940-1968.

Townhouse B renamed **Allan Hall**

Named in honor of John L. Allan '19, faculty member, Bursar, Executive Secretary, Vice President and Trustee of Bryant College 1919-1956.

Townhouse C renamed **Hoey Hall**

Named in honor of Rita C. Hoey '33, Secretary to the President of Bryant College 1933-1966.

Townhouse D renamed **Stowell Hall**

Named in honor of Theodore B. Stowell, faculty member, Principal and Proprietor of Bryant and Stratton College 1872-1915.

Townhouse E renamed **Barber Hall**

Named in honor of Jeremiah C. Barber, faculty member and Dean of Bryant College 1897-1940.

Townhouse F renamed **Scott Hall**

Named in honor of William B. Scott, faculty member of Bryant and Stratton College 1890-1927.

Townhouse G renamed **Mowry Hall**

Named in honor of Joseph Mowry, original settler of the property now comprising the Tupper Campus of Bryant College.

Dorms 1 and 2 renamed **Harriet Hall**

Named in honor of Harriet Einstein Jacobs, wife of President Henry L. Jacobs and mother of President E. Gardner Jacobs (born 1878 - died 1930).

Dorms 3 and 4 renamed **Gardner Hall**

Named in honor of E. Gardner Jacobs '21, Director of Admissions, Vice President, President, Trustee and Chancellor of Bryant College.

Dorms 7, 8 and 9 renamed **Kilcup Hall**

Named in honor of Dr. Ernest I. Kilcup, H '61, Trustee (1949-1961) of Bryant College, and his wife, Edna D. Kilcup, in recognition of their generous support.

Dorms 5 and 6 renamed **Berberian Hall**

Named in honor of Artacky Berberian '09, H '73 for his continued interest, especially in establishing the Alumni Association.

Fishball, Faculty Dining Room renamed **Arris Dining Room**

Named in honor of Dr. George H. Arris, H '59. Dedication of Arris Dining Hall will take place in the early spring.
