



## **Citizen Police**

In recent months the country has seen a significant level of violence between some police officers and other members of the community. The well-documented incidents beg the question, how can citizens and police get along, so that cops will serve and protect? With this question in mind, Officer Anthony Nolan visited Bryant University, on Febraury 19th, to talk about what to do when stopped by a police officer. And more importantly, the answer to the question, how can we avoid more bad interactions, like what happened in Ferguson, Cleveland and Ohio, in the future?

One of the most important things to remember is that there are a lot of good police officers, but there still are a handful of bad apples making them all look bad. The good officers are the ones who have pride in what they do, and will treat people as they would want their families to be treated. They are dedicated to the safety of the community and the values of justice, peace and unity. The bad officers treat people disrespectfully, and unequally, and are characterized by misconduct, verbal abuse and other inappropriate behaviors. One of the problems is that a good police officer may be too intimidated by a bad one to stand up. In that case, what can other people do?

The best thing is for us to be aware of the law and our rights. This knowledge gives us a chance to catch a possibly bad police officer, and that will cause hesitation on their part. For example, police officers are required to provide you with a racial profiling card, which details what to do if you believe that you were stopped for an unspoken reason. If this is not given after the ticket, then it will likely be a case of racial profiling. It is also the officer's duty to respect your rights, and the stop must have a reason behind it, and not that they just think they have the authority. In addition, if the police officer does not specifically say "stop," or that you are detained, then you are free to go, unless the officer actually grabs you. Another option is for a person to use their phone camera if it looks like the officer may be getting out of line. This is a two-way street, and there are things the driver can do to prevent additional problems with the police.

The most important of tips is to not panic, which is what happens in a lot of stops. Things such as flailing your arms around and refusing to answer the questions gives the officer an additional reason to write you up, or keep you stopped longer. It is also not a good idea for somebody to run their mouth to the officer. An officer may also egg you on to fight a ticket in court for the overtime pay. However, while getting the ticket is not a good time to argue against it, in other words do not get into a debate. Also, another thing that an officer will likely ask for is for proof that your car is insured. They are not required to contact your insurance company, so you will need to have your insurance card in the car. If the insurance card is expired as of the stop, then it will be an additional thing to write you up for, but it cannot be the reason for the action to have happened in the first place, and your car may also be towed.

Doing what the officer asks is also important, for example they can ask you to take your hoodie off for identification, if you resemble somebody that has done something wrong. This is usually only during a legal stop however. Another thing that may cause a stop is if you are from an area where there is a lot of wrongdoing. Finally while an officer may egg you on, you should not attempt to egg them on, especially to shoot you. Ultimately, people need to be bold enough to have conversations about what is going on, or these bad interactions are going to keep happening. Regardless, the best thing to do is to keep up to date on the laws where you live, for all possible aforementioned situations, and realize that all communities are different. The officers, for their part, will need training for how to deal with problems that an attitude can cause, so that there are less overreactions. However, it is up to the police departments to provide it.

That still leaves the question: how can people get along with the police in their community? A particularly strong solution is known as community policing, where relationships are built between the police and others. This is so that the public gets used to the officers, and the officers can get used to what goes on. This will make people less nervous when a police officer has to stop them, which will lead to better interactions

## Snowmageddon

Over the last month, almost eight feet of snow has accumulated in Boston, Providence, and surrounding areas. The consequences of this snowfall are tremendous. With consistently below-freezing temperatures, a bitter wind chill, and over 90 inches of snowfall in certain areas since late-January, the northeast has been left in a crippled state.

Supermarkets and convenience stores have been barren for weeks. The trend of panic-buying has made its way to Scoop, where students have depleted the stock and shipping delays have left shelves near-empty. Companies such as FedEx and UPS have been unable to keep up with shipping demands due to inclement weather. As a result, students have resorted to making frequent trips to nearby stores like Target and spending large quantities of money stocking up on foods for days when it is simply too cold to step outside.

Major cities such as Boston and Providence have spent over twice their respective allocated budgets for snow removal. Pipes are bursting, ceilings are leaking, and basements are being flooded. Financially, this winter has been an absolute nightmare for families all over the east coast.

These families have been presented with an even larger obstacle. Children are staying home from school and their parents are unable to get to work because the road conditions are so poor. Parents are at risk for losing their jobs and, in extreme cases, their homes.

At Bryant, snow days have thrown courses off-schedule, and REDday has been cancelled for this year. Classes have been rescheduled for weekends and professors have been forced to rework their syllabi. Students are stressed out over making up missed coursework.

Though facilities and maintenance crews continue to work tirelessly to clear out pathways across campus, walking conditions on campus have worsened. Freezing rains have created patches of black ice, and in areas where snow has melted there are deep puddles of slush flooding the paths. "It's just a shame that the sidewalks are barely walkable even several days after a storm", sophomore Amanda Walsh noted. "We live in New England so I feel as if Bryant should know how to approach a snowy season".

Finding parking on campus, though never easy, has become nearly impossible. Students' cars are buried under mounds of snow and stuck in ice piles. For those who do get their cars out and spend hours shoveling their cars out, their parking spots are taken almost immediately.

With no clear end in sight to these snowstorms, one can only wonder how much worse conditions may get. Spring officially starts Friday March 20th. Hopefully it will bring with it warmer weather, clear skies, and sunshine.

## **Brian Williams**

Misremembering or Lying?

NBC news anchor Brian Williams has been suspended without pay for six months following the revelation that he lied about a 2003 Iraq War mission. Williams had previously claimed to have been riding in a military helicopter that was hit by a grenade during the war, but is now saying that he was not actually on the helicopter at the time it was fired at. Questions were raised regarding the credibility of his story after CNN analyst Peter Bergen said on "Anderson Cooper 360" that it was impossible for Williams to have traveled with Seal Team 6, who were operating the helicopter that was shot at, as journalists are never allowed to travel with them. This event has created a lot of chaos for NBC, and they are currently debating about whether or not Williams should be fired.

One of the major issues surrounding this controversy is whether the lie was intentional or not. Williams is insisting that he misremembered the event and made a mistake when telling his story to the public, but an NBC network source states that 90 percent of the people know it is not a case of misremembering, and that the story was made up. Because it is believed that Williams blatantly lied about the Iraq War mission, it has opened the door for investigating the credibility of other events he has recalled on the air.

Prior to his suspension, Williams' credibility on numerous other stories had been questioned internally by NBC, but it was never severe enough to raise public concern or cause a full investigation. He is now also being accused of providing false information regarding his stay in New Orleans during Hurricane Katrina. According to Hunter Stuart of the Huffington Post, his story depicts a hotel filled with gangs and looters, while the manager of the hotel he was staying at insists that there was only one incident involving two looters, and that it was taken care of immediately. Similarly, according to CNN, he has been caught telling multiple versions of his encounter with Pope John Paul II, who spoke at the Catholic University Williams was attending years ago. The original story was that he did not actually speak or interact with the Pope, but, in the following years, he spoke about meeting and having a conversation with him.

In an article published by the Washington Post, it is said that Brian Williams' storytelling ability is what helped him connect so well with viewers. However, it also points out that it is what has gotten him in trouble. While some are quick to call him a liar, it is also important to consider that it is easy to get caught up in the story you are reporting and, as a result, you exaggerate the facts. Unfortunately Williams has done more than simply exaggerate the story regarding the Iraq War mission, as his lie about being on the helicopter changes the entire situation at hand and leads to questions about if Williams was actually present when grenades were fired at this helicopter, which brings the credibility of the entire event into question. All of his colleagues at NBC insist that Williams is a great journalist with a passion for what he does, and they want to believe he did not commit any intentional deceitful acts. Whether it was a matter of getting caught up in the job is an issue still being discussed, and Williams' future with NBC is currently being weighed by the network.

## **Fire Safety Tips**

Kitchen safety is important for both on-campus students and those that live off campus. While we have safeguards in place on campus, you are responsible for your safety off campus. The following are good safety practices that can be followed by all students:

- •Turn on the exhaust fan when you cook. This helps to limit the possibility of a smoke detector being activated, and it also limits any grease fumes being generated.
- •Become familiar with all the fire-safety tools in your living space (fire extinguishers, fire alarm devices, sprinklers, etc.) Know where they are and how they function.
- •Keep all objects other that cooking utensils away from the cooking surface. Many items, including plastic utensils, will ignite and cause a fire once heated by the stove.
- •If you encounter a pan fire on the stove, the best and easiest thing to do is to cover the pan and smother the fire. DO NOT use water to extinguish the fire. This will cause the burning grease to run and will only serve to spread the fire.
- •Use the stovetop for cooking ONLY. Do not use it as a lighter. This leaves residue on the burners which may cause a fire later.
- •Scalding can occur from hot steam as well. Be careful when lifting lids from hot food (including opening that hot bag of microwave popcorn)!
- •Never cook in loose clothes and keep long hair tied back. You don't want anything accidentally catching fire (not to mention hair ending up in the food!).
- •Turn pot handles away from the front of the stove. You can't bump into them if they're out of the way.
- •Keep all combustible materials away from the stove (napkins, paper towels, papers,
- •Once you have started cooking an item, do not leave it unattended. Cooking food left on the burner for an extended period of time can cause a fire.
- •Periodically clean your stovetop and remove any accumulation of grease to reduce the chance of a fire.
- •If your stovetop malfunctions, stop using it and notify the RA immediately. This will allow repairs more quickly.

## Anthem faces largest security breach to date

Anthem, one of the nation's largest and most reputable health insurers, has fallen victim to a monumental cyber attack. While the breach was detected toward the very end of January, the announcement that as many as 80 million customer accounts had been hacked was not made public until almost a week later. The company is facing some criticism for their delay in communicating the information to the media, however, they are being praised for what is truly important—their quick report of suspicious network activity to the FBI. In the case of a security breach such as this, immediate

notification to law enforcement is vital in order to identify responsible criminals before they are given the chance to potentially destroy evidence. Thanks to their timely alert to officials, FBI spokesman John Campbell, describes Anthem as a "model" to other companies who face similar attacks.

As encouraging as this feedback is, it does not make the underlying issue less concerning. According to Alyssa Newcomb of ABC News, hackers now have the names, addresses, contact information, birth dates, social security numbers, medical IDs, and employment information of tens of millions of people across the nation, making it the largest security breach to date. The breach of social security numbers (SSNs) poses a particularly strong threat as they are essentially each citizen's national identification, and can unlock endless private information. Young children are even more vulnerable when it comes to the issue of stolen SSNs.

As NBC News stated, "For most minors, their number is pristine - it's never been used and is not yet associated with a credit file. That means there's very little chance that the credit reporting agencies are monitoring it." Because these agencies are not tracking the file, it gives criminals the opportunity to match the number with a different name and birth date, creating a fake identity

and using it for a variety of fraudulent activities. It is extremely important that parents keep an eye out for red flags that may indicate the theft of either their child's or their own social security number.

Anthem is now handling the cyber-attack in the most responsible ways that it can. The company's chief executive, Joseph Swedish, sent letters to millions of members so he could personally apologize for the security breach, even though his and many other Anthem associates' information had been accessed as well. The company is now offering free credit monitoring and identity theft protection to its current customers and former customers from the past eleven years.

At this point, what is most important is that every customer watches for any sign of suspicious activity within their own account and information, and continues to do so even after attention wanes. Identity thieves may keep information for years without deciding to act upon it. When they finally do, time is critical in addressing the issue. The attack on Anthem is just another reminder of the persistent threats faced by massive industries such as healthcare providers and retailers. Their security is vital in order to protect the information and identities of our nation's citizens.

## Yahoo's Mayer makes pitch to work with app developers

SAN FRANCISCO - In a pitch to imprint Yahoo onto the world's smartphones, CEO Marissa Mayer gathered hundreds of software developers from around the country Thursday to showcase her company's turnaround and reveal new tools to make money from mobile applications.

"Mobile at Yahoo went from being a hobby, with just 50 people working on it, to more than a quarter of our business last year, and we'd like to help you do the same," Mayer told the crowd of about 1,000 people.

The venue was decked out in Yahoo purple for the company's first mobile app developer conference, a geeky Silicon Valley tradition already in place at some of the rival tech companies that long-struggling Yahoo hopes to emulate and compete with.

While Yahoo's traditional core business of Web advertising continues its steady decline, Mayer said the company is now the world's third-largest mobile advertising firm with about 575,000 monthly smartphone and tablet users and \$1.26 billion in annual gross revenue from mobile devices, up from almost nothing when she arrived in summer 2012.

"I feel confident that we've caught up," Mayer

The free products that her team announced Thursday all cater to independent developers hoping to grow and track their audience and make more money from the apps they create. Many of the new tools were developed from Yahoo's acquisition six months ago of San Francisco mobile analytics firm Flurry, already a popular platform for app publishers.

One of the new products makes it easier for developers to use Flurry to understand app users. Another allows independent developers to integrate Yahoo's search engine directly into their apps. And the new services allow users to tap into Yahoo's mobile advertising platform, known as Gemini, and video advertising platform BrightRoll, which Yahoo bought last year.

Mayer described the conference as a "forkpoint" in Yahoo's evolution toward a stronger mobile

presence and a chance to share with independent developers some of the fruits of Yahoo's recent growth. It also helps Yahoo leave its mark, and its ads, on an entire network of apps not developed by the company.

"If we can help developers make their apps better, everyone wins," she said.

Yahoo's shift under Mayer has been a "dramatic cultural change" away from a rules-based culture at the Sunnyvale Web pioneer toward a fast-growing startup environment, said Adam Cahan, Yahoo's senior vice president of mobile, in an interview at the conference Thursday.

Cahan said mobile ads have greatly improved over the past two years from being a shrunken version of Web page banner displays to becoming more ingrained in the experience of using a smartphone. Part of Yahoo's strategy has been to become a leader in making both apps and their ads look and work better.

Developers who attended the conference applauded several of the announcements, with the strongest cheers for new analytical tools.

"It's a smart move for Yahoo to focus on mobile," said software engineer Delaney Parker, of job search engine Simply Hired, which has long used Flurry to analyze its users.

As a smartphone user, Parker said he also looks forward to anything Yahoo can do to make mobile advertising "less jarring."

"A lot of apps are task-oriented, so being interrupted with an ad while trying to do something is annoying," he said.


The stock market showed another strong week for investors. Although the gains might not have been as good as in previous weeks, they still stand impressive.

The NASDAQ had the strongest week, gaining 1.27%. The NYSE gained .60%, the Dow .67% and the S&P 500 .63%. Although the gains do not seem significant, accumulated over a yearly basis would result in massive gains (66%, 31%, 35%, and 33% respectively).

Gains, however, cannot be expected week after week. There will be some weeks where the market will plummet and others where it will skyrocket. There will also be weeks with small losses or gains. As an investor, it is important to follow the trends of the market in order to have a slightly better idea of what to expect. Looking at recent trends, particularly in the Dow, over the past three months, one would notice that once the Dow gets slightly over 18,000, it draws back. It has done this twice in just the last three months.

That's not to say the Dow will suddenly feel this drawback. It could just as easily take off to 19,000 as it could regress back to 17,000. Like I said last week, if investors feel the companies that comprise the Dow index represent good opportunities, then the Dow will continue to climb. On the other hand, if investors instead feel the Dow is overvalued, then the index will inevitably fall.

All in all, another good week in the market. Let's hope this week's performance will be even stronger.

Straight from physical therapy I head to our mandatory team lifts at two o'clock. From lifting, we go to practice at 3:15 until around 5:30 or so.

Post-practice, I take a shower and revisit my trainer once again for some ice to cool down my legs or whatever other part of my body is sore from that day. By this time it is about 6 o'clock, right in time for study hall. I grab something on the go once again or maybe sit down in Salmo for about 10 minutes and eat before I am required to get my study hall hours in; 8 per week. I grab a coffee quickly so I don't pass out while studying. It's around 9 or 9:30 when my roommate and I finally make it back to our room. As soon as my body hits the mattress and the television lights up, I am sleeping like a baby.

No, I don't think college athletes are given enough time to really take advantage of the free education that they're given, and it's frustrating because a lot of people get upset with student-athletes and say they're not focused on school and they're not taking advantage of the opportunity they're given. I would love for a regular student to have a student-athlete's schedule during the season for just one quarter or one semester and show me how you balance that.

Richard Sherman, professional football player for the Seattle Seahawks, who went through the same rigorous schedule, agrees. It really is tough work; you have to be very disciplined and dedicated to yourself in order to be able to keep up at the Division 1 level. 
#### Basketball

Another good match up from this week was team Cool Ranch against the Sky Hookers. Cool Ranch was able to edge out a mere two point victory by a score of 45-43.


#### Floor Hockey

The outside foam cup restricts the coldness, keeping it away from your already cold hands. This basically acts as an iced coffee koozie, which Dunkin Donuts actually now sells for a few dollars. They are reusable and do the same exact thing as the extra Styrofoam cup does without the significant ecological

consequences. Also, for those of you who also double-cup in the summer because it contains the condensation, the koozie addresses that problem as well.

I am not trying to sell you this product, but I am telling you that the double cup is completely unnecessary and wasteful. Styrofoam itself is very bad for the environment. According to Bloomberg Business, Styrofoam is made out of a type of "thermoplastic petrochemical called expanded polystyrene" and this is not biodegradable and cannot be recycled. It significantly adds to overall waste and can actually contaminate the course of recyclable metal, glass, and plastics.

Almost 100 cities and towns have banned single-use Styrofoam food and beverage containers. This is in an effort by cities to reduce waste and to become more environmentally friendly, as there has not yet been a solution to effectively recycling this plastic foam. New York City is among those with a styrofoam ban; they have until the summer of 2015 to find a way to make this material safely recyclable before the official ban goes into effect. If this passes, it will have a huge impact on Dunkin Donuts, other coffee shops, restaurants, and stores, as they may no longer be able to sell

products using this type of packaging.

Dunkin Donuts has a lot to think about considering the increasing number of foam bans in large cities. According to the New York Daily News, Dunkin Donuts has been trying a few alternatives, one of them being a "double-walled paper cup." However, they are still fearful that customers may not like this alternative and will want the iconic original cups that function just as well.

At this point, it is difficult to tell what exactly is going to happen; Dunkin Donuts and other restaurants still have some time to figure out alternative options. Meanwhile, before asking for that second cup that you barely use and don't really need, consider how harmful that luxury actually is. Think about the long term implications of those cups on the environment, as they build up in landfills for years.

Buy some gloves, a koozie, or maybe just bear the cold for the few minutes that you will be outside. You will be okay, the environment on the other hand, cannot survive like this. If we continue to use these non-recyclable materials, we are unnecessarily contributing to excessive waste and its effects on the environment.

Since 1985, college costs in the United States have increased by nearly 500 percent, and tuition fees are expected to keep climbing. In many other countries they have done quite the opposite. Currently there are several countries that offer free higher education. Germany, one of the first tuition free countries since October 2013 has always boasted low tuition rates. The German government has done away with tuition fees and now fully funds the education of not only its citizens but also of foreigners.

In Denmark, most students

graduate without significant debt. Danish citizens do not have to pay tuition fees, in fact they receive about \$900 per month from the government. This financial support does not have to be paid back, and the only requirement is that they do not live with their parents. It may seem to most people that these college students may spend this money in bars and clubs. However, most Danish students understand that this money is essential in enabling an excellent education for everyone, regardless of their family's

Sweden and Brazil also offer free education to their citizens. There is no negative correlation between free education and private education systems. As the University of Sao Paulo and the University of Uppsala, Sweden both are prominent in international academic rankings. I feel that there are both positive and negative impacts of free education.

College tuition paid by the government will give students the luxury of receiving a free education. This will allow tuition discouraged young people who do not have a traditional academic family background to take up studying. Also it gives recent college graduates more options and flexibility without the burden of student loans. Currently, 80 percent of college seniors graduate with student loans, the average

debt level amongst these students rose to \$29,400 in 2012 – a 25% increase from 2008.

A free education system will let high school students know that they have the ability to go to college regardless of their financial situation or academic standing prior to graduation. This will lead to a rise in graduation rates. On the other hand, this could lead to an influx of students entering college without the motivation to excel as their fees are taken care of. In today's society it is normal for students to take on debt to put themselves through college. In my opinion, this acts as a source motivation for students to perform to the best of their ability throughout

their college years.

Using Denmark, Brazil and Germany, countries that have already put a tuition free scheme into place as a model there are effects on its citizens and its country as a whole. But to finance this system there must be an increase in taxes such as Denmark has with one of the highest tax rates in the world. 



In Birdman, Alejandro González Iñárritu brings out some of the best performances of the year with his ingeniously subtle screenplay and his dedicated style of directing. His script follows Hollywood actor Riggan Thomson around. Riggan Thomson is relentless. He won't stop. He yells at his daughter because he loves her. He runs through Manhattan in his underwear because he refuses to see his play fail. He begs a critic to give him a fair shake because he doesn't just want this comeback - he needs it.

Birdman is about reality. Even though its characters may be drug addicts, 1980s celebrities, angry cynical critics, and alcoholic method actors, its characters carry an intriguing sense of relatability. Their struggles and their pains, though not always mirroring those of our own lives, are human. I don't know about you, but I had no idea what it was like to be a depressed former celebrity with an ex-wife, a mistress with a pregnancy-scare, and a daughter who's no stranger to rehab. But thanks to Birdman, I


do now, because the movie never forgets to remind the audience that it is simply a view into Riggan's quest for redemption, and that's something almost everyone can relate to.

Iñárritu plunges his audience into Riggan's world. His characters are expertly constructed - we simultaneously root for and loathe Riggan, while we eagerly await the return of Edward Norton's Mike every time the camera pans away from him. Iñárritu had a vision for making this movie more than just a great screenplay, and with the skills of cinematographer Emmanuel Lubezki, Birdman's impact jumped from marvelous to historical

Following the cast through rooms, hallways, buildings, and massively mobbed city streets, the camerawork of Birdman is formatted in a way of making the viewer think the film is shot in one continuous take, and so when the cuts occur, you don't even notice it (which makes me wonder where this movie's Best Film Editing nomination is). Lubezki, winner of last year's Best Cinematography Oscar for Gravity, is in a pretty good position to get a second consecutive win. Equal credit goes out to the actors for not only going along with the experimental style, but embracing it.

I'll try to avoid labels in my wrap-up, as I don't think Riggan would appreciate them too much were he a real person. Birdman is both inventive and revolutionary. Few movies dare to reach for the ambition that Birdman achieved, and even less will live up to that expectation with the bar of originality, cinematography, and bluntness that the film has set. Although it drags at times, Birdman is an accomplishment on various levels of filmmaking, and earns its recognition.




## From the bookshelf to the big screen

When a book becomes commercially successful, whether it is Fight Club or Fifty Shades of Grey, production companies compete with each other for the licensing rights for the book to be made into a movie. The filmmakers hope to profit from the books that already established commercial success and must then impress two audiences, those who have read the book and those who have not. For example, when I went to go see the first Hunger Games movie I thought it was great. The movie was well paced and had an interesting concept, but the people that I talked with who read the book said they were not impressed. To them, the movie was not entirely



true to the source material and left out major chunks from the book.

While there are plenty of pitfalls in adapting beloved novels into films, some of the highest critically acclaimed movies can trace their origins back to the bookshelves. One of the largest success stories in this arena has been Peter Jackson's Lord of the Rings trilogy. This series of films revived J.R.R. Tolkien's rich complex universe and brought it back to life. Each of the three movies was nominated for an Oscar in the best picture category, and in 2003 the last movie of the franchise took home the award. These blockbuster movies proved not only to be commercially successful, but were instrumental in rebranding the fantasy genre as credible among studios.

While there may always be some disapproval from readers who do not want to see their favorite book

tarnished by Hollywood, as long as the medium remains profitable there will be a studio looking to capitalize on their accomplishments. However, these individuals can take comfort in the fact that despite the entrepreneurial nature of production companies, the theatrical release of these films has the ability to encourage its audience to pick up the original book and discover what inspired these filmmakers to action.

#### The Stanford Daily Stanford College

Six Stanford students were arraigned in San Mateo County Superior Court on Monday, Feb. 23, on a single misdemeanor charge of violating Section 647c of the California Penal Code, which prohibits the willful obstruction of any person's free movement in a public place. The charges stemmed from the San Mateo Bridge protest led by the group Silicon Shutdown on Jan. 19.

The students all pleaded not guilty. A pre-trial hearing date was set for April 21, to be followed by a jury trial on May 26. If found guilty, they may be sentenced to up to one year in county jail or a maximum fine of \$1,000, or both.

Vassar College

The College has drafted a new policy forbidding consensual romantic and sexual relationships between students and faculty. Currently, the Faculty Handbook's policy states, "The College strenuously discourages romantic or sexual relationships between faculty members and students, administrators and students, and staff members and students... A faculty member, administrator, or staff member who is involved in a romantic or sexual relationship with any student must disclose its existence to his or her department chair, dean or supervisor and must cooperate fully in making alternative arrangements for the supervision, evaluation, teaching, grading or advising of the student." The policy will, however, grant exceptions in the case of spouses or domestic partners of faculty members enrolling as students. If the draft goes through, potential violations of the new policy would be investigated by the Office of Equal Opportunity and Affirmative Action, and could result in disciplinary action such as leave without pay or even termination, as determined by the Dean of the Faculty.
