### Legislation: So Far, A 15 Year Fight


- S 1520 Military Justice Improvement and Increasing Prevention Act of 2021 Senator Gillibrand, D-NY
- Establish a position of Court-Martial Convening Authority to take on the powers of commanders and place them in the hands of independent prosecutors
- Now attempting to add more crimes to the list of cases
  - Part of the larger National Defense Authorization Act

Faculty are not sexual harassment and assault advocates nor are they interventionists



- Buy-in two directions
- Professionalize the field
- Collaborate
- Revert from advocating the topic toward integration of the topic




### Building **Blocks**

- Set minimum educational competencies first
- Place wisely
- Ensure cut and pasting is not occurring without due consideration of purpose and overall fit into a program
- Encourage a working knowledge of the subject matter for faculty well prior to teaching the topic
- Use high-quality materials that interconnect Military-Culture-Congress
- Use the right curriculum tools
- Ask probing, thoughtful questions

# Primary Unique Attribute of the Topic in a Public Policy Curriculum

- The topic is being tied to a formally legislated agency that is attempting to modify the military culture
- Understand there are three types of cultural policies
  - Those that are rule-shifting, those that are culture-shifting, those that are a combination of both
- Therefore, the discussion should never be without some form of information that addresses both (1) rule and law-making <u>and</u> (2) military culture

Department of Defen Annual Report on Sexual Assault in the Military



### Best and Problematic Question Sets

- Current Questions and Their Weaknesses
- Does Congress have a role in shaping the culture of the military and if so, what tools are available to do so?
- Why are Members of Congress interested in how the military investigates and prosecutes cases of sexual assault?
- Why do leaders in the DoD resist change in this instance?
- What other instances have you seen where tensions exist between Congress and the military regarding a policy outcome? How was it resolved?

- Which comes first, changing the culture or changing the law?
- What mandates does Congress have to intervene in the cultural environment of the security sector?
- What were some challenges between the Senate Armed Services Committee and Senator Gillibrand? Between the Congress and the Military?
