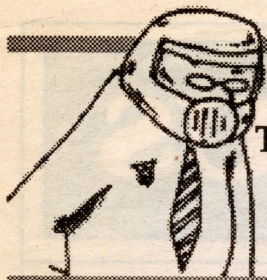

## Black History Month begins with academics

The Office of Dean of Students organized a seminar with which to kick off Black History Month. This seminar took place in Student Union room 214 on Tuesday February 4, during activity hour. A notable speaker, Dr. Jawanza Kunjufu, spoke at this event, organized by the Black History Committee at Northeastern.



Kendra Young started the program by introducing Kunjufu, who has won the admiration of many through a number of notable accomplishments. He was very pleased to speak at Northeastern about Black History and issues concerning the black community. Kunjufu is the president of African American Images, which is a publishing company here in Chicago. He is also the author of several books, has served as a consultant to the Chicago Department of Human Services and the U.S. Office of Education, and he is a former instructor at the United Theological Seminary's Doctoral Division.

Kunjufu stressed at the beginning of his speech that African-Americans should study their history, and learn about their culture not only during Black History Month, but also during the "rest of the other eleven months of the year." Kunjufu's speech centered on "academic achievement" and the lack thereof among African-American youth. He went on to explain the consequences of this lack of academic achievement in youth, and he went on to address the causes behind the lack of academic achievement in African-American youth.

According to statistics that Kunjufu presented to the audience, compared to Asian and White college students, African-American college students have the highest drop-out rates. According to the data that Kunjufu made mention of, Asian college students have the highest rate of college graduation, that being 64%, followed by White students with 56%. A low 41% is the graduation rate of African-American females, and an

alarming 32% is the rate of graduation for African-American males.

Kunjufu blames the shortage of academic achievement, partly on the African-American students, partly on their parents, and partly on the political and educational systems that exist in this country. He explains that although African-American students find the time to spend on recreational activities such as watching television and playing basketball, they do not take as much time to study. This in turn hurts their academic performance, and ultimately causes many of them to drop out of college. "What you do best, is what you do most," explained Kunjufu.

He then explained the role that the African-American parents play in this issue of "shortage of academic achievement" in their children. The African-American parent all too often waits for the school system to teach his/her child about African-American history, explained Kunjufu. This practice has deprived the African-American youth from learning a complete version of their history; instead, they only get the Eurocentric version taught in K-12 schools throughout the country. Instead of relying on the school to provide proper history education for an African-American child, Kunjufu, suggests that the parents take a more assertive role in educating their child at home, and starting from a very early age.

Thirdly, Kunjufu examined the role that the education and the

## Blix reports an obstacle for U.S. Security Council remains divided; U.S. and Britain continue to push for resolution as U.N. stalls war talk

February 14<sup>th</sup>, U.N. chief weapons inspector Hans Blix delivered his second report on the current weapons investigation in Iraq to the U.N. Security Council. The Security Council continued undecided on any military actions against Saddam Hussein's regime. Blix's report on Friday reported no disclosure of any completed weapons of mass destruction. What was included, and further documented by U.N. nuclear chief, Mohamed El Baradei, was Iraq's continued program of acquiring or manufacture of banned weapons. Chief among these banned weapons were the still unaccounted for biochemical weapons stockpiles like VX and Anthrax.

The U.N. weapons inspector also took U.S. Secretary of State, Colin Powell, to task over photographs introduced in the previous Security Council meeting. Blix stated that interpretations of the photos as evidence of Iraq's deception as only a possibility and not a fact. "The reported movement of munitions at the site could just as easily have been a routine activity," Blix told council members. He proceeded to inform of the increased productivity in the investigation, providing statistics on what has transpired so far.

### Weapons sites and rockets

The report revealed that there are now 250 U.N. personnel that have conducted over 400 inspections at 300 sites. Hans Blix stated that over

200 chemical weapons samples had been collected. The United Nations Monitoring, Verification and Inspection Commission, the U.N. bureau in charge of destroying munitions, UNMOVIC, has begun to destroy 50 liters of mustard gas. Several hundred boxes of documents pertaining to chemical weapons and advanced artillery systems.

From their discoveries, attention moved towards the issue of the interviews with scientists. Scientists had been declining interviews unless they were taped and monitored by an official from the regime. Out of the suspected hundreds of scientists working for Saddam's weapons program, only three were interviewed by UNMOVIC. Despite possible coaching by their handlers, the interviews revealed several startling projects being implemented by the government.


The most provocative of these revelations was the construction of rockets or missiles that exceed the limits imposed after the Persian Gulf War. Inspectors had uncovered versions of the al-Samoud Two and al-Fatah rockets. The rockets' design with

illegally purchased SA-1 engines, exceed the 150 kilometer (93 miles) limit that Iraq is allowed for its ballistic weapons. UNMOVIC reports indicated that the design of the missile "shells" (they were in a state of pre-production at the time of discovery) indicated that the missiles have a larger diameter than what was allowed. Secondly, the engines are, according to the report, a derivative of a surface-to-air missile system, another piece of military hardware that is officially banned according to Security Council Resolution 687 in 1991. Blix further stated that Iraq was in the process of refurbishing its old missile manufacturing capabilities for the al-Samoud Two designs. "If proscribed weapons exist they must be presented for destruction. If they do not exist, credible evidence to that effect should be presented," Hans Blix concluded on this.

Blix final part of his report was an announcement that UNMOVIC would begin using U2 spy planes and other reconnaissance aircraft including drones from Germany. Blix concluded that Iraq's cooperation has improved, yet the regime could be more forthcoming.

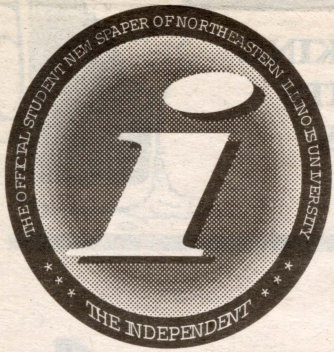

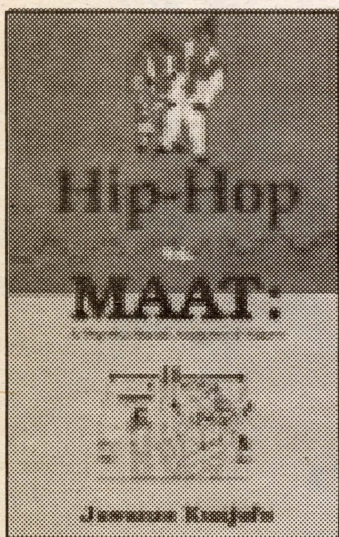
political systems play in the shortage of academic achievement in the African-American youth. According to Kunjufu, the rate of property taxes in a certain area of the city determines the amount of funding the schools within that area receive from the city. For example, an area with a high property tax such as Park Ridge might get \$18,000 per child per year in funds, whereas an area of low property tax such as Chicago's South Side might get only \$4,000 per child per year in funds.

The distribution of funds in

public schools in keeping with property tax is unfair, Kunjufu believes. It puts a large gap in the academic achievement between African-American students, who mainly come from disadvantaged backgrounds, and other more advantaged students, he explained.

On the issue of Affirmative Action, which is a program implemented by colleges and universities across the country in which ethnicity and color are used as a basis for admission into the institution, Kunjufu vows that he will continue to be an advocate for the Affirmative Action program as long as the rate of property tax continues to determine the amount of funding that each public school receives. Once the distribution of funds to public schools ceases to mirror property tax value, minority students who come from disadvantaged backgrounds will no longer need Affirmative Action to help them in admission into certain institutions, Kunjufu asserted.

Overall, the program was very insightful for the audience; throughout the speech, audience members were nodding their heads in agreement with Kunjufu's statements, and many clapped and cried things like "yes" and "amen" whenever Kunjufu stated something they believed to be true. As for the Black History Committee, they promise that programs such as this will continue to be held throughout the month of February.



## U.N. meeting continued

"The period of disarmament through inspection could still be short, if immediate, active and unconditional co-operation with Unmovic and the IAEA were to be forthcoming," Blix then added that had Iraq cooperated to this degree, they may have not have faced a decade of sanctions.

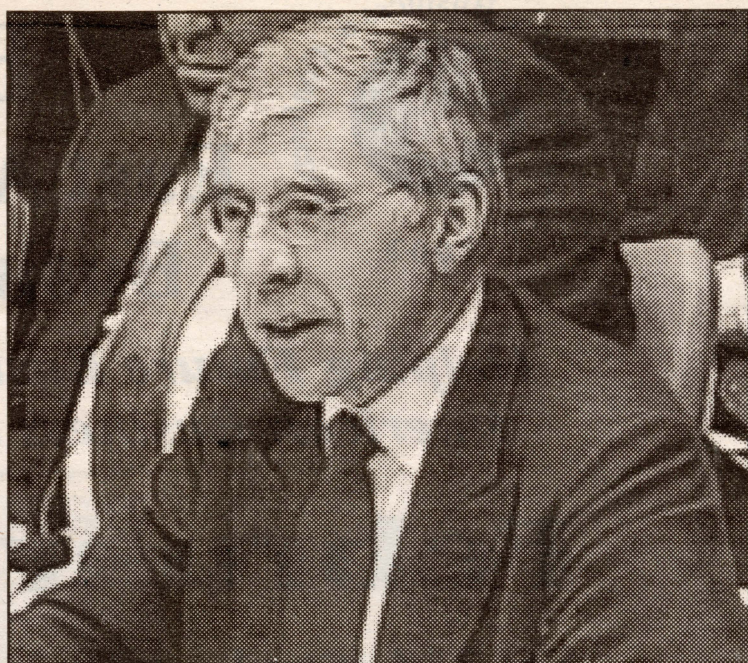
### El Baradei's Report

Following Messrs Blix was the Secretary-General of the International Atomic Energy Agency (IAEA), Dr. Mohamed El Baradei. Dr. El Baradei began with the urgency of more equipment to check radiation levels like gamma rays. El Baradei then moved on to the issue of the discovered aluminum tubes and that the IAEA was still deciding whether the tubes could be used as gas centrifuges. These centrifuges, he continued, could be used to enrich uranium or as a booster for rockets. "We have to date found no evidence of ongoing prohibited nuclear or nuclear related activities in Iraq. However, as I have just indicated, a number of issues are still under investigation and we are not yet in a position to reach a conclusion," Dr. El Baradei said to the council.

Two issues seemed to stand out to the Secretary-General, one being the use of high explosives. The second issue being the discovery of using a laser system on uranium. On the first issue, Dr. El Baradei stated that there was no evidence that high explosives suitable in the use of developing nuclear weapons had not been use, as Iraq had stated, for mining usage. On the second issue, documents recovered by UNMOVIC agents detailed Iraq's use of lasers to enrich uranium at several sites, sites that the IAEA says they already know about. Dr. Mohamed El Baradei concluded stating that he, like Hans Blix, hopes that Iraq increases its cooperation.

### Reaction at the U.N.

Following their reports, various foreign ambassadors and state

ministers gave their reaction to today's information from Blix and El Baradei.

*Syrian Foreign Minister, Farouq al-Shara*: "Inspections are bringing about important results, dialogue, co-operation, and mutual confidence between the inspectors and Iraq. The council must therefore continue to support the inspectors and allow them sufficient time to undertake their task."

*French Foreign Minister, Dominique de Villepin*: "The use of force against Iraq is not justified today; there is an alternative to war, and that is to disarm Iraq through inspections."

Following de Villepin's speech, an unusual round of applause broke out across from many members of the council, taking many by surprise. Looking a little upset but not unshaken, U.S. Secretary of State, Colin Powell stated the U.S.' position: "What we need is not more inspections... what we need is immediate, active, full co-operation on the part of Iraq. What we need is for Iraq to disarm."

"[Recent signs of co-operation] are not responsible actions on the part of Iraq, these are continued efforts to deceive, to deny, to divert, to throw us off the trail, to throw us off the path."

"We cannot allow this process to be endlessly strung out as Iraq is trying to right now... My friends, they cannot be allowed to get away with it again."

### Spain and the United Kingdom soon added to Powell's argument

*UK Foreign Secretary, Jack Straw*: "They've lied, they've concealed, they've played games. The issue before us could not be graver. Most significant part of Blix's report on his comment on Iraq's forthcoming."

"The issue before us is the authority of the U.N. and the defiance of this council. This period of 12 years, since passing 687 in 1991, has been 12 years of humiliation."

"This is not just about Iraq, but also of proliferators in general and how we secure the world."

"I hope and believe that a peaceful resolution to this crisis may still be possible, but this will require a dramatic and immediate change by Saddam. This will only be achieved if we in the Security Council hold our nerve in the face of this tyrant."

*Spanish Foreign Minister, Ana Palacio*: "What we don't need is more inspectors. We risk losing credibility of this council. Iraq's cooperation has not been forthcoming."

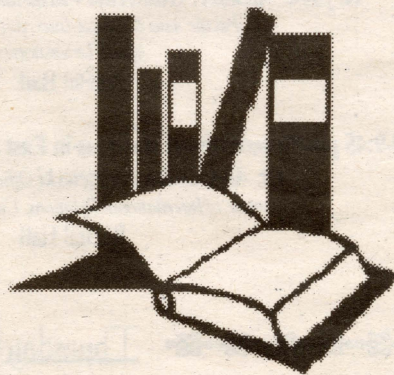

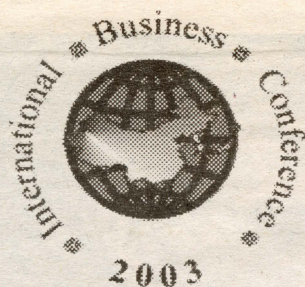

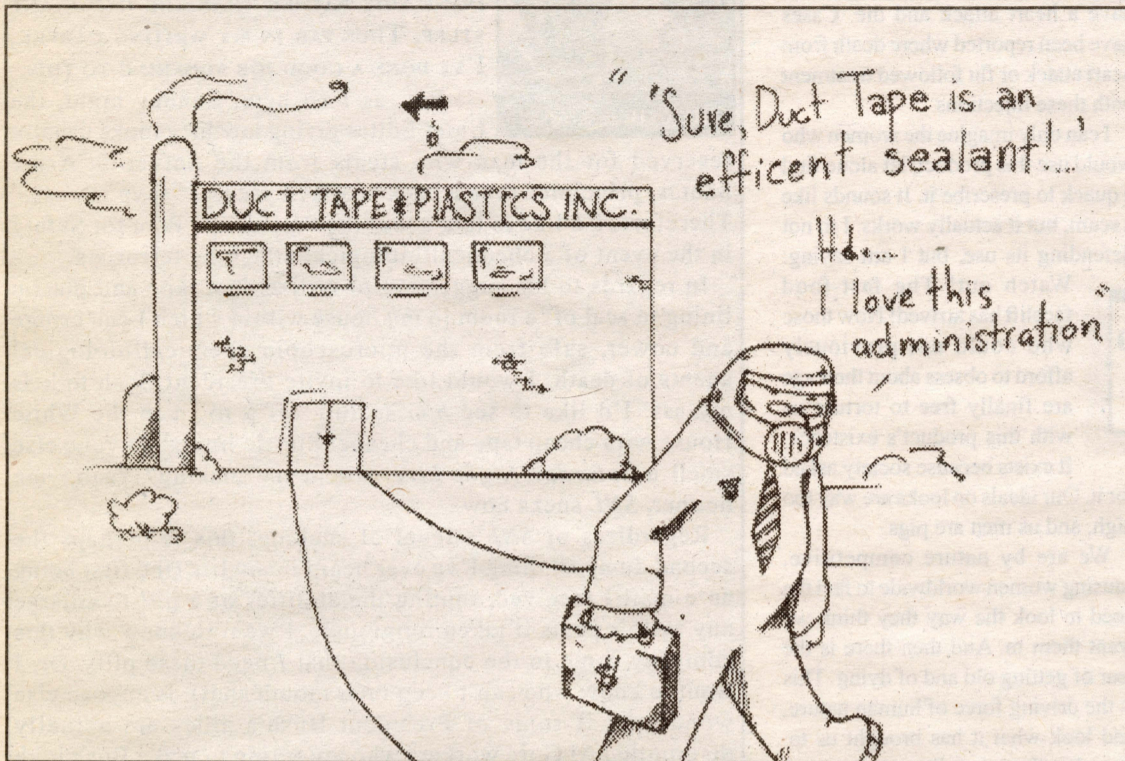

## Botox is a sad example of insecurity

Many celebrities and rich folk have partaken in the plethora of cosmetic surgeries out there. You can tuck, fold, and sew your face tighter. You can augment or reduce your breasts. Or you can have all the fat sucked out and made into soap. You can even have permanent makeup tattooed on, just in case the Paparazzi catch you at a bad time. But now, with the widespread availability of Botulinum Toxin injections, even poorer folk can have cosmetic surgery.

Marketed as BotoxÆ Cosmetic, this is a muscle relaxant that a doctor shoots into your face. It acts as a temporary facelift, and can, according to the parent company Allergan, give you a facelift and erase wrinkle lines in ten minutes. A vial of BotoxÆ Cosmetic contains 100 units (U) of Clostridium botulinum type A neurotoxin complex, 0.5 milligrams of albumin (human), and 0.9 milligrams of sodium chloride in a sterile, vacuum-dried form without a preservative. Yes, that albumin comes from donated human blood. Sick!

To be fair, Botox has been used for over ten years, quite successfully I might add, to treat severe cases of

medical conditions. It is used for the treatment of chronic crossed eyes, muscle spasms in the eyelids, and uncontrollable spasms in the head and neck. It has been approved by the FDA to treat "frown lines" since two years ago. This is pure hedonism.

On the news recently I have seen the re-hashed stories of Botox parties, where housewives have gotten together to get these "fast-food facelifts" as a group. The truth is, the drug can only be prescribed and administered by a doctor. In Chicago alone there are literally thousands of plastic surgeons eager to ease timid, insecure women into being

## Peterson mystery is affair gone bad

Then again, is it because people have started to use services such as Hot Wire and Price Line to get the absolute best deal? It might just be the general state that the economy is in, that affects both business and pleasure travel.

Well, for whatever multitude of reasons, the major airlines are struggling to stay afloat. When you are sinking, the first thing most people do is get rid of the excess weight they are caring. If you have flown recently you have probably realized the serious lack of food on most shorter flights. In fact, unless you are flying to California, you

should consider yourself lucky to get a bag of pretzels and a can of soda. Airlines are cutting back left and right, and these cut-backs affect the people that do business with them. Culinary Foods Incorporated, a division of Tyson Foods, based out of the south side of Chicago, which supplies airlines with passenger meals, has just announced that they are laying off four hundred people due to the airline cut-backs.

The airlines are also increasing their restrictions. Reservations are not as easily changed now once they have ticketed. Nine times out of ten, in order to change the date on a ticket, you will have to pay a

twelve hours of leeway in your schedule for both your arrival and your departure.

As far as making your actual flying experiences more enjoyable, try to get to the airport at least an hour before your flight. When you arrive, if you have luggage, ask a skycap to curbside check your luggage for you. It will cost you a few dollars in tip (the going rate is about two dollars a bag), but I think it is better than lugging your bags inside and waiting in line.

Many airlines now have self-check-in, and some have even started a service where you can check in at home via the Internet. Many of these services even allow you to pick your own seat.

Now I know that on an airplane space is a premium; in order to get the most space possible, try requesting an exit row if you are not flying with any small children.

Also, if you are flying United Airlines, request a seat in Economy Plus. Economy Plus is the first 10 rows of coach on United where they give you a few extra inches.

If at first you are assigned a seat that you do not like, don't be afraid to ask for a better one. A little secret: twenty minutes before boarding, all the seats that have not been checked in become available, so keep asking! Once you're on the flight, don't be afraid to ask flight attendants for things; it's their job to serve you. On a final note, if you do not have a good experience on a flight, do not be afraid to call, e-mail, or write to the airline and ask for compensation.

one hundred dollar change fee. Of course, on that tenth occasion, you will have to pay for a completely new ticket. As far as the actual service goes, according to one frequent flyer, "They [airline personnel] are just as rude as they always were."

Still, it is possible to make your travel experience a relatively good one. In order to get the best deal, shop around and keep an eye out for specials. Try to book at least two weeks in advance. If you are not bound by a tight schedule, try booking through [www.priceline.com](http://www.priceline.com) or [www.hotwire.com](http://www.hotwire.com). I only suggest these options if you have about

## Prof. White: Don't Hide Behind 'Pro-Life'

Dear Editor,

It would take several tanks of liquid nitrogen to cool the vehement slanders inflaming Daniel Gonzalez's article opposing abortion (*Independent*, 2-4-03). In their absence, I will try to stick to some factual errors.

Mr. Gonzalez writes: "The actual physical and emotional stress placed on women when they have an abortion is beyond anything we can comprehend." Actually, it's quite comprehensible. When he was Surgeon General, C. Everett Koop, a strong abortion opponent, commissioned a study hoping to document that women who have abortions suffer from terrible trauma and guilt. When the study showed that no such emotional stress was evident, he attempted to suppress the findings. What is beyond comprehension is the emotional stress anti-abortionists cause women and doctors. Perhaps we might study that.

"Abortion...denies potential stars their chance to shine in our society." The chances that aborting an unwanted pregnancy may prevent the birth of a maniacal killer or mentally and physically defective infants are just as great as the probability that it will prevent the birth of a star. Which brings us to another of Gonzalez's non-points, that we "should stop being so selfish" by practicing abortion. In a world that is dangerously overpopulated, in a country that contains about 6% of the world's population and consumes about 30% of its diminishing resources, having children is more selfish an act than limiting the birth rate.

"There are many families eagerly awaiting a child to love." That should read "eagerly awaiting a *white* child." Many American families travel half-way round the globe so as not to have to adopt the many non-white orphans in the United States who are available for adoption. This means that there are many non-white children in this great racist country of ours who are eagerly waiting to shine and who will probably never be given the chance to have a family to love.

"We are all pro-life in this country." No we're not. I for one can think of a long list of people I would like to see killed. As for the rest of society, we have a murder rate which is second to none, we are one of the few countries in the industrial world that accepts capital punishment, and our military, whose reach covers the globe, has caused more deaths throughout the world than has ever occurred in the history of inhumanity.

Mr. Gonzalez finds it "humorous" that pro-choicers fight "to end capital punishment" or "rally against war." What's so funny about that, Mr. Gonzalez? There is nothing "ironically hypocritical" in people who want to protect a woman's right to abortion being opposed to war or capital punishment, since their stance on abortion does not claim to derive from a general pro-life position. Every society I know of, every religion we are familiar with, accepts the taking of human life under certain conditions. You can be damn sure that reactionary religious zealots who are stalking this land are dedicated to undermining the legal protections women and men have gained and to limiting the life, liberty, and happiness the Declaration of Independence celebrates and which we have only recently come to enjoy.

On Thursday February 13<sup>th</sup> at the Center Stage a production of the highly acclaimed Vagina Monologues was performed by six talented women. Unsure of what to expect I was pleased with the hour I spent listening to the accounts of women from all walks of life talk openly and honestly about their vaginas.

The Vagina Monologues was created by a woman named Eve Ensler and encompasses various true stories about women and some of their experiences specifically related to their vaginas, indicative to their sense of womanhood. I have to admit I never knew there were so many terms to describe the vagina. Powder box, koochie snorter, peacher and mina- just to name a few.

Some questions asked were if your vagina could talk what would it say? If you could dress your vagina, what would it wear? Maybe some frilly lace or black leather. Or maybe a baseball cap and some high heels. Some woman reported that their vaginas might say things like- slow down, speed up, stay away or come on in. No pun intended. In any case, each answer given by the woman interviewed was a direct correlation to their individuality.

All six of the performers did a great job in relaying these stories. Their animation and articulation mixed with an obvious level of sensitivity made for a thought provoking hour. I laughed out loud when the woman known as the "groaner" described the many different types of sounds made by all kinds of women during sexual intercourse. She concluded her symphony of screams just before she slumped down in her chair and asked, "Does anyone have a cigarette?"

While there was undoubtedly an element of humor present, there was also a more serious side presented. A

monologue was given about a woman who had been raped by military forces in Kosovo. Described in her story was the stripping of her identity as a woman, going on to say that she no longer knew who or where she was. Aside from the physical pain inflicted on her was a complete annihilation of her sense of self and her spirit. I had to bite my lip to keep from shedding a tear as I listened to the story of one woman's rape, because her situation is far from isolated or unique. I began to think about all the repercussions of sexual violations as they seem to inevitably begin with the vagina.

As I watched the six women who sat before me dressed all in black I began to wonder where I fit into the stories I was hearing. I have a hunch that almost any woman who sees this production could, in one way or another, identify and relate.

Some of us may be aware of the power of our vaginas, while others of us may not. Factors such as personal experience, religion, home and family life, sexual preference and standards set by the societies in which we live have and will play a part in our assessments of our vaginas.

The Vagina Monologues are very simply accounts of truth. What is true and right for one woman may not be for another, and that is what sets us apart as woman -but more importantly as empowered individuals. Say it-Vagina, Vagina, Vagina. This production emphasizes the importance of comfort and the acceptance of womanhood. I enjoyed the Vagina Monologues and would encourage both men and woman to experience it; we just might learn something.

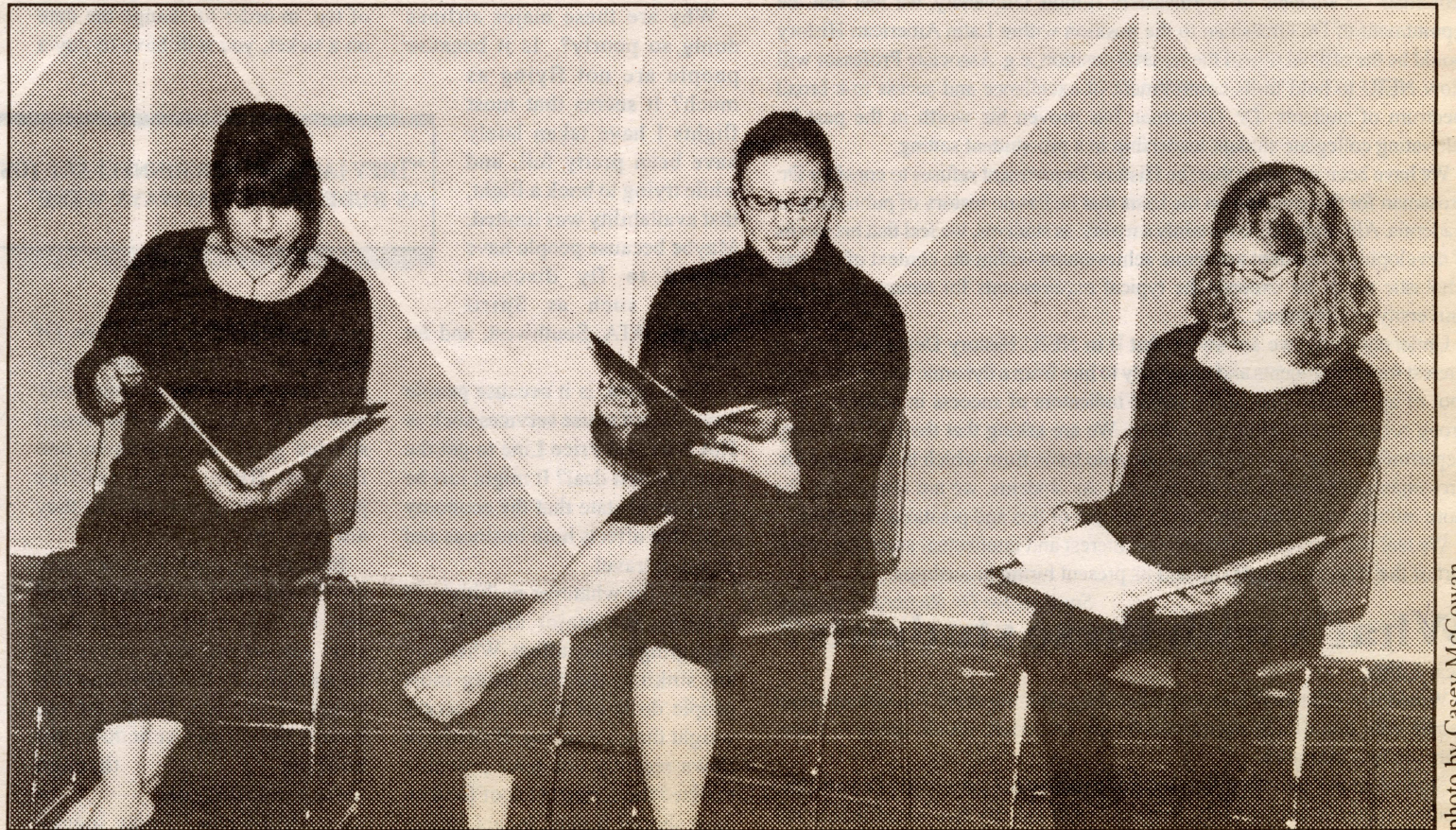

Well, they are an experimental performance company, which means that every performance is an experiment. The Neo-Futurists produce the ongoing show *Too Much Light Makes The Baby Go Blind* (30 Plays in 60 Minutes) 51 weekends a year. The show runs Fridays and Saturdays at 11:30 PM (doors open at 11) and Sundays at 7:00 (doors open at 6:30).

I first saw T.M.L.M.T.B.G.B. 12 years ago, when they were at the Live Bait Theater. My sister dragged me there with her friends, and I remember that the play blew my mind then, and left me with a sense of wonder. Now they are in fancier digs, with the entire top floor above the Nelson Funeral Home on Ashland and Foster. It is called the Neo-Futurarium, and the experience of going to the play does make you feel like you are part of an

The actors, who were kind enough to inform us that the price of the ticket was random, based on the roll of a die, welcomed the audience. As you are let in the show, an actor asks your name, and then writes you a nametag with something entirely different. I was Scary Clown, and the friend I

brought was Whoopee Cushion. (12 years ago when I went I was given the nametag Joker; I wonder if I must look like an evil clown?)

The actors attempt to perform 30 plays in 60 minutes with tremendous energy and agility, involving the audience every step of the way. At the end of each play you are encouraged to shout out the number of the next play you want to see, and the first shouter gets it. Each play is based on real personal issues from each

of the actor's lives, so is performed with passionate honesty. The night I went they did not finish the last play and a half, but it did not phase anyone, such is the uplifted wonder you feel walking out of there. No matter who you are, you owe it to yourself to go see this play!

Why should you go see it? Since you asked,

this play has been evolving and improving continuously since 1988, making it the longest currently running show in Chicago. The Neo-Futurists have toured the world with their antics, being awarded countless honors. All the material is current, as they change a random number of the plays each week based on a roll of dice. Some of the plays dealt with racism in society. One of them, called "COL. Emuthep Huka", locked a random audience member out in the cold! # Caesar conquers Navy Pier

The Chicago Shakespeare Theatre at Navy Pier, is quite well renowned for its inventive, stirring, and beautiful productions of the Bard's work, and with *Julius Caesar*, their current production, they did not drop the ball. Roman tales of power, ambition, and tragedy translate well into modern settings of political strife and internal backbiting. With updated settings and scenery, from *Citizen Kane* style larger than life posters of Caesar to modern paramilitary battle gear, the production brought archaic values and ideals into the modern era nearly as effectively as Shakespeare brought those same values to life in Elizabethan England.

The acting, with a few minor exceptions, was superb. Caesar was brutal, ambitious and self-aggrandized, yet still somehow contained qualities that evoked pity and care. Brutus, the torn and tragic pseudo-protagonist, was played beautifully. It became quite obvious that Brutus truly did love Caesar like a brother, yet also realized the problems sure to arise if Caesar were to be crowned Emperor.

Some productions I have seen left the audience believing that all of the conspirators, including Brutus, were simply protecting their own political interests, vying to survive the strife of populist political upheaval. This production, however, brought out the plurality of reasons and motives for Caesar's assassination. Brutus acted for love of Rome, Cassius on his jealousy of Caesar's power and popularity, and others on a willingness to follow whomever holds, or rather who is going to, hold power.

What was most striking about the production was the

series of prime-time plays at 8pm on Thursdays, Fridays and Saturdays, typically. These require 24-hour advance reservations, and are \$12, but students get a big fat discount of \$4, and every opening night of each 6-week production is "pay-what-you-can"! The currently running full-length play is called *A Duchampian Romp, even*, a play that "tackles the fascinating, mischievous, mystifying world of Marcel Duchamp." Next, From March 20 to April 26, is the play *The Emmett Project*, based on the story of Emmett Till, a 14-year-old Mississippi boy murdered in Chicago in the summer of 1954. And from May 22 - June 28, they are doing *Game/Place/*

use of the space to create feelings of immensity at some points, to feelings of claustrophobic entrapment at other times. The stunning luminary effects with visual projections and sparse lighting and ambient, discordant sound running through the second half drove home the madness and chaos of the characters and the action of the play. At times, audience members would jump in their seats, or would shrink back to protect themselves from the violence and intense emotional displays on stage.

One of the most difficult scenes in the show, but also the image that stands out as most fully dramatically realized, was Caesar's murder. The light ringing the conspirators as they surrounded Caesar removed the scene from feeling public domain; turned it into a voyeuristic leap into private affairs of the powerful, and thus also highlighted the intentions of the act as individually politically motivated. Then, their faces as they stabbed Caesar, and Cassius standing behind it all laughing maniacally, drove home how brutal and terrible power ability to corrupt and defile is.

Then, just before a Mark Anthony, as the conspirators dipped their hands into Caesar's blood, the audience is posed an almost direct question; How many times will these bloody deeds be played out again in the future in many different places?

It was a question that resonated out beyond the walls of the theatre, how bloody are the deeds of politicians today who claim to be acting in the general interest? Shakespeare's words are as true now as they were in the 17<sup>th</sup> century, and the Chicago Shakespeare's production prove it.

*Show*, an interactive game show extravaganza where the audience members get to play the parts of themselves, contestants, or even host the show! All shows are written, directed, devised, curated and/or performed by Neo-Futurist ensemble members. They also have 2 books published, **100 Plays from TMLMTBGB**, and **Neo-Solo: 131 Neo-Futurist Solo Plays**, available at the theater and by mail at The Neo-Futurists, 5153 N. 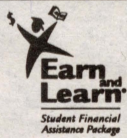

# The Emperor needs some new emotions

Julie Otsuka's premiere novel *When the Emperor was Divine*, delivers the experiences of a Japanese-American family during World War II. With the father imprisoned on charges of espionage and the family sent to a concentration camp, the characters express a range of emotions and reactions. The children, ages eight and twelve at the onset of the war, experience challenges of adolescence, such as burgeoning sexuality and existential issues authenticity and self.

On top of these common struggles, the children also encounter issues of existing in a culture of paranoia that creates racism and hatred, forced isolation and a disruption of their social lives.

The mother's stoic external treatment of her families situation juxtaposed with the obvious internal turmoil and breakdown speaks volumes on the effects of internal colonialism on the colonized, specifically on the Japanese-American experience. Then, the fathers appearance in the last section screams the reality of the effect of isolation, propaganda, and separation on the psyche.

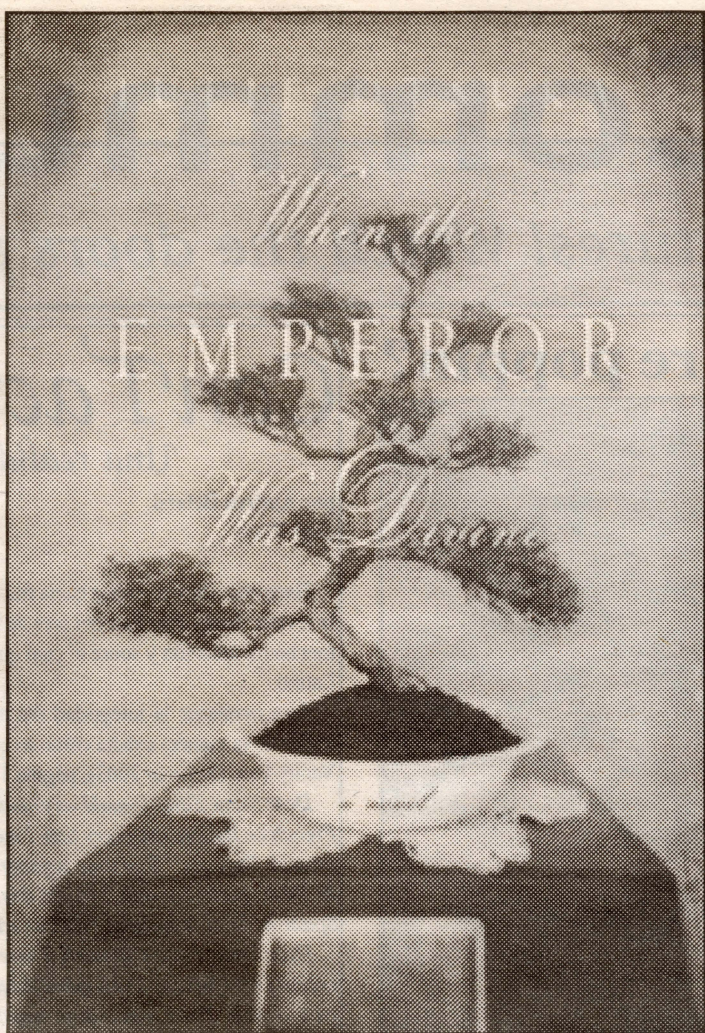
The issues raised by the novel are not just pertinent to its specific context, as it casts portentous shadows onto America's Cold War mentality for anyone who did not fit the profile of patriotism. The concept resounds even in today's society where people who fit the description of looking like terrorists are forced to deal with public and private scrutiny and prejudice.


The novel's strength relies heavily on its subject matter. Personalizing the plight of millions of Americans with characters who express emotion and desire is an important step in dealing with the past. No longer are the "concentrated" people just numbers and facts in a history book or a Defense document. Human struggles emerge; created and complicated by the removal, but still the same struggles that men, women, children of all ethnic backgrounds, in all walks of life deal with.

Otsuka's spare economy of language, however, leaves the novel simple and unfulfilling at times, however. Some of the "universal" problems the children deal with border on being hackneyed and trite. Some explosions of fierce emotional and metaphoric significance arise, but they are far and few between.

The loss of the family pet is rendered brutally, but somehow serenely, an intense early entry into the families' realities, but the family never quite comes alive. Their problems never quite become the reader's problem, as they are too detached and removed, to lacking in the full range of human emotion that one would expect from someone in that situation.

Ultimately, the novel takes its readers to a world full of fear and isolation, but never quite delivers them into any kind realization about it. Otsuka renders the numbers and facts of history with delicate humanity, but sometimes with a sparseness bordering on uncertainty.



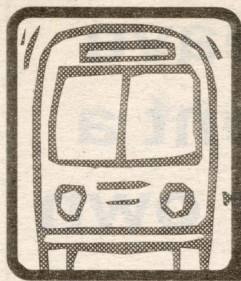

## Is it really Ecstasy that you're poppin'?

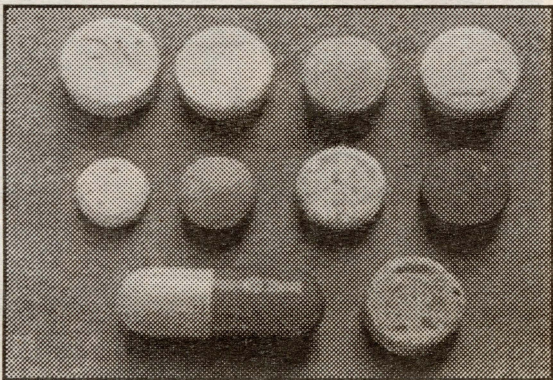
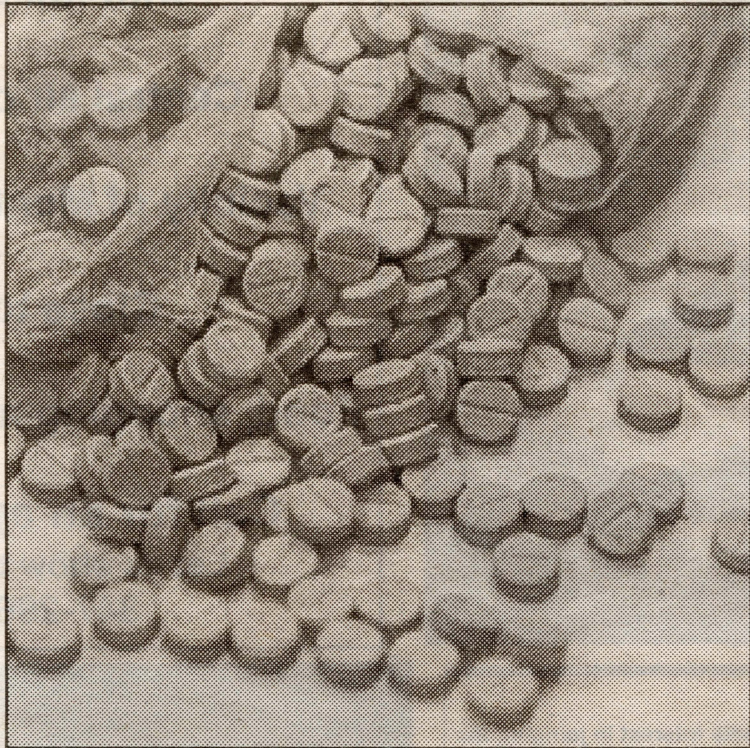
Methylenedioxy-methamphetamine (MDMA) is better known as Ecstasy. Some of its other street names include Adam, E, X, XTC, Rolls, Hug Drug, Disco Biscuits, White Doves, New Yorkers, Love Drug, Clarity, Lover's Speed, and Widgits. Why do people take MDMA? MDMA is supposed to have stimulant and hallucinogenic properties. Ecstasy users report increased sensitivity and high energy levels, and that MDMA gives people a euphoric feeling.

It is a popular drug at clubs and raves because it tends to break down people's inhibitions so they feel free to dance with more intensity for longer periods of time, while at the same time have the energy and neurological control of their body to do this. The heightened sensitivity is also said to increase the pleasures of sex. In fact, many people take it in combination with Viagra and refer to it as "hammer heading" or "sextasy." To quote one person, "It's f—ing awesome."

Depending on if you get the ones cut with coke or heroine, because they are all cut with something, you either are majorly wired or totally content."

So, now that you know the reasons to take ecstasy, the question is, why not? First of all, you have to make sure what you are getting is really MDMA. Since MDMA tends to come in pill form, it is nearly impossible to tell what it may be laced with. There's been rumors of it being laced with everything from cocaine and angel dust (PCP) to strychnine, a deadly rat poison.

The taking of ecstasy in combination with other drugs is becoming as increasing popular as titling the combos with seemingly innocuous names. One popular combination, which is referred to as "candy flipping on a string," is the use of ecstasy in combination with LSD (acid) and cocaine. Another interesting combination is called "flower flipping," where one takes ecstasy while ingesting



psychotropic mushrooms. Still other combinations include "chocolate chip cookies" which is MDMA combined with heroine or methadone (a synthetic opiate with many of the same effects as heroine).

The combination of ecstasy and PCP is referred to as "elephant flipping," because it hits you like an elephant. Another common practice is "speedballing," or taking a depressant (downer) and a stimulant (upper) simultaneously. This term originally was used when taking cocaine in conjunction with heroine, but in the MDMA crowd, it has been adapted to the concurrent use of ecstasy and ketamine (special K), which is used as an animal tranquilizer.

Ecstasy has become the drug of choice amongst many suburban teens. Among other reasons, this is due to its relative low cost in comparison to marijuana and the belief that is milder than many of the other hallucinogens such as LSD or PCP. It tends to make its

way into many house parties and basement raves. In fact, a nickname has developed for the young MDMA users: candy ravers. Many times they come dressed in candy jewelry and sucking on pacifiers. The pacifiers serve a second purpose; ecstasy use can cause one to clench their teeth uncontrollably. The pacifier prevents permanent tooth damage. With all the variations and availability, Ecstasy is billed as a designer drug. MDMA was designed with similar chemical structure as amphetamines (speed), a stimulant, and mescaline (peyote), a hallucinogenic.

So, assuming somehow you can guarantee that you are getting unadulterated MDMA, why else shouldn't you take it? Let's start with the fact that you may end up dancing until you pass out, and once you pass out you never know what is going to happen!

That's if you are lucky. If you are unlucky, your body loses the ability to control its temperature and you can get serious heat stroke and dehydration. You can suffer kidney failure, liver damage, blurred vision, tremors, high blood pressure, anxiety, paranoia, and use of MDMA destroys brain cells.

If you are looking to fit in, to break out of your shell, to become an outgoing person, you have to ask yourself if it is really worth risking permanent damage to many of your bodily functions for a good time.

# Fitness Matters

Recently there has been a lot of controversy over High Fat versus High Carbohydrate diets. It's critical to recognize this is not just an issue for people trying to lose weight. Whether you are trying to lose, gain, or maintain weight, what you eat affects your health.

In July 2002, the NY Times Magazine cover story by Gary Taubes reported that scientists were finally agreeing with the Atkins high-fat, no-carbohydrate diet approach, first published in 1972. This touched off a heated media debate on the "fat vs. carb" issue. One key response, published in November in the CSPI Nutrition Action Health Letter, criticized Taubes reporting and noted many of the experts from the Times article felt they had been misquoted or misinterpreted.

To decipher the truth you have to go to the detail. Some fats are actually good for you and essential for health, while some should be eaten sparingly, and others not at all. Likewise, while carbohydrates comprise the largest portion of a diet recommended by most nutritionists, all carbs are not created equal. Finally, it's important to understand not only which foods should be avoided, but also those that should be eaten to improve health.

Fats are classified as saturated and unsaturated. Saturated fats are found in meat products and consumption is still recommended only sparingly by most sources. "Trans" fats present in hydrogenated and partially-hydrogenated vegetable oils, most margarines, and many packaged baked goods, are the worst health risk and should be avoided. Some unsaturated fats, common in vegetable oils, are now being recommended to improve health.

The chart from the internet WebMD identifies healthy fats:

FOOD SOURCE	FAT TYPE - BENEFITS	USES
Olive Oil	Omega-6 Fatty Acids & 30-40 antioxidants.	Helps protect the heart & reduce cancer risk. Use in place of butter or margarine, drizzle on bread, excellent for cooking.
Canola Oil	Omega-3 fatty acids. Helps reduce blood pressure & LDL cholesterol.	Use in place of other vegetable oils for cooking and in salad dressings.
Fish - Salmon, Tuna, Striped Bass, Mackerel, Herring, Sardines	Omega-Fatty Acids.	See above. Try slow-baked at 200 degrees for 20-30 minutes to retain moisture.
Nuts - Almonds, Walnuts, Pecans, Peanuts	Monounsaturated.	Helps lower LDL cholesterol & reduce the risk of heart disease risk when eaten in place of other fatty foods. Use only nut butters without hydrogenated vegetable oils or eat raw as a snack.

It's also helpful to think of carbohydrates in groups: refined, vegetables and fruits, and whole grains. Refined include sweets, white bread, and sugared sodas and should be eaten sparingly as they have little nutritive value. Vegetables and fruits are high in vitamins and minerals and most have a low glycemic index, which means you stay full longer after eating them. In addition, many vegetables contain "phytochemicals" a new class of nutrient getting a lot of attention these days. They are thought to act as antioxidants and may reduce the risk of cancer and heart disease. Whole grains also have a low glycemic index and are high in fiber, which has been shown to reduce the risk of colon cancer. Carbohydrates in the form of vegetables, fruits, and whole grains should make up the largest portion of your diet. Contrary to popular opinion, carbs such as rice, pasta and potatoes fall somewhere in between, have a moderate glycemic index, and should be eaten in moderation.

So what's a glycemic index (GI)? Carbohydrates are ranked by the food's ability to contribute to glucose (sugar in its simplest form in the body) in the blood stream. The faster the carbs are converted to blood sugar, the higher the glycemic index number. The GI numbers rank from 1 to 100 with an example being grapefruit at a GI of 25 to a baked potato at a GI of 85. This means that a grapefruit will enter the blood stream slowly thus give sustained energy, while a baked potato will enter the blood stream more rapidly to give immediate energy.

Final answer: A diet including NO fats or NO carbs is NO good. The key to a healthy diet is moderation and remembering, it's not always what you exclude from your diet, but what you intentionally include in your diet that can increase your odds of living a long, healthy life.

# Alcohol has its good side

## Benefits outweigh risks when you drink moderately

As I sat at the computer while having another beer, I began to wonder why my editor gave me another assignment dealing with alcohol consumption, and the benefits thereof. I could tell you the benefits that alcohol has had for my life, but that is more on a social level, whereas the editor is concerned about the health aspects, so that is where I shall begin.

My grandmother always said, "All things in moderation," and I believe that. Any food, any drink, or any activity can become harmful and even life threatening when abused. And when the benefits of alcohol consumption are discussed, one must carefully weigh the physical and psychological risks involved and not just begin drinking because you found out that it was good for you. Just as the tobacco companies deny harmful effects while touting minor benefits, so too the liquor producers had their say. But in their case, these benefits are supported by actual independent medical reports and studies.

In December of 1999, a report published in the British Medical Journal by researchers at the Harvard School of Public Health stated that "two drinks a day will reduce the risk of heart attack in individuals by at

least twenty-five percent. The authors found equal benefit for beer, wine, and spirits."

The report continued to say, "By examining over 75 previous clinical studies in which alcohol was provided in experimental doses, the researchers have pinpointed two mechanisms by which alcohol reduces risk of coronary heart disease (CHD). Ethanol alcohol increased HDL-cholesterol ("good cholesterol") and reduces clotting ability in the blood." The study I refer to is "Moderate Alcohol Intake and Lower Risk of Coronary Heart Disease: Meta-Analysis of Effects on Lipids and Hemostatic Factors," and can be found online at [www.bmj.com](http://www.bmj.com); it summarizes 25 years of experimental alcohol research.

It is not difficult to see that when we talk about the average individual having one or two glasses of wine or beer at dinnertime, that it is not going to turn one into a roaring drunk, and everyone knows that wine aids in the digestion of food. Even Paul the Apostle encouraged one of his men to "have a little wine for thy stomach's sake."

Psychologically, alcohol acts as a relaxant, lowers the libido, and makes us feel more at ease. We consider it to be an acceptable "ice breaker" at social gatherings. One can sound more knowledgeable and appear more impressive holding a martini or scotch on the rocks in his hand. And if it's kept at that level no more than two or three drinks a day, we will feel the benefits with little risk. But if there is abuse, we wind up more like the gang at Moe's bar on *The Simpsons*, and any

benefit alcohol might have is lost to the increased risks and impairment it produces when abused.

Reuters reported that a Danish study, published by the American Heart Association in the journal *Stroke*, found that persons who drink moderate amounts of wine (one to six glasses a week) had a thirty-four percent lower risk of stroke compared to those who never or hardly drank wine. A sixteen-year study of more than 13,000 people, conducted by Dr. Thomas Truelson at the Institute of Preventive Medicine, concluded: "Wine, especially red wine, contains plant compounds that may be healthy and beneficial, including tannins, flavonoids, and polyphenols. Some studies indicate that these substances can act as antioxidants, which can help stop fat from sticking to artery walls."

We are all aware of the risks of excessive alcohol consumption, and there is no need to expound on the physical problems such as cirrhosis of the liver, cancer, and high blood pressure. Not to mention the immediate after-effects of binge drinking, such as finding yourself suddenly in the after-life, or with a steering wheel wrapped around your head in an emergency room, or waking up with a strange person in bed with you. And, as humorously put by a statement in *Harvard Medical Journal*: "A drink a day may keep the cardiologist away, but several drinks a day and the oncologist may be your constant companion!"

I must stress that this is not a recommendation that you start drinking. Rather, it is a caution that if you do drink, please drink in moderation; it may prove a health benefit for you. Now, if you will excuse me, I have to run out and buy some more beer.

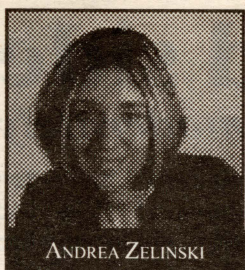

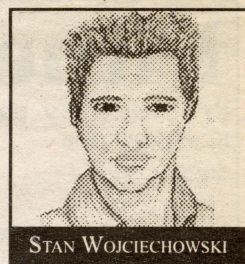

## Relationship truths: Men vs. Women

As I began this project and passed out the survey to my classmates, I was pretty confident that most men would say *yes* and most women would say *no*. However, the further I got in to it, the more I realized how each individual has a very different experience, and the results of the survey were not in accordance with my initial beliefs.

The stats for the men are as follows: fifteen said *yes*, eleven said *no*, and two said it depends on the circumstances. ## Are vegans getting enough?

Lately there has been a bit of an uproar about vegan (people that eat no animal products) mothers that breastfeed not passing enough Vitamin B-12 on to their children. There is good reason for this concern. Vegans, unlike lacto-ovo-vegetarians (people that eat milk and eggs), tend to be deficient in protein and B-12. Now if balanced correctly, a vegan diet can be very healthy.

If a breastfeeding vegan mother does not get enough B-12 herself, odds are her child will be deficient in it as well. The problem with B-12 deficiency is that it is hard to detect at a young age. Since the body's B-12 requirement is small and the body both stores and recycles it, a deficiency may not be noticed for many years. A baby can suffer permanent stunts in their developmental process from a lack of B-12, specifically in fine motor and communicative skills.

Many vegans eat vegetables such as spirulina, sea vegetables, tempeh, and miso for their B-12 intake. The problem is the B-12 in these vegetables tends to be inactive. The American Dietetic Association suggests supplementation or fortified foods to make up for this.

A second of the problems with a vegan diet is iron intake. Most plants only contain only nonheme iron. This type of iron is more sensitive to both inhibitors and enhancers of iron absorption. The body absorbs it very poorly due to this.

However, while there is anemia found commonly in both vegans and omnivores, some propose that

vegan's higher vitamin C intake may help them with iron absorption. Regardless, it's still recommended to be safer for vegans to take supplements to make sure their bodies receive the proper amount of iron that it requires to survive and function in healthy working order.

Another concern is that many vegans are not vegans for the purpose of health, religion, or moral issues. Some take on a strictly vegan diet to mask anorexia, a very serious eating disorder. Anorexia can kill you. One cannot live on a stalk of celery a day. Furthermore, if you are breastfeeding as an anorexic, you are denying your child essential nutrients he or she needs to grow. Breastfeeding also compounds problems for the mother, as she tends to lose about 500 calories a day through breast milk.

Despite these possible complications, there are many benefits to being a vegan. It lowers your chance for many circulatory diseases. In addition, a diet high in vegetables contains many antioxidants such as vitamin C and E that are believed to help prevent cancer. Incidence of hypertension seems to be decreased in vegans when compared to omnivores.

There is a right way and a wrong way to subscribe to veganism. There are many nutrients available in plants that people believe are only in animal products. A diet rich in legumes and grains is very important to maintain a proper intake of proteins and amino acids. Other nutrients that vegans need to take special care to receive enough are zinc, vitamin D, and of course, B-12. When thinking of a diet change, please take into account how it could affect your children.

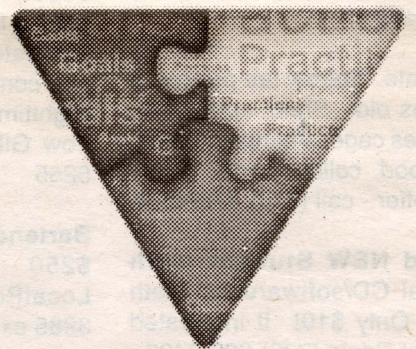
