1. General Information

a. Name: The name of this committee is the Jacksonville State University Institutional Review Board (IRB).

b. Purpose and Scope: The IRB is a committee that reviews all JSU research involving human participants and is responsible to the President. The purpose of the IRB is to assure that research is conducted in an ethical manner, specifically in accordance with the Department of Health and Human Services regulations 45 (46 Protection of Human Subjects and 45 CFR and 46 Subpart A.) This includes ensuring that risks to participants are minimized, the selection of participants is equitable, and participants are informed fully of what their participation will entail.

The policy on the use of human subjects in research applies to any activity deemed to be research at JSU. The applicability of this policy is to all entities of the university: faculty, administration, staff, students, and contracted consultants. This policy applies to any research activity using human subjects that is directly or indirectly supported by the university.
