## Comments to the author

Reviewer 1: This article describes an agricultural practice in Indonesia and evaluates its advantages and disadvantages relying exclusively on interviews with the two kinds of parties involved in the practice: owners of capital in the form of land or livestock, and farmers or workers who provide labor in exchange for a portion of the valuables they cultivate. The research seems to belong generally within the field of development studies, but this is never clarified as the article makes very few references to any broader discipline of study and relies mostly on accounts of Islam and agriculture in Indonesia. Without clearly identifying a field of intervention, the intervention itself is inevitably weak. In the end the reader is left with the simple conclusion that there are advantages and disadvantages to the practice of tesang, and it would be good if the disadvantages were fewer.

The topic is nonetheless important, and if the authors would like to develop the article, I would suggest two routes.

First, what are the debates within the field of development studies to which this article may speak? This is in fact not my field of study and so I cannot comment, but I learned nothing about the field from the article. The absence of comparative study was most apparent in Section 4 which introduce “three models of empowerment” without telling the reader where these models come from. Are they the researchers’ own conclusions? Are they derived from academic literature? Are they discussed and debate by local policy makers or aid workers? As presented, these models simply fall from the sky and this leaves the argument insufficiently contextualized.

Second, what is the history of the practice of tesang? At present the article quite explicitly assumes that the practice has been constant across generations, or even centuries. By doing so, it ignores the history of development and underdevelopment of Indonesia agriculture in the colonial and postcolonial eras. This is also not my field but again I learned nothing about it from the paper. Based on my reading, here are two suggestions of how the material described in the paper (the evidence of interviews about tesang) could be more carefully historicized:

1. The article borrows the interlocutors’ language of a simple opposition between written contracts and trust. There is one hint on p. 10 that tesange had been “regulated in oral rules” but this is very important and must be carefully considered in the argument. As documented by scholars like Brinkley Messick, other Islamic legal systems have considered oral contracts as binding, and in some places even written contracts were not sufficient evidence in a judicial dispute without oral testimony confirming the contract’s veracity. Surely in Sulawesi there is a history of how contract disputes were resolved, and that history was likely quite tumultuous across the 19th and 20th centuries. Including some of that history will illuminate the new challenges that these farmers face in an economy that is now probably attached to a global capitalist market in important ways.
2. The article uncritically adopts the capital holders’ complaint about farmers’ laziness. In doing so, it adopts a neoliberal analytical framework that deflects attention from structural economic inequality to a moralizing discourse about the laziness of the poor. In short, the analysis that poor lazy people prohibit economic development is not merely uninteresting academically but politically quite destructive. There are many studies that provide critical perspective on neoliberal development policies, but one often cited study is James Ferguson’s book “give a man a fish.”

Finally, I would add two points about the use of evidence and writing in the article: the article’s use of extended quotations from farmers is not efficiently or effectively used. The translation of their claims to English does not seem to be particularly difficult or problematic as the points they make are quite simple. As such, the inclusion of the original language does little to facilitate a more careful analysis or comparative study. Even the use of a quotation at all seems unnecessary to me because a paraphrase of their words would deliver the same point to the reader. In addition, the concluding discussion section is repetitive as the same hadith is quote twice, and the same points about the advantages and disadvantages of the practice of tesang are repeated without new perspective.
