is no growth, integrity, freedom, and most importantly, no patriotism." National unity is an essential component of any country's stability and development, and Nigeria is no exception.

Promoting national unity, on the other hand, is not a privilege reserved for a few experts in the country; it is a responsibility shared by everybody. This means that everyone has a role to play in promoting national unity. As a result, no one is excluded from promoting national unity because it is a shared responsibility that benefits all. Furthermore, promoting national unity has been a recurring theme in Nigerian society due to its diverse ethnic groups and cultural values. The importance of promoting national unity cannot be overstated since it not only ensures peaceful coexistence among Nigerians but also fosters social cohesion, economic growth, and political stability in the country.

Library and information professionals play vital roles in promoting national unity by leveraging their expertise to create connections between Nigerians from different backgrounds. LIS professionals are among many professionals whose profession plays a significant role in the promotion of national unity simply because of their direct involvement with information, which has been identified as one of the many resources that aids in the promotion of national unity (Ambali, 2019). They are responsible for collecting, managing, processing, preserving, disseminating information resources that promote social inclusion while fostering a shared sense of identity that distinguishes Nigeria as one nation with diverse cultures. Leveraging digital technologies and social media platforms is critical to achieving this goal. Library professionals can use various tools at their disposal such as online archives or virtual libraries to connect Nigerians with local/national resources that promote social cohesion while simultaneously educating citizens on the importance of diversity tolerance. In this essay, we will explore how library professionals' innovative approaches can help foster national identity by connecting citizens through technologybased solutions tailored towards uniting Nigerians around shared goals for the future. Therefore, the main objective of this study is to discuss the roles of Information, Library and LIS professionals in promoting national unity.

#### **Concept of National Unity**

Caplan (2019) describes National unity as a political construct that reflects the collective spirit and will of a group of people who agree to be part of the particular geographical area as a unit, for the purpose of governance and action on behalf of all.

According to Zamare and Karofi (2015), they described National unity as a process that produce an omnibus of initiatives put in place by a state, its representative or institution guided by respect for the unique traditions and cultural background of ethnicities sharing the same polity with the goal of harmonizing all interest through a form of dialogue and representation and addressing differences that may be divisive and conflictual using the instrument of fairness, justice and equity in the sharing of resources, benefits, opportunities and responsibilities in order to guaranteed stability, longevity and prosperity of the polity as long as the inhabitants decide to remain in the polity. This definition is a wholesome piece of manual which present a clear picture of who, why, how and what is involved in national unity. Also, Echem, Pokubo, and Ejuh (2018) expressed the view that National unity is crucial to the development of any meaningful nation. For any meaningful society to advance and flourish it must embrace national unity. The idea behind national unity is simply uniformity, oneness not minding differences as a people. In other words, it's unity in diversity (Alabi, Zabairu and Onuoha, 2019).

Ambali (2019) further stated that National unity is the bricks and caprice of any meaningful development a nation could record because it revolves around a society with unity of purpose and togetherness not minding the difference in term of political affiliation, religion, tribe, culture and every other peculiarity that alienated us from one another.

## **Promoting National Unity**

Creating this environment of mutual respect starts with education on cultural awareness in schools or workplaces where all members of society are given equal opportunities regardless of their background. ## **Information and National Unity**

Information by definition is said to be a processed and structured data that causes a human mind to change e its opinion about the current state of the real world and contribute to a reduction in the uncertainty of the state of the system (Ifidon and Ahiauzu, 2005). Going by this definition, information can be seen to influence, solve problem, make choice and decision, judge and so on. Even among the fundamental human right, access to information was given preference as a right of the citizen. This is because Information in the view of Anasi (2010) helps in creating enlightened and responsible citizens which will in turn have a positive effect in the society. Therefore, a society cannot develop beyond the literacy level of her citizen's.

However, citizen literacy is a direct function of accessing the right and adequate information. This is why Sokari (2006) consented that that information is necessary for liberation from the shackles of ignorance, misconceptions and social unrest arguing that social cohesion cannot be achieved without timely, accurate, and relevant information. Therefore, Satgoor (2012) noted that the importance of information on national unity is hinged on the fact that information is needed to understand the impact of the past on the present; redressing iniquities of the past; creating an acknowledgment and appreciation of existing diversity, fostering communication across cultures and safeguarding human rights so as to have a nation bound in freedom, peace and unity.

Moreover, in today's world, digital technologies and social media have become powerful tools that can be used to connect people from all walks of life. In Nigeria, these tools have the potential to promote social cohesion and national unity by providing access to information that is right and

adequate. As Ambali (2019) points out, "National integration for national development is not realizable without the provision of access to right and adequate information." Leveraging digital technologies and social media can help provide this needed information in a way that connects Nigerians with local and national resources. The use of technology has already had an impact on how politics are viewed in Nigeria as well as how voters engage with their leaders. By using these platforms effectively, citizens also gain a voice which increases accountability within government bodies while promoting transparency regarding policy decisions. However, it must be noted that meaningful change cannot occur through technology alone; efforts must also be made at the local level through community engagement initiatives such as town halls or other forms of public dialogue where ideas are shared freely between stakeholders across diverse backgrounds towards achieving common goals for nation-building purposes.

## **Library and National Unity**

Additionally, they provide an opportunity for individuals who may not have had access to certain materials or technology otherwise to expand their knowledge base. Thus, libraries are essential building blocks towards creating a more united Nigerian society with shared values and beliefs centered around progress through learning together as one cohesive unit.

Furthermore, information can be said to be important in achieving national unity, then libraries should not be an exception because the major objective of any library is provision of information.

This is seen in IFLA (2003) which describes libraries as key actors in providing unhindered access to essential information resources for economic and cultural advancement thereby contributing to the development and maintenance of intellectual freedom, democratic values, peace, and universal civil right. Also, the creation of the library was made with the intention of preserving all manners of information resources then seen as record for the use of man, in the benefit of man. This is why White (2012) opined that a world without libraries, would be difficult in terms of advancing research and human knowledge or preserving the world's cumulative knowledge and heritage for future generations.

Achieving national unity can be said to be a subtle objective for libraries because among all other educational institution, libraries are said to make a huge difference in combating illiteracy and erasing ignorance (Ugulu and Oghuvwu, 2015). However, library today is now what can be said to reduce digital divide, with the aid of ICT. Thereby making access to information no longer an exclusive right of the elites, as libraries now offers free internet accessibility which widening the nation's access to information. This is why citizens who would have been caught off from accessing information on the internet can do so in the libraries and as such, people now have access to information from diverse cultures both globally and locally which leads to more exposure and promotion of nation unity (Alabi et al., 2019).

However, libraries promote National unity through the following ways:

- 1. The library helps to serve as an authorized source of information for citizens of a nation;
- 2. The library, with the help of ICT, plays a major role in the digital divide by allowing people to communicate and share ideas on how to better the nation;
- 3. The library lends its voice to advocate national building through its way of embracing unity in diversity. This is communicated through the library's resources, users, formats, and location;
- 4. The library is a central location for integrating a nation's past, present, and future;
- 5. The library serves as a massive memory and data bank for the nation's knowledge.

6. Furthermore, as previously said, all library goals are related to national unity. As a result, it is the responsibility of library and information professionals to assist libraries in achieving this goal of national unity.

## **Roles of LIS Professionals in Promoting Nation Unity**

LIS professionals are experts who work in libraries and other information centers to acquire, process, organize, and preserve information resources, as well as to provide a variety of information services based on industry standards and their own experience. The roles of LIS professionals are very important in the promoting of national unity because LIS professionals have the essential abilities to obtain relevant information resources for the library and thus serve as a bridge between the information resources and the users (citizens), their stake in establishing national unity is as significant as the information provided (Kumar, 2018). This means that if LIS professionals fail to fulfill their responsibilities, the nation may suffer. As a result, Dr. Tedros Adhanon, Director General of the World Health Organization (W.H.O.), remarked of the threat of bogus and insufficient information, "we are not just fighting an epidemic, we are fighting an infodemic." This is due to the fact that false and incomplete information spreads more quickly and easily than the virus, yet it is just as damaging." In this remark, insufficient information is given greater weight than a virus in terms of consequences. This means that those in charge of information, such as librarians, must not slack off or the nation would suffer. This, on the other hand, emphasizes the importance of librarians in the fostering of national unity.

Furthermore, Information professionals play a vital role in creating inclusive and accessible library spaces that foster cross-cultural understanding and respect. By incorporating diverse perspectives into their collection development practices, information professionals can help to ensure that patrons from all backgrounds feel represented within the library's resources. Furthermore, by providing access to materials written in multiple languages, librarians can make sure that individuals with limited English proficiency are not excluded from using the library's services. As Kari and Yusuf (2019) note, "Libraries have functioned as instrument of political and social change and as a guardian of intellectual freedom." This means that libraries have historically been at the forefront of promoting equity through knowledge dissemination. Information professionals who prioritize inclusivity must also consider factors such as physical accessibility for patrons with disabilities or sensory impairments. When librarians work to create welcoming environments for

all members of their community, they contribute to efforts towards greater cross-cultural understanding and respect within society at large.

In order to foster national unity, LIS professionals have been recommended to take on 10 roles that could potentially contribute towards this goal. While these roles have not yet been supported by empirical evidence, they have been derived through logical and rational thinking, which has been informed through personal and collective observations as professionals in the field. These suggested roles are aimed at promoting a sense of cohesion amongst individuals from different backgrounds and communities within the nation. They serve as pointers for how LIS professionals can utilize their skills and knowledge to help bridge gaps and create a more harmonious society. Additionally, these suggested roles emphasize the importance of social responsibility among those working in the LIS industry. By taking an active role in promoting national unity, these professionals can demonstrate how libraries and information centers contribute not only to individual growth and learning but also towards the betterment of society as a whole.

- 1. It is expected that individuals who work in Library and Information Science (LIS) should maintain a high level of ethical standards. This is crucial because it ensures that the profession remains reputable and an integral part of national unity. Upholding ethical standards means acting with integrity, honesty, and transparency in all aspects of work. Maintaining these standards builds public trust, reinforces professional credibility, and helps to sustain a positive image for the profession as a whole. Ethical behavior is essential not only for individual LIS professionals but also for the overall success of their organizations and the society at large. Therefore, it is vital that LIS professionals recognize the importance of ethics in their daily operations and always strive to follow best practices while adhering to their code of conduct.
- 2. It is highly recommended that professionals working in the field of Library and Information Science (LIS) promote information literacy. The reason for this is that information literacy encompasses a wide range of skills and knowledge, which are essential for individuals to function competently in today's increasingly complex world. Essentially, information literacy refers to the ability to identify when one needs certain information, as well as the ability to locate, evaluate, and utilize that information effectively. By promoting information literacy among citizens of a nation, LIS professionals can contribute significantly towards national unity. This is because individuals who possess strong information literacy skills are less likely

to fall prey to incomplete or misleading data. Instead, they will be able to make informed decisions based on accurate and relevant sources of information. Furthermore, possessing effective research and analytical skills will equip individuals with an advantage over others who may not have similar abilities. This skillset enables them to examine different viewpoints, connect ideas across various domains while critically analyzing them. Such individuals are better suited for positions requiring leadership roles where they can integrate their critical thinking abilities into decision-making processes. Overall then, it is evident that promoting information literacy should be considered a crucial objective by LIS professionals given its positive impact on national unity and societal empowerment by increasing people's knowledge base.

- 3. Professionals in the field of Library and Information Science should take a proactive approach to promote national unity by organizing events such as seminars, conferences, and lectures. These events should focus on areas where there is a lack of understanding among the general public that leads to division and discord. It is crucial for LIS professionals to examine these issues objectively and try to find commonalities among different communities. These seminars, conferences, and lectures will serve as an excellent opportunity for people from diverse backgrounds to come together and share their experiences, beliefs, traditions, and values. This will enable them to gain a better understanding of each other's perspectives, which will lead to greater empathy and tolerance within society. Moreover, these events also provide a platform for individuals who have previously been excluded from mainstream society due to their ethnicity or religion. Currently, the lack of representation has resulted in little recognition of the role played by LIS professionals towards promoting national unity. By gaining power through strategic appointments, this profession can assert its importance on a larger scale and receive appropriate recognition.
- 7. Librarians, information specialists, and other professionals in the field of Library and Information Science (LIS) are renowned for their selfless dedication to their work. They place an emphasis on serving others and ensuring that they are fully satisfied with the services they receive. Given this philosophy, it is imperative that we prioritize archiving national unity through the provision of information services. By doing so, we can ensure that all members of society have access to accurate and comprehensive information that promotes a sense of national unity. This approach aligns perfectly with LIS professionals' overall mission to serve communities by providing them with access to knowledge that enables them to make informed

- decisions about their lives and surroundings. Thus, fostering national unity through information service delivery should be at the forefront of our collective efforts as LIS professionals.
- 8. To create an environment that is welcoming to students of different cultural backgrounds, it is necessary to include diverse subjects such as Indigenous knowledge in the curriculum at library schools. Library professionals are responsible for shaping the learning experience of future generations, which makes it crucial for them to be well-versed in various cultures, races and values. It's important for students to learn about different perspectives of people from all walks of life and gain a deeper understanding of their experiences. By incorporating such subjects in the curriculum, library schools can promote a more inclusive and engaging learning environment that benefits all students. Therefore, educators must acknowledge the significance of diversity and take steps towards creating an educational system that fosters cross-cultural understanding and acceptance.
- 9. LIS professionals can reduce information gaps by repackaging content to make it more accessible to individuals from all backgrounds. Information can be repackaged in various forms like infographics, summaries, videos, or presentations to give an overview of key points on a certain topic. Annotated bibliographies can also be created by LIS professionals to highlight important research studies and reports. This will help users navigate through resources and gain insights into specific areas of interest. LIS professionals can use technology to make content more engaging for users. They may organize webinars with experts or promote relevant materials on social media. LIS professionals can bridge knowledge gap by simplifying information for those who need it.
- 10. Libraries face many competitors, some of which are unreliable and cause division among citizens. It is important for Library and Information Science professionals to provide access to authorized sources of information using ICT to promote national unity. They must recognize the importance of fostering national unity by ensuring people have access to reliable sources of information. LIS professionals must work towards ensuring society seeks verified sources when seeking answers or guidance on pressing issues, providing credible platforms for accessing data and empowering critical thinking skills. Equal access to trustworthy resources should be available regardless of social status or background by eliminating barriers

like cost or location hindering diverse groups from easily accessing library services. This builds a cohesive society promoting shared values anchored in authentic knowledge acquisition - a crucial step towards building a country founded upon mutual respect and understanding despite differences leading us towards a better future together.
