Editorial Dedication to Siobhan O'Sullivan (1974–2023)

This edition of the journal is dedicated to the memory of Siobhan O'Sullivan who died in the early hours of Saturday June 17, 2023. It was ovarian cancer which cut short the life of this indomitable advocate, activist, scholar and charismatic woman who deployed her abundance of energy, humour, intellect and compassion to bring awareness to the injustices wrought on other animals in this world.



The critical/animal studies network is close-knit in Australia and Siobhan played a leading role in finding ways to support the discipline as it developed. We first met in 2007 – a colleague and I were seeking funding for a national symposium on replacing animals in scientific and medical research, and I am certain Siobhan's presence on the funding committee had a great deal to do

with the decision to fund the event. Two years later I started working with Siobhan in a scholarly group formed to build and strengthen the then nascent field of animal studies – the Australian Animal Studies Group. It was the early days, our small group was diverse, productive and dynamic and our meetings were sometimes boisterous – Siobhan's voice and laugh rang out along the corridors! The group is now the Australasian Animal Studies Association (AASA) and the current chair, Dinesh Wadiwel, wrote after her death 'For those of us who knew Siobhan personally, she was experienced as something like an irrepressible force ... always the pulsing heart of any gathering she was part of'. In 2021 Siobhan funded two prizes, conceived as ongoing support for the field – the AASA Journal Article by an Early Career Researcher Prize and the AASA Popular Communication of Animal Studies Prize.

Siobhan is the author of *Animals, Equality, and Democracy* (2011) which, as Peter Singer writes: 'appeals to democratic values to argue that the way we treat many animals is unjustifiable, even when judged by the standards that citizens of most democracies already accept'. With Robert Garner she co-edited the important collection, *The Political Turn in Animal Ethics* (2016). However, Siobhan is perhaps most widely known to critical/animal studies scholars internationally through the podcast she founded in 2015, *Knowing Animals*, in which she interviews researchers and animal advocates about their work: https://www.knowinganimals.com/podcasts

The love shown for Siobhan at her funeral a few days ago and the many hilarious stories told there by her family, friends and colleagues honoured a woman whose work, commitment, innovation and trademark humour and laugh will be greatly missed by us all.

Rest in peace Siobhan.

Thomas Aiello is a professor of history and Africana studies at Valdosta State University. He is the author of more than twenty books and dozens of peer-reviewed journal articles. As a volunteer for the nonprofit Assateague Island Alliance, she created the first educational field guide for the wild pony herd in the Assateague Island National Seashore, situated along the Atlantic coast of Maryland, USA. She has previously published 'Bordering Processes and Pony Wildness on Assateague Island' in *Society & Animals*, co-authored with Christian Hunold. In addition to wild horses and burros, her research interests include 20th-century American urban and suburban development; she has also published about Drexel's anchor-mission-driven practices and strategies as an institutional leader in that work in spaces like Metropolitan Universities Journal and Planning for Higher Education. She is the Executive Director of Drexel University's Sustainable Development Strategy, and holds an M.S. in Science, Technology, and Society.

John Enman-Beech is a lecturer in the law of contract at King's College London. They have published on the ways contract structures people's relationships with social media platforms, gig economy apps, and other businesses. Their work is methodologically diverse, encompassing both doctrinal approaches and feminist, queer and critical legal and economic theory. **David Herman** is an independent researcher based in the US who works at the intersection of interdisciplinary narrative theory and human-animal studies. He is currently exploring ways to hybridise different kinds of discourse about animals – fictional, scientific, philosophical, and other – in a collection of posthumanist fables. His recent publications include 'Dogs: A Diaspora', in *Miracle Monocle* (2022), and 'Lin May Saeed and Post-Anthropocentric Art', in *Humanimalia* (forthcoming).

Kris Hill is completing her PhD in Anthrozoology with Exeter University. Her doctoral research focuses on cat-human relations in urban communities, and discourses surrounding roaming cats (Felis catus). His latest publication is a chapter in *The Oxford Handbook of Animal Organization Studies: A Critical Reader in Ethics, Business and Society*, edited by Lindsay Hamilton and Linda Tallberg, titled 'Social Media Images of Urban Coyotes and the Constitution of More-than-human Cities'. The present article is part of an ongoing collaboration with Jennifer Britton on the governance of free-roaming horses and burros in anthropogenic landscapes. **Sarah Oxley Heaney** is an Anthrozoology PhD student with the University of Exeter. Her project 'Kissing Sharks'<u>www.kissingsharks.com</u> examines unique, co-developed shark-human relationships. Other anthrozoologic interests focus upon abandoned cats in Saudi Arabia, where her research-activist work continues.
