PREFACE

This is essentially a working bibliography which originally arose out of research being undertaken by Dr. E.W. Anderson and Dr. G.H. Blake. The desirability of publishing a selection of references from the huge range of literature on the security of the Arabian-Persian Gulf had been brought home to us on several occasions, not least in connection with projects undertaken by candidates taking the M.A. course in the Geography of the Middle East and Mediterranean at Durham, with which we are associated.

Publication was made possible because of the availability of Dr. David Newman during a brief post-doctoral interlude. Without his skilful use of the computer and his own extensive additions to the collection, the bibliography would not have appeared. Unfortunately a few entries were still incomplete in minor details at the time of Dr. Newman's departure, and these have been asterisked in preference to their total omission. We hope that this will not spoil our work in the eyes of professional bibliographers. Our aim was to increase knowledge of this vitally important and topical subject, with the least possible delay.

There are some 750 references in this bibliography. We thought it would be helpful to sort them into a number of sections as follows:

1. General References.
2. Internal Politics.
3. Superpower Rivalry and Interests.
4. The Oilfields.
5. Sealanes and the Straits of Hormuz.
6. The Indian Ocean.
7. The Cape Route.

It should be noted however that many references could appear in more than one of these sections.
