





The Baltimore Ravens and the San Francisco 49ers clashed in the New Orleans Superdome, each team in hot pursuit of the Super Bowl XLVII Lombardi Trophy and a ring on their finger that would solidify their place in NFL history. This year, however, there was more at stake than winning the greatest championship in the world.

John and Jim Harbaugh, head coaches of the Ravens and 49ers respectively, are two of the most lauded head coaches in the league. Not only that, but they're also brothers. This is the first time that two brothers have been the head coaches of opposing Super Bowl teams, and they both bring strong cases to the

table as to which one had the edge in this game.

John Harbaugh has been the head coach of the Ravens for five years, during which time they have had multiple playoff appearances, including trips to the AFC Championship, but they have never made it to the Super Bowl. At the time of the decision, Smith had one of the best completion ratings in the league, and the team was winning. Kaepernick has been utilized in specialized situations for small portions of the season, particularly on hot-read option plays.

New Lounge Brings Asbestos Worries

Before winter break, Northeastern Illinois University (NEIU) began renovating the student lounge in the basement of the E building. Among other things, the carpeting was removed, and beneath the carpet tiles was a significant amount of asbestos.

Many people have heard of asbestos and its hazards, but they don't really know what it is, where it is found and when it becomes hazardous. According to the Health & Safety Executive of Great Britain (HSE), asbestos is a "naturally occurring fibrous material that has been a popular building material since the 1950s. It is used as an insulator (to keep in heat and keep out cold), has good fire protection properties and protects against corrosion."

As a common building material from the '50s, asbestos can be found everywhere: in ceiling tiles, internal and external wall paneling, pipe insulation, vinyl and thermoplastic floor tiles, water tanks (pre-1980), boilers and sprayed coatings.

According to Interim Director of Student Leadership Development Veronica Rodriguez and NEIU Safety Coordinator Rick Matus, all of the asbestos was removed during winter break.

Matus explained that with any renovation project on campus, asbestos is always removed according to the strict codes of the Asbestos Hazard Emergency Response Act (AHERA), which is typically applied to dealing with asbestos in elementary and secondary schools (K-12). However, Matus

and the NEIU Safety Program Department choose to be on the conservative side and enforce the strictest asbestos removal regulations possible.

Since most of the buildings on campus were built before the 1980s, their infrastructure does contain asbestos. To date, much has been removed, but there are still spaces that have not been touched.

However, Matus reassures the NEIU community that this is nothing to be concerned about because asbestos is "only hazardous if you can inhale it," and all of what remains on campus is contained within sealed and enclosed spaces. According to

the Environmental Health and Safety department of Princeton University, asbestos is only hazardous when it is friable, or "easily crumbled by hand, releasing fibers into the air. Sprayed on asbestos insulation is highly friable. Asbestos floor tile is not."

The lounge was repainted in NEIU's colors, blue and gold, and new carpeting was installed. Veronica Rodriguez informs that new furniture will be placed in the lounge, similar to furniture currently found in the Student Union. Two flat-screen TVs with cable are on the way in as well.

Bridge to SSA - Connecting NEIU to U of C

Professor Marius Dancea was once a student at Northeastern Illinois University (NEIU), just like most reading this article. He too roamed the halls in between classes and worried about finals.

But when he graduated from the school in 2002 with a Major in Political Science and a Minor in Social Work, a professor named Stanley Ramos convinced him to continue his education at the University of Chicago's School of Social Service Administration (SSA).

"He told me, 'Marius, This is the place for you; you have to feel the aura of this place, and I think you should go here."

Graduating in 2004, with a Master's in Social work, Dancea later came back to NEIU as a professor in 2009. During that first semester, He began a program to encourage students to seek out the same opportunity afforded to him; The Bridge to

SSA Program.

"What [Ramos] did for me, I wanted to do for as many students as possible."

The bridge to SSA is just that. Every year, Dancea rounds up any interested NEIU students and the group heads out to visit the University of Chicago. The daylong event includes a tour of the university, and a lunch for the participants to interact with SSA personnel.

Students meet up with members of faculty, chat with current graduate students from NEIU, as well as students that have graduated from the SSA.

"Mentorship is a huge piece there," says professor Dancea. Having students experienced in transitioning from NEIU to University of Chicago matters to him. "The students that participate in Bridge to SSA themselves later become the mentors." Dancea explains how students in years past

who become accepted, return to aide in the bridge program. Students who decide to apply through Bridge to SSA can also have their application fees waived.

Aside from a networking opportunity, Dancea also stresses the importance of having students actually visit the University of Chicago campus. "Sometimes you have to see the goal or vision right there," said the professor. "And if you are not in that environment, it's kind of hard to see it." He says that having prospective students physically there helps to let them envision a future with them studying there.

Dancea is passionate about giving back to the places that helped shaped who he is. Aside from creating the Bridge to SSA, Dancea is actively attempting to create a transcontinental bridge program.

In his native country of Romania, Dancea is in talks with the University of West Timisoara to create an exchange program. Not only does he hope to create new opportunities to provide students here, but as well as to advance Social Services studies in Romania.

All this is in an effort to create the world's best social workers. "He's broken that intimidation," says Luis Ortiz, colleague and officemate. Ortiz has also had a hand in helping Dancea and students in the Bridge to SSA, citing prestigiousness, financial issues as well as academic issues.

When asked about his motivations, Dancea replied "when you start believing in [students] more than they believe in themselves, that's when change starts to develop," adding "that's when they start developing in a way you never thought possible."



The Online Educational Model

For the first time in US history, student debt has surpassed credit card debt and reached one trillion dollars. It created social unrest when it became one of the most prominent concerns expressed by those involved in the Occupy movement.

Big banks are profiting off of student debt but our future generations, their career hopes chained up to fiscal slavery, are demanding access to affordable, good quality education.

Increasingly, online education is being cited as a key component of any solution to this problem. The Oct. 29, 2012 issue of Time magazine listed Udacity, Coursera and EDX as three companies that,

together, offer online college education to an international 2.15-million-strong student body for free. It is expected that this may change in the future, but the fees are expected to remain negligible.

The MOOC (Massive Open Online Course) trend appears to be gaining ground after Stanford professor Sebastian Thrun, CEO and co-founder of Udacity, developed an interactive, efficient online classroom where students were found to learn more than those taking classes in person. He did this using teaching methods that implement what we know from extensive research about how the brain learns.

In addition to the success of Udacity and similar models, there

have been numerous studies that document successful interactive learning online (ILO) models. A study by Ithaka S+R, a non-profit agency devoted to furthering online education, titled Interactive Learning Online at Public Universities: Evidence from Randomized Trials, compared ILO with traditional classroom-based learning (CBL) and found that there was no statistically significant difference in outcomes for students.

The Bottom Line Benefits

As a business model, online universities offer minimized need for brick-and-mortar buildings, courses that have a very low cost to produce, an international reach, and since lectures are recorded the professors put in less work and less time to reach more students.

For students, the trend offers lowered tuition costs and, perhaps as importantly, the virtual global campus ushers a new era that promises the democratization of educational opportunities.

Accreditation

Udacity is not yet nationally accredited but, through a partnership with some conventional schools, Udacity students are able to pay a fee to take their final exams at independent testing sites and gain college credit for it. However, even without traditional college accreditation, the success of Udacity is secured as many employers are

already beginning to hire Udacity students directly, particularly for positions that require skills that are in high demand, many of them in the computer science field.

Implementing ILO at NEIU

NEIU professor Mary Ellen Mc-Goey started doing online courses at the 300-level about five years ago and has continued to do one every semester ever since, expanding into 100- and 200-level French courses.

"For the most part, students at NEIU take online courses first and foremost for convenience. Most work and have family responsibilities so they truly appreciate the flexibility online courses offer.

Some reasons that have been mentioned by students for taking online include the birth of a new baby, full-time jobs which make it very difficult to attend on-campus courses, desire to complete their last course at NEIU the most convenient way possible, sudden moves to other parts of the country, etc. As is the case with most students who take online courses nationwide, 80 percent or more also take courses on campus," she said.

Professor McGoey took it upon herself to learn the computer technology required to construct a more efficient virtual classroom, although she says NEIU already has the beginnings of one (Blackboard). This was a time consuming process, and she had to invest some money herself in the software, but "more and more instructors beginning to get interested and willing to commit the time needed to give online a try."

When asked about Udacity and their partnership with conventional universities that offer credit by proctoring an exam for a fee, and whether that model may be implemented locally, Brad Baker, Assistant to the Provost said that NEIU is not likely to proctor MOOC exams from competing online universities saying "that's kind of where we are. We're not gonna be an online university but use the online tools when they enhance learning and make sense."

He cited a 2012 ECAR (Educause Center for Applied Research) Study of Undergraduate Students and Information Technology that mirrored the results of the Ithaka S+R study, reporting that 70 percent of students indicated that they learn best in blended learning environments such as are found in hybrid courses.

He added, "this semester, Spring 2013, there are 41 fully online class sections being offered and 74 hybrid class sections. So far, 175 NEIU faculty members have completed a four-week program offered by the CTL called Online Teaching I."

Energy Drink Risks May Jolt New Prohibition

Red Bull may give you wings, butAlderman Ed Burke of the 14th ward wants to give you fines. He recently proposed a ban on the distribution, consumption or furnishing of energy drinks. If caught, the fine can range from \$100 to \$500.

Alderman Ed Burke is most famous for his ordinance to ban smoking in public areas in Chicago, making it mandatory to spay pets, regulating fatty restaurant foods and holding a hearing with Jerry Springer to determine whether the violence on his show was real or fake and if it was acceptable.

The FDA has received four reports of energy drink related deaths. Multiple people and children have been reporting to the emergency rooms for caffeine intoxication caused by energy drinks. The sudden influx of energy drink-related hospitalizations has prompted Alderman Burke to gain support for an energy drink ban.

According to the FDA "it is a natural chemical found in such items as tea leaves, coffee beans and cacao." As a result, energy drink corporations are not required to list the amount of caffeine they have in their products, so smudging the numbers is a non-issue.

The key to energy drinks, besides the high amounts of caffeine is that they also include multiple other known energy supplements. Guarana, panax ginseng, and L-Tyrosine are some of the most common energy supplements which are known for providing energy or being used to create energy within the body. The problem is that all

of these put together slowly compound to a huge energy boost.

The greatest problem caused by energy drinks is caffeine intoxication. This is caused by caffeine directly over-stimulating the central nervous system (CNS) made up of the spinal cord and brain.

This can lead to ventricular fibrillation; this means the heart muscles quiver as opposed to properly contracting. This arrhythmia can lead to the heart stopping completely and death due to lack of circulation, also known as sudden cardiac death (SCD).

Continuous overdosing without going to the extreme of death though, can also slowly lead to skeletal muscle break down (Rhabdomyolysis). This is exactly what it sounds like, the weakening of muscles due to muscle tissue break down.

If the muscles get swollen there can be other problems such as the blocking of arteries and veins leading to shock from lack of circulation and even kidney malfunctioning.

As K. Steven Whiting, Ph.D., of Phoenix Nutritionals in San Diego explains, "One, it targets the central nervous system directly. Two, it can lead to dehydration and loss of water-soluble nutrients that have a calming effect on the central nervous system. This combined effect can cause agitation and sleep problems and potentially lead to the development of long-term anxiety issues."

The most important thing to avoid with energy drinks is alcohol. While most individuals think


it prevents intoxication, it actually does the opposite.

The caffeine increases the absorption of alcohol into the body and it also energizes the drinker, making them feel like they are just fine. This can lead to alcohol intoxication much quicker since the alcohol is still in the person's system, they just don't realize it due to the caffeine keeping the CNS active.

A recent study on energy drinks by Dr. Sara Seifert found that "Results of human and animal studies have suggested that long-term taurine exposure may cause hypoglycemia but a decreased risk of coronary heart disease.... Of particular concern are ...the risks of hypertension, syncope, arrhythmias, and sudden death."

What this means is that energy drinks may be beneficial for but they can also have multiple adverse effects, especially if the consumers have pre-existing conditions or are very young such as in early adolescence.


The real answer is moderation; the same idea applies to energy drinks, especially because of their high caffeine and energy supplement contents. Alderman Burke's proposal assumes that people cannot and will not use energy drinks in moderation. Regulation or prohibition of energy drinks is another step towards the complete removal of personal responsibility via governmental regulation.

Not Just a Feeling of Loneliness

Feeling blue? Changing family dynamics, increased social isolation and an aging population are all factors that contribute to loneliness.

According to Dr. Christopher Merchant, Assistant professor of psychology at Northeastern Illinois University (NEIU) "Loneliness can be seen throughout the lifespan, and in fact is likely experienced by everyone at least some time in life.

Since humans are largely social animals, being deprived of social interaction and engagement (either actual social engagement or engagement that is meaningful to the individual) can be problematic no matter how old they are..."

Loneliness can strike any age group, but there are some age groups that are the most vulnerable. Young adults and elderly people are at the greatest risk of loneliness. Loneliness, depression and shyness are distinct but related to one another.

Dr. Merchant stated, "Loneliness and depression are different, but can be very related. Loneliness is a subjective, cognitive appraisal that an individual is disconnected from those around him or her; that they either do not have enough people in their social network, or that they cannot rely on these people for support. Depression is a collection of various mental, physical, behavioral and emotional disruptions that result in an overall lowering of mood and functioning. Feeling lonely can lead to depression, and being depressed can also increase the likelihood that one feels lonely."

A senior Biology student at NEIU admitted to periods of loneliness but would not classify herself as antisocial.

Several collaborated studies linked loneliness to greater sympathetic nervous system reactivity, higher blood pressure, or greater perceived stress.

A study published in the Journal of Neurology, Neurosurgery and Psychiatry, found that elderly people who were classified as lonely were 2.5 times more likely to develop dementia. The research study concluded that it was not a cause and effect relationship, but loneliness was associated with increased risk of dementia in elderly people.

According to Dr. Merchant, "In addition to the mental and social problems related to it, loneliness has been linked to problems with sleep, decreased immune function, high blood pressure and other cardio-vascular problems."

In a study published in Psychoneuroendocrinology, a positive correlation exists between loneliness and significantly greater fibrinogen, which is a protein that helps the blood clot and natural killer cell responses to stress.

Studies on lab rats showed that the rats kept in groups lived 40 percent longer than those rats that were kept in isolation. Treatments for loneliness ranged from mediation and brainpower to socialization programs.

The senior Biology NEIU student said when she becomes lonely, hanging out with friends helps.

According to Dr. Merchant, "A good way to fend off feelings of loneliness is to engage in activities that allow and/or force you to engage with and find common ground with people. Activities that require in-person interactions and shared goals and values may be particularly helpful. If the feelings of loneliness become very severe, cognitive-behavioral therapy has been shown to be effective in dealing with some of the problematic and troubling thoughts that lead to feelings of loneliness".

This could have huge implications on those individuals who are isolated in jails, mental institutions and those individuals who are isolated due to social dynamics and the ever-changing world.

Increased Prices for CTA

Frequent riders of the Chicago Transit Authority (CTA) are now paying more out of pocket to travel. The fare hikes went into effect on Jan 14, 2013, and are expected to generate an estimated \$56 million for the previously cash-strapped

The majority of the increases in price only affect riders utilizing one of the CTA's unlimited ride cards. There is also a surcharge on all pay-as-you-go magnetic strip cards purchased at the blue line O'Hare Airport stop.

The rise in prices for the 3-day pass, the 7-day pass and the 30-day pass were substantial. 3-day passes that were \$14 are now \$20, a 42.9 percent increase in price, while the 7-day passes rose to \$28 from \$23, a 21 percent increase.

The 30-day pass, previously \$86, now costs \$100, a 16.3 percent increase. The surcharge on the O'Hare Blue Line stop rose from \$2.25 to \$5, an increase in price of 122 percent.

Reduced student fare decreased by 10 cents to 75 cents, a decision made to help increase school attendance by Chicago students, CTA President Forrest Claypool told CBS News last week.

According to CTA Chairman

Terry Peterson, these prices along with the base fare of \$2.25 are set to stay the same until at least 2015. According to the CTA, an estimated 55 percent of CTA customers use the multi-ride passes. Many Chicagoans depend on it as a vital costsaving measure in a tight economy.

But many question the wisdom of the choice to levy a fare hike on the CTA's most consistent customers, the multi-ride passengers.

Significantly raising the cost of bulk ride purchases to the point of rendering the savings insignificant runs contrary to conventional business practices and may decrease income due to passengers being unable or unwilling to pay out the higher rates.

As it stands, a passenger using a 30-day pass will now have to take at least 46 full-fare rides in a month

(as opposed to 40 previously) to see any savings over paying the singleride fare of \$2.25.

7-day pass users now have to utilize the pass for a minimum of 14 full-fare rides within a week, up from 12.

Riders using the CTA's 3-day pass must use the pass 10 times over 3 days to save money over the perride price.

CTA users will eventually get to reap a few benefits of the price increase, including energy-efficient rail cars that will have aisle facing seats, and new six -car trains equipped with multiple security cameras, complementing the other cameras on the stations platforms for increased passenger safety.

Currently, the BSA has been gaining media attention since it may remove its long standing ban on homosexual members.

An internal memorandum from 1991 on bsa-discrimination. org, which has the BSA's position statement on homosexuality states, "We believe that homosexual conduct is inconsistent with the requirements in the Scout Oath that a Scout be morally straight and in the Scout Law that a Scout be clean in word and deed, and that homosexuals do not provide a desirable role model for Scouts.

Because of these beliefs, the Boy Scouts of America does not accept homosexuals as members or as leaders, whether in volunteer or professional capacities."

On June 28, 2000, the Supreme Court case Boy Scouts of America

went against the mission of the organization. Through this decision, the BSA was allowed to exclude homosexual members.

Now the BSA is considering dropping their policy against gay members. According to an article from NBCnews.com, a BSA official stated of the possible change in policy, "We're a grassroots organization. This is a response to what's happening at the local level."

One individual who sparked this change in policy is Ohio native Jennifer Tyrell. Tyrell, who was her son's Tiger Cub den leader, led her troop through acts of community service such as volunteering at soup kitchens and helping their community. She remained den leader, until April 2012, when she was notified that her position was being taken away because she was a lesbian.

Tyrell has since started an online petition and currently has more posted on local Ohio News website, WTOV9.com, quoted Tyrell saying "I like to think that my petition kind of ignited a fire under people and so this kind of thing happens all the time but now people are more willing to stand up and say we're not going to stand for it."

It's not just Tyrell who is fighting against the BSA policy; corporate companies have also shown their disapproval. An article on NBCnews.com states, "About 50 local United Way groups and several corporations and charities have concluded that the ban violates their non-discrimination requirements and have ceased providing financial aid to the Boy Scouts."

Despite those advocating for change, many individuals are strictly against the idea of letting homosexual members participate. A user on debate.org argued that because the BSA is a private organization and was founded on Christian ide-


Caulking Causes Computer Lab Closure - From the Desk of the Editor

Secession of Stupid States

The irresponsible aspect is that most red states that want to secede take more federal aid than they pay in back taxes. For example, South Carolina takes \$1.35 in federal money for every dollar paid in federal taxes. Louisiana takes about \$1.78 for every dollar. Without federal aid, public schools, small businesses, universities, city workers corporations, and law enforcement would crumble.

Along with losing federal aid, sanctions would be enacted, just like during the civil war. This would include pipelines, Federal blockage of shipping lanes, and truckloads of produce. Many believe this would be impossible due to them being so close, but if it happens with other countries, and it happened during the American Civil War, it can happen again. Just because someone is a neighbor doesn't mean they have

Even if secession was possible, it's still considered illegal by the Supreme Court. In 1862, early in

the Civil War, Texas seceded from the Union to join the Confederate States of America. After the war, Texas was temporarily governed under the Reconstruction policies of the federal government. That same year, the confederate government transferred funds to private individuals in payment of Confederate supplies and aid. After the Civil War (sometime in 1869) the Reconstruction government of Texas filed a lawsuit to recover state-owned bonds that were still held by the individuals at the time.

One of the buyers of these bonds was George White. White argued that at the time the bonds were sold, Texas was not a state of the Union, therefore they could not use the Supreme Court to file a lawsuit. The Court ruled against White, stating that the transfer of the bonds was not legal because they were not signed by the governor, as required by the federal law at the time. Due to this evidence Texas was able to get their bonds back.

The defendants argued that

since Texas had seceded at the time the federal law could not be applied. The Supreme Court later retorted that even though Texas had seceded, they only temporarily lost rights of the Union and not the membership itself. This lead Chief Justice Salmon Chase to state that the constitution created "an indestructible Union, composed of indestructible States."

Even though the government of Texas committed an illegal act, it was still considered a full-fledged state; therefore Texas could still file suits using federal courts. This was confirmed once again on November 2006, when Alaska's Supreme Court ruled that secession was il-

As hard as those states try they will never win, even if they would have been willing to wave their rights as U.S. citizens. So everyone: Stop crying about seceding! If it's really that bad, there's always Canada right across the border.



Letter to the Editor: Sandy Hook Shooting

On December 14, 2012, Adam Lanza walked into the Sandy Hook Elementary School in Newtown Connecticut and murdered 26 people with firearms that he reportedly took from his mother. Twenty of his victims were little children and six were adults. When the police arrived he committed suicide rather than face life in prison for his heinous crimes. On the same day of the shooting, and in the days to follow, the next despicable thing to happen was the way anti-gun members of our society reacted by blaming gun owners for the slayings at Sandy Hook resulting in a flame war between gun and nongun owning members of society.

Right after the news of the Sandy Hook shooting was dispatched on all of the major news networks, people were calling for tighter gun laws and some were even blaming the National Rifle Association for this horrible event. Message boards on the Internet and talk shows on television began to reflect the progun anti-gun debate that has polarized our nation for some time. The anti-gun argument called for comprehensive gun regulations and bans, while the pro-gun argument was defensive in an effort to protect the guns that many own which the anti's are suggesting the government confiscate. Another pro-gun response to the proposed gun bans was to buy massive amounts of ammunition and firearms from gun shops just in case some bans were to go into effect. Currently, Senator Diane Feinstein is trying to push a bill which would ban 157 types of weapons and any magazine which holds more than 10 rounds. This legislation would not ban all firearms; it will leave many types of weapons available for the general population's use. The ultimate goal of course is to ban them all. Senator Diane Feinstein said on 60 Minutes over 10 years ago that if she had the votes in the Senate she would ask Mr. and Mrs. America to give up all of their guns. The next shooting that the public was aware of was the shooting at Sandy Hook Elementary School, located in Newtown, CT; which also brought a light to the public's eye.

20-year-old Adam Lanza used household guns to kill his mother before going to Sandy Hook Elementary School. There he killed 20 children and six adults. Lanza was known to have social and behavioral problems thought to stem from a condition called Asperger's, soon to be part of the spectrum of

Illinois University (NEIU) Police, "What happened in the Adam Lanza shooting situation was very sad and tragic. He was told by his mother that he had to go to a mental hospital. Well, Adam didn't like that and took a gun and went to the local elementary school and shot

'With so many incidents steering from mentally unstable people having access to guns, the question now is what's happening to America with the mental people out there?" Sgt. Brehmer continued. "What's happening now is that some of the mental hospitals are being closed. In fact in Illinois they are closing a lot of mental homes, because of the money."

There will be 14 mental hospitals being closed this year, and the reason for that; Governor Quinn says it will save the state \$100 mil-

imum security prisons being closed as well. Tamms Correctional Center, one of the local maximum jails in Tamms, Illinois will be closing soon. "So what happens with the people that are in Tamms jail, they are going to go to Joliet jail which is the general population, and the mental institution patients are being pushed out because there is no more money for mental institutions to take over care of the patients," Sgt. Brehmer explained.

Last month on Dec. 15, 2012 15 situations and the lack of funding for mental health care point to a need for more regulations on gun control. 

Will Egypt Degenerate into a Theocracy?

Egypt in 2011 had a revolution where people died on the streets thirsty for freedom and furious against tyranny. Now, as the dust is settling, the draft of a new constitution seems to have been hastily voted on by a slim majority that re-establishes shari'a as the basis of Egyptian law and gives what many consider too much power to clerics from Al-Azhar University, to the president and the military.

The process was so lacking in transparency that liberals, Christians and secularists walked out in protest at one point, leaving mainly members of the Muslim Brotherhood in charge of the contents of the new constitution and increasing the polarization between secular and Islamist forces.

A recent article in The Economist, entitled "The Founding Brothers," states that the new con-

stitution would give a lot of power to the Muslim Brotherhood and in turn, Egypt would be similar to the days of Hosni Mubarak. The article discussed how one particular part of the constitution draft says that although freedom of religion is allowed, punishment would be given to those who ever insult the prophets. The Economist states that aspects such as these in the constitution draft were "vague or contradictory."

Among its provisions, the constitution gives the military the dubious right to arrest and subject to trial citizens independent of the judiciary, a clause that made many international defenders of human rights cringe. It reminded many of the recent arrest of 52 men on the Queen boat for the imaginary crime of homosexuality and the harassment and torture by the military that, according to Amnesty International, gay men had been facing for years. The so-called "Cairo 52" were accused of "habitual debauchery" and some were charged with the crime of "defaming Islam."

We may glean an indication of how unsophisticated the military's judicial and legal rationale can be, particularly when informed by shari'a ideology, from the example of BBC reports in 2002 that the Cairo men were ordered to take down their pants by the military to verify whether they were wearing typical Egyptian underwear. This was the

test that proved whether or not they were homosexual.

During the vote, the city of Alexandria witnessed violent protests, particularly aimed at women as they protested a polling station where they were being prevented from voting because they weren't veiled.

Another group that stands to suffer are the Baha'i. Not only is the new constitution based on shari'a, but it also limits religious liberty to the so-called "heavenly religions" of Islam, Christianity and Judaism: Article 37 grants the right to build a house of worship only to these three religions. As such, Baha'is and members of any other religious tradition would find themselves sec-

ond-class citizens just as they were under Mubarak, when they were denied the right to carry a national ID card for refusal to identify as either Christian or Muslim. Without this card, they were unable to enjoy basic social services and rights in Egyptian society. The new constitution clearly indicates that religious discrimination will continue even as it supposedly guarantees religious liberty.

If the Muslim Brotherhood has its way and the new constitution is formally adopted as it is, many who are concerned about nurturing the seeds of the democratic revolution feel that nothing will have changed in Egypt and the blood of its martyrs will have been spilled in vain.





The Ravens are 1-0 (Super Bowl XXXV vs. the New York Giants) and the 49ers are 5-0 (Super Bowls XVI vs. the Cincinnati Bengals, XIX vs. the Miami Dolphins, XXIII vs. the Bengals, XXIV vs. the Denver Broncos, and XXIX vs. the San Diego Chargers).

The Ravens, wearing visiting white jerseys with black bottoms, won the coin toss and elected to defer. The 49ers, wearing home red jerseys with gold bottoms, started slow with a 3-and-out. The Ravens offense surged behind Joe Flacco, who threw a touchdown to Anguan Boldin to put the Ravens up 7-0.

The 49ers responded with a field goal on their next drive, making the score 7-3. Flacco and the Ravens weren't going to ease off, and ended up adding two more touchdown passes, including a 56vard bomb to Jacoby Jones, who danced his way into the endzone.

The keys to the first half were takeaways and Flacco's performance. Flacco went 13-of-20 with 192 yards and 3 TDs. The Ravens were able to force a Mike James fumble, and intercepted a pass by Kaepernick, the first interception in a Super Bowl by the 49ers.

With less than two minutes left in the half, the 49ers tried one more time to get the ball into the endzone, but were denied by a stout Ravens defense, and had to settle for a field goal, making the score at halftime 21-6.

The Ravens received the kickoff after halftime, and Jacoby Jones returned the kick for a 108-yard, record-tying touchdown. It seemed as though the Ravens were set to steamroll the rest of this game as they took a 28-6 lead, but a darkness was about to creep over the team.

Actually, it was half of the Superdome. Just into the second half, half of the power was lost in the stadium, causing a 35-minute delay. Officials stated that a power surge caused the outage, but no more information was provided.

The 49ers couldn't have been given a greater gift. The delay took the wind right out of the Ravens sails, and breathed new life into Kaepernick and the 49ers. They rebounded with a monster of a third quarter. Kaepernick passed to Michael Crabtree for a 31-yard score, Frank Gore rushed in for another, and a David Akers field goal brought the game within one score, at 28-23 going into the fourth quarter.

The teams were determined to leave nothing on the field, but the Ravens were struggling and the 49ers were mounting a monumental comeback. The Ravens were able to stay ahead with a Justin Tucker field goal, making the score 31-23. But Kaepernick wasn't finished. He led his team on a touchdown drive, topped off by his own 15-yard rush for the score. Now down by only two, the 49ers elected to go for the 2-point conversion. They failed.

The Ravens got the ball back,

and although they still couldn't muster much offense, they were able to come away with another field goal, making the score 34-29.

History in the Malcing

Kaepernick had approximately 4:30 left on the clock in order to bring his team back for the victory. The 49ers drove down to the red zone, and were forced into a fourth and goal situation. This was their last chance to score, but they were denied by a rallying Ravens defense.

The Ravens took back possession, ran the ball three times to wind the clock, and finally ran the clock down to four seconds before the punter stepped out the back of the endzone for a self-inflicted safety. The 49ers didn't score on the ensuing punt, and the game ended with a final score of 34-31.

Joe Flacco was named the Super Bowl MVP, going 22-of-33 for 287 yards, 3 touchdowns, and 0 interceptions. The Baltimore Ravens are the champions of Super Bowl XLVII, and they are most certainly going to Disney World.



Battling tough teams, the Chicago Blackhawks have pulled through and shown their strength by having the best start in franchise history: 6-0-0. As of Jan. 30, 2013 the Chicago Blackhawks have one of the best starts in NHL history, and although they have a rough road ahead of them, the rest of the Hawks' season looks very promising.

With attendance and ratings off the charts, it is no surprise that the Hawks have a large following on the road. The Hawks challenged the LA Kings on Jan. 19 and won with a score of 5-2. They made hockey look easy as they scored three of their goals in the first period. Marian Hossa, in the first game he has played since his concussion in late April last season, had two goals and one assist.

Next the Chicago Blackhawks battled the dreaded Phoenix Coyotes. These teams hadn't seen each other since the first round of the playoffs last season, and tensions were high. Hossa had two goals that helped Chicago keep their lead against the Coyotes. After the game Hossa said, "I can't expect two goals

every night, but it's nice to have a good start." A good start indeed, and a trend that will hopefully continue into the rest of the season. Although the Hawks let a 5-2 lead slip away in the middle of the third period, they managed to stay ahead by one and finished for a final score of 6-4.

In the Chicago Blackhawks home opener two days later, they faced the St. Louis Blues. The Blues, coming off two wins themselves, were looking to stay undefeated and gave the Hawks a good run. Unfortunately for the Blues, Patrick Kane, Brent Seabrook and Viktor Stalberg each had a goal for the Hawks to start off with a 3-0 lead. St. Louis fought back with two goals in the third, but Hawks goalie Corey Crawford held them off with 32 saves for a final score of 3-2.

With attendance at high of about 21,500 fans, the Hawks were proud to continue their undefeated season.

Marian Hossa was again the star of the game as he was able to score in overtime against the Dallas Stars. Hossa's goal edged the Hawks for a 3-2 final on Jan. 24 At the Ameri-



can Airlines Center in Dallas, Patrick Sharp and Jonathon Toews each had a goal that contributed to the victory. Without the team's assists, they would not have been able to win. They are playing like the 2009-2010 season when they came together to win the Stanley Cup.

Patrick Kane said in an interview that it is still too early for playoff talk, so the Hawks continued on the road and headed to Columbus next. The Blue Jackets were coming off a couple of losses and were looking to make a comeback. Jonathon Toews pulled through in the third period once again for the game winning goal against the Blue Jackets, and Corey Crawford had 24 saves to help the Hawks maintain their lead.

Blackhawks Head Coach Joel Quenneville said, "Finding ways to win is important. You're not going to be great every night or your best every night. Columbus played a hard-working game, working harder than us tonight. But we got key saves from (Crawford) tonight and that helped us."

As far as who deserves credit for the history marker, Quenneville praises everyone, "I think everybody deserves credit. Everybody's




her body, relieve stress, and get a healthy dosage of adrenaline. This was not her first time participating, so Davis knew what to expect, but she still expressed eagerness to participate.

The recent climb had a low attendance, which proved advantageous for the few attendees because it allowed for more space and time on the course. Cameron has been teaching Zumba at NEIU for two semesters and plans to continue teaching Zumba for as long as NEIU will allow. He teaches Zumba Toning on Tuesdays at 12- 12:50 p.m., as well as at 7:30- 8:30 p.m. in studio one in the NEIU P.E. Complex. "One of our biggest field trips will happen this spring break," Leibovitz said. The group will camp at the Daniel Boone National Forest in Kentucky and visit the Red River Gorge Geological Area and Mammoth Caves. This is an opportunity for students to see "some amazing geological sites," learn the art of function and survival in the field, and "get to know some great people," said Leibovitz. This experience is believed to assist future geologists or create a spark and a newborn interest to pursue a career in geology.

Mani Valathur was attracted to the club for its commitment to help the community. He had the privilege of joining their Great Lakes Issues and Montrose Beach Cleanup and The Friends of the Chicago River cleanup.

"The club helps even the local cub scout troops to earn their geology badges," Valathur said. Making a difference in the community with such activities not only transforms those at the receiving end and our environment, but also the individuals who volunteer.

The club also provides many opportunities for those who are not ideally outdoorsy. Activities include trips to museums and volunteer opportunities at schools. In the fall of 2012, members visited Warren Township High School in Gurnee, IL. The students were taught about the activities of the ESC, the expectations of college life, and advantages and opportunities in pursuing the geosciences. kept for love and secrets,



Take a break from the negative news of the world by walking through 'Breaking Hours,' Zeenat Ismail's Senior Art Show. Ismail presents a narrative series of 18 breathtaking paintings designed to stimulate the viewer's imagination.

"Daily life is too serious," Ismail said when asked of the purpose behind 'Breaking Hours.' "We are bombarded by images of war, crime, feminist issues by the media. These issues are important, but people need a break from the bad news. This series is intended to bring a return to the fantasy and magic of childhood," Ismail said.

Her influences include the rich colors and dramatic light play of the Impressionist era. Ismail also receives inspiration from films such as Pan's Labyrinth, Disney movies, and musicals, particularly from the Golden Age of Hollywood cinema.

She described the concept of the unseen world as viscerally attractive, and likened the development of the 'Breaking Hours' series to search for a child's enchanting perspective. "Creating fantasy worlds of all scales remains the primary impetus of my work," Ismail said in her artist statement.

The paintings themselves recall dreamscapes and a return to a more elegant age. "I hope my work will broaden the viewer's imagination," Ismail said.




The Green 17 Tour comes to Chicago every year right between the end of January and the middle of March. On Jan. 26, Flogging Molly once again dismantled the walls of the Aragon Ballroom.

This year, Flogging Molly brought along two opening acts. The first, Dave Hause, is one man alone with his guitar. A very talented guitar player and vocalist, Hause's styles and songs are reminiscent of Rise Against, but he looked and felt very alone on stage. There wasn't a

single song of his that would not have benefitted greatly from a solid bass line or rousing drum fill.

The other group along on the tour was Skinny Lister. This fivepiece band out of London showed up and rocked some faces off with their Old English take on classic Bluegrass. Imagine four super-skinny British guys in tight jeans, flannel shirts and wife beaters, and one frisky looking girl in a sundress. Now give those guys an accordion, a standing bass, an acoustic guitar or a mandolin, and give the girl some silly dance moves and a huge XXX jug of alcohol and we've got quite the show. No drum set? during the show, including songs that the band hasn't played in many years.

The biggest gamble is which of their hits they will open or close the set with, and then rush to count which ones are left during the encore. Fans are guaranteed a happy dose of "Drunken Lullabies," "Seven Deadly Sins," "Salty Dog," and "If I Ever Leave This World Alive," and there will never be a complaint heard about any of them.

In true classic Flogging Molly fashion, after their encore was complete and the crowd was still cheering, Monty Python's "Always Look on the Bright Side of Life" came on over the speakers. The band sang and danced with each other as they shook hands and met people who stayed for autographs. Across the main floor fans could be found dancing, singing and whistling as they headed toward the exits.

Moviegoers in search of something purely for its entertainment value need look no further; *Gangster Squad* certainly didn't. While this film has all of the gun-blazing, face-beating and fancy suit-wearing that makes every gangster genre film at least somewhat enjoyable, Director Ruben Fleischer's *Gangster Squad* provides little else for its audience to enjoy.

Matt Brunson of Creative Loafing said it perfectly, "This movie claims to "be based on a true story" but turns out to be as authentic as *The Flintstones in Viva Rock Vegas*."

The film takes place in 1949 Los Angeles during the rise of famed mobster Mickey Cohen (Sean Penn). The plot centers on Cohen's swift and violent takeover of Los Angeles while a group of incorruptible cops, led by Sergeant John O'Mara (Josh Brolin), attempts to dismantle Cohen's organization and drive him out of the city.

Audience members seeking more from their movie-going experience than base levels of entertainment will be pleased with this film for one reason: Sean Penn. Penn's portrayal of a malicious crime lord encapsulates and thrills every time he appears on screen. Penn manages to act his way around a belligerent script and come across as disturbing and cruel as Mickey Cohen was in real life.

The same cannot be said, unfortunately, for the rest of the cast. Josh Brolin is weighed down by O'Mara's forced dialogue, making the character seem like little more than a dumb brute, and Emma Stone exists purely as a prop. Her character never has much to say, but certainly plays her part as the foxy bombshell in the red dress. This was fine for

aesthetic purposes, but was overall disappointing from an actress with legitimate talent.

The true disappointment came from Ryan Gosling, who seemed to personify the debacle that this movie becomes. Peter Rainer of the Christian Science Monitor explains, "Director Ruben Fleischer and Screenwriter Will Beall can't decide whether to make a spoof or a serious drama, so they wrongheadedly attempt both." This is exactly true of Gosling's character, who never seems to take anything seriously, and yet still tries to be the voice of

reason within the film.

In a film too obviously modeled after Director Brian De Palma and Screenwriter David Mamet's brilliant The Untouchables, Fleischer and Beall hardly claw their way into the ranks of the gangster genre pantheon. *Gangster Squad* is reminiscent of *The Untouchables*, but in reality it comes away barely as good as *Public Enemies*, which was certainly no gem itself.




Switching gears, the next game

play hard. So hit the books... and then the buttons.






