AUTHORS OF ARTICLES IN THIS ISSUE

SAMUEL J. BROAD, author of "The Accountant's Report and Certificate," is a partner of Peat, Marwick, Mitchell & Co., New York, N. Y. He has been associated with the firm since 1946. Mr. Broad received the B.A. degree from Queens University, Kingston, Ontario, and is a Canadian chartered accountant. He is a past director of the New York State Society of Certified Public Accountants. Mr. Broad has been a member of the American Institute of Accountants since 1921 and has served on many of its committees, including the committee on accountants' certificates, and special committee on cooperation with Securities and Exchange Commission. He is chairman of the special committee to revise the bulletin, Examination of Financial Statements.
