AAC President to Speak at CLAS Colloquium

Mark H. Curtis, president of the Association of American Colleges, who is a leading authority on undergraduate curriculum and educational administration, will be the keynote speaker at the CLAS 50th anniversary colloquium Wednesday, Feb. 20.

Curtis, a Guggenheim fellow and Folger Shakespeare Library fellow, will discuss the AAC's new report on redefining and the meaning and purpose of baccalaureate degrees. He chaired the special committee that prepared the report.

The title of Curtis' address, which will be given at a keynote luncheon at noon in the Pallot Library, is "Liberal Education, Meet for These Times."

The talk is part of a two-day program on "Creativity and the Implementation of Change: Liberal Learning in the Practical World" which will be held in the University Auditorium, featuring creativity in technology, schooling, and literature.

At the opening session, Wednesday, Feb. 20 at 9 a.m., Zenon W. Pylyshyn, director of the Centre for Cognitive Science at the University of Western, Ontario, will speak on "Artificial Intelligence and Human Nature." He will be joined by Maria M. Bonaventura, professor of chemistry at Suffolk University, Daniel C. Dennett, professor of philosophy at Tufts University, and Stuart Goldkind, member of the Artificial Intelligence Group at Mitre Corp., as discussants.

Edson Elected SOM Trustee

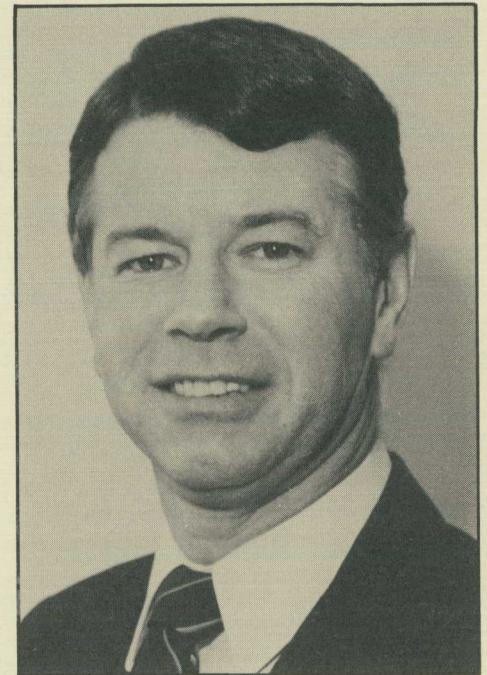
Robert P. Edson of Wakefield, regional director of the Department of Health and Human Services, has been elected to a three-year term as a School of Management representative on the Board of Trustees.

Edson, who received his B.S.B.A. degree in 1967 and an M.B.A. in 1972, both from Suffolk, was voted to the board in a general election by School of Management alumni. He was sworn in as a member of the Board of Trustees at the board's meeting Feb. 13.

"I'm delighted," said Edson. "It means a lot of hard work for the next three years, but I'm looking forward to it. As an alumnus, I have a great sense of pride and respect in the achievements and direction of the School of Management and will strive to serve the University and the alumni by supporting the continued growth of quality education at the University, promote the importance of an active and involved alumni body and develop stronger relations between students and alumni."

Edson succeeds Frank A. Sablone, B.S.B.A.'70, M.Ed.'71, who has just completed a three-year elected term as an alumni trustee for the School of Management.

Married to the former Miriam Smith, and with a daughter, Danielle, Edson has been long active in alumni activities. He served two terms as director of the MBA/MPA Alumni Association, including two years as



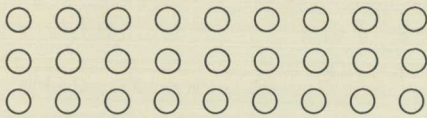
president and is an area chairman of the annual fund drive. He is also a member of the New England Intergovernmental Audit Forum and serves on other professional and local organizations.

The alumni trustee process, under University bylaws, calls for all three schools of Suffolk University to have three-year representation on the board of trustees with candidates elected on a rotating basis. Currently the College of Liberal Arts and Sciences is represented by Gerald A. Lozeau while the Law School is represented by Atty. Thomas J. Wynn. The process was instituted in 1976. ○

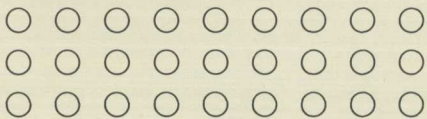


accomplishments, considers its current circumstances and raises questions about the future, will be distributed to all department chairmen. Comments and suggestions from the faculty are welcome. One of our "strategies" is to become more aggressive and more scientific in our recruitment of new students. Last fall, the Board approved the position of dean of enrollment management. This position will help to coordinate and improve the efforts of admissions, financial aid, registrar, publications, admissions-research and retention in the College of Liberal Arts and Sciences and the School of Management. A search committee chaired by Dr. Kenneth Garni, director of the Counseling Center, has worked long and diligently to find the best possible candidates for this position. I look forward to announcing the newest member of the Suffolk University family shortly.

Discussions with the Beacon Hill Civic Association and with our neighbors on Hancock, Ridgeway and Temple Streets concerning the development of a new University Center on Cambridge Street are proceeding. Expectations for a reasonable resolution of differences are positive. At the January 29 meeting of the Trustees' Student Affairs Committee, the need for a new University Center was spoken to by several student leaders. The students described the conditions of student life in the Ridgeway Building and in the leased physical education facilities used by Suffolk University. They expressed their support for the project as critical to the continued development of the University and the enhancement of student life. The student leaders offered to establish a committee to work with the Development Office to help realize this long-standing goal.



President's Corner



Another strategy is to further increase our fundraising and external support for faculty activities, scholarships and other endeavors. Thanks to the efforts of the Development Office and the alumni leaders, the number of alumni donors has increased by 50 percent over this time last year. The number of grant applications submitted for individual, departmental and University projects also continues to increase, as does the number of faculty involved in research.

On February 20 and 21, the College of Liberal Arts and Sciences will conclude its year-long celebration of its 50th anniversary with a conference on "Creativity: Liberal Education in a Practical World." The conference is sponsored in conjunction with several national and regional organizations, including the Association of American Colleges (AAC), the organization which represents liberal arts education across the nation. Participants include Dr. Mark Curtis, president of the AAC, scholars from Suffolk University and elsewhere, and Governor Dukakis. Dr. Curtis' remarks are expected to focus on the future of liberal learning and the baccalaureate degree.

Our past achievements, celebrated during the University's 75th anniversary in 1981 and which we continue to celebrate during the 50th anniversary of the College of Liberal Arts and Sciences in 1984-85, have enhanced both the quality and the visibility of Suffolk University. These accomplishments are a prelude to future achievements and recognition. In terms of calendar years, the University may be a mature established institution. In spirit and in outlook, it remains youthful, creative, dynamic, forward looking and developing.

Adult students have always been an important part of the clientele served by Suffolk University. Although we now enroll 2,400 full-time undergraduates who come to Suffolk University, for the most part, directly from high school, it is important that we not neglect our service to adult learners. In November, I established a Task Force to Improve the Conditions for Adult Learners at Suffolk University. Chaired by Dr. Diane T. Rudnick, the purpose of this task force is to examine issues which affect adult learners, to explore policies and procedures which will enhance and improve learning opportunities for adults, and to make recommendations which will not only improve the circumstances for students presently enrolled but will facilitate the University's efforts to reach out to its traditional clientele.

As a community of scholars and learners we share a vision of the future of Suffolk University as an institution of growing quality and recognition. Working together, we can make that vision a reality.

On December 17, 1984, the Board of Trustees met to consider the strategic planning issues raised by "A Strategic Plan: Step 1," a document produced out of the deliberations of the University's Long-Range Planning Committee. Copies of this document, which reviews the University's recent

On Feb. 7, Carnival, a festival with music and dancing, was held by the Suffolk Hispanic Association in the Sawyer Cafeteria.

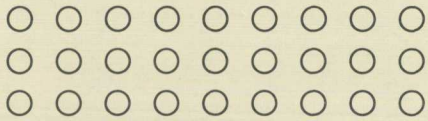
"Can I Speak for You, Brother," a one-man, one-act play, was performed by Philip Walker in Fenton 603 on Feb. 13.

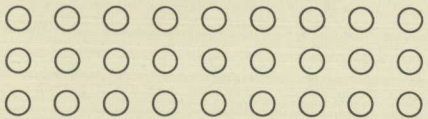

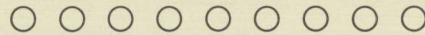

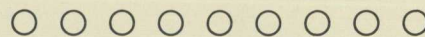

Law School's CCPD Plans Workshop on Abused Children

The Law School's Center for Continuing Professional Development, which sponsored a highly successful workshop on recent developments in the law in December, has scheduled two new workshops for the month of March.

The first, taking a look at Practical Aspects of Article 2 of the Uniform Commercial Code, will be held on March 9. On March 30, a workshop will be held on Care and Protection of Neglected and Abused Children. The workshops are under the direction of Prof. Charles Kindregan.

A December 13 workshop on recent developments in the law attracted 95 attorneys from throughout New England. Attys. Diane Tillotson and Steve Kramer of the Law School Alumni Association acted as commentators.

Open Enrollment for TIAA Total Disability Insurance Plan

March is "Open Enrollment" month for the TIAA Total Disability Insurance Plan.

If you are a full-time member of the faculty, administration or support staff (office and clerical), over 30, and have been employed at the University for one year or more; you may enroll in the disability plan. No medical exam is required for the March enrollment. Even if you have been previously denied coverage for health reasons, you may join now.

Coverage is effective April 1 provided you are at work on that date and that the enrollment card is signed and returned to the Personnel Office by April 1.

Briefly, the TIAA Total Disability Insurance Plan pays you a part of your salary if you are totally disabled and unable to work. After six consecutive months of total disability the plan pays you income benefits which are equal to 60% of the first \$5000 of your base monthly salary.

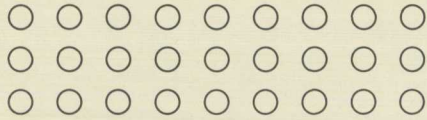
If you are enrolled in the TIAA-CREF Standard Retirement Plan, the plan also pays both yours and the University's contribution to your retirement plan.

You and the University share the cost of this plan. Your cost is based upon your salary and will change as your salary changes.

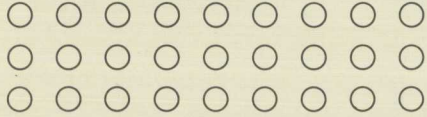

Trustee Emeritus Joseph Schneider Succumbs at 84

President Perlman and Vice President Flannery headed a group of University trustees paying final respects to Trustee Emeritus Joseph Schneider at Levine Chapel, Brookline Feb. 3. He died Feb. 1 at the age of 84 after a brief illness.

A practicing attorney for more than 50 years, Mr. Schneider had served on the Suffolk Board of Trustees for 20 years and held an honorary doctorate of law from the school. He was presented a gold medal at the 1975 commencement

exercises for his distinguished service to the University and designated trustee emeritus in 1978.

Born in Russia, he grew up in Boston's old West End. He was a founder of the Massachusetts Bar Foundation, the National Association of Claimants Compensation Attorneys and the New England Law Institute. He was president emeritus of Massachusetts Continuing Legal Education.

In addition to his Suffolk honors, Schneider was the Gold Medal Recipient of the Massachusetts Bar Association and a past president and was also national treasurer of the American Trial Lawyers Association. ○
