Social Impact and the AACSB Standards

In the 2020 Standards Societal Impact was defined as a "force for good."¹

A February 2023 AACSB paper further defined it as "activities undertaken by business schools that over time lead to meaningful, discernable change for the betterment of people, economies, and the environment."²

Library Support - Standard 4: Learner Success

4.3 The school's curriculum promotes and fosters innovation, experiential learning, and a lifelong learning mindset.

Program elements promoting positive societal impact are included within the curriculum.

- 1. Curriculum support:
 - a. Identification of sustainability and social justice resources for new programs and courses
 - b. Review of OER materials for courses
- 2. One-shots and consultations helping students to find sources for sustainability and social justice assignments.
- 3. Tutorials and micro badging including sustainability and social justice scenarios.

Library Support - Standard 8: Thought

8.3 The school's portfolio of intellectual contributions contains exemplars of basic, applied, and/or pedagogical research that have had a positive societal impact, consistent with the school's mission.

A 2023 Sage study⁷ of business academics found that:

- 31% of business academics say there is no incentive to apply their research outside of academia
- 76% said journal impact factor was important/highly important

A February 2021 *Insights* article⁸ addresses this conflict between journal impact factors and societal impact, emphasizing the need to prioritize societal impact in faculty publications and measure outcomes of the article (real world impact) over output (number of cites).

S. Kabadayi and G. Jason-Dibartolo (2021)⁹ interviewed 26 administrators from 24 business schools and recommended schools "require and give additional weight to positive societal impact contributions during merit and/or tenure/promotion decisions." Another recommendation was to compose a list of publications that specialize in societal impact in the field.




FIGURE 4. Importance of research getting published in highly cited journals/journals with high impact factors (as measured by Journal Citation Reports)

Library Support - Standard 9: Societal Impact

9.1 The school demonstrates positive societal impact through internal and external initiatives and/or activities, consistent with the school's mission strategies, and expected outcomes.

Develop library programming around sustainability and social justice--we are already doing this!

See how it can be tied into the business school.

- 1. Micro-credentialing
- 2. Extra credit
- 3. Faculty speakers
- 4. Provide a Venue

Offer research support to extracurricular experiences--case competitions, internships, community partnerships, entrepreneurial development within the social justice focus.

Regularly answer the question "what have you done to create societal impact…Impact should not be an afterthought."¹⁰
