# A GENERALIZED FINITE ELEMENT METHOD FOR LINEAR THERMOELASTICITY

#### Abstract

We propose and analyze a generalized finite element method designed for linear quasistatic thermoelastic systems with spatial multiscale coefficients. The method is based on the local orthogonal decomposition technique introduced by Målqvist and Peterseim (Math. Comp. 83 (2014) 2583-2603). We prove convergence of optimal order, independent of the derivatives of the coefficients, in the spatial $H^{1}$-norm. The theoretical results are confirmed by numerical examples.

## 1. Introduction

In many applications the expansion and contraction of a material exposed to temperature changes are of great importance. To model this phenomenon a system consisting of an elasticity equation describing the displacement coupled with an equation for the temperature is used, see, e.g., [6]. The full system consists of a hyperbolic elasticity equation coupled with a parabolic equation for the temperature, see [9] for a comprehensive treatment of this formulation. If the inertia effects are negligible, the hyperbolic term in the elasticity equation can be removed. This leads to an elliptic-parabolic system, often referred to as quasistatic. This formulation is discussed in, for instance $[24,27]$. In some settings it is justified to also remove the parabolic term, which leads to an elliptic-elliptic system, see, e.g., $[24,27]$. Since the thermoelastic problem is formally equivalent to the system describing poroelasticity, several papers on this equation are also relevant, see, e.g., [5, 26].

In this paper we study the quasistatic case. Existence and uniqueness of a solution to this system are discussed in [24] within the framework of linear degenerate evolution equations in Hilbert spaces. It is also shown that this system is essentially of parabolic type. Existence and uniqueness are also treated in [27] (only two-dimensional problems) and in $[23,25]$ some results on the thermoelastic contact problem are presented. The classical finite element method for the thermoelastic system is analyzed in [11,27], where convergence rates of optimal order are derived for problems with solution in $H^{2}$ or higher.

When the elastic medium of interest is strongly heterogeneous, like composite materials, the coefficients are highly varying and oscillating. Commonly, such coefficients are said to have multiscale features. For these

[^0]problems classical polynomial finite elements, as in [11,27], fail to approximate the solution well unless the mesh width resolves the data variations. This is due to the fact that a priori bounds of the error depend on (at least) the spatial $H^{2}$-norm of the solution. Since this norm depends on the derivative of the diffusion coefficient, it is of order $\epsilon^{-1}$ if the coefficient oscillates with frequency $\epsilon^{-1}$. To overcome this difficulty, several numerical methods have been proposed, see for instance $[3,4,15,16,18]$.

In this paper we suggest a generalized finite element method based on the techniques introduced in [18], often referred to as local orthogonal decomposition. This method builds on ideas from the variational multiscale method $[15,16]$, where the solution space is split into a coarse and a fine part. The coarse space is modified such that the basis functions contain information from the diffusion coefficient and have support on small patches. With this approach the basis functions have good approximation properties locally. In [18] the technique is applied to elliptic problems with an arbitrary positive and bounded diffusion coefficient. One of the main advantages is that no assumptions on scale separation or periodicity of the coefficient are needed. Recently, this technique has been applied to several other problems, for instance, semilinear elliptic equations [13], boundary value problems [12], eigenvalue problems [19], linear and semilinear parabolic equations [17], and the linear wave equation [1].

The method we propose in this paper uses generalized finite element spaces similar to those used in $[14,18]$, together with a correction building on the ideas in [12, 16]. We prove convergence of optimal order that does not depend on the derivatives of the coefficients. We emphasize that by avoiding these derivatives, the a priori bound does not contain any constant of order $\epsilon^{-1}$, although coefficients are highly varying.

In Section 2 we formulate the problem of interest, in Section 3 we first recall the classical finite element method for thermoelasticity and then we define the new generalized finite element method. In Section 4 we perform a localization of the basis functions and in Section 5 we analyze the error. Finally, in Section 6 we present some numerical results.

## 2. Problem formulation

Let $\Omega \subseteq \mathbb{R}^{d}, d=2,3$, be a polygonal/polyhedral domain describing the reference configuration of an elastic body. For a given time $T>0$ we let $u:[0, T] \times \Omega \rightarrow \mathbb{R}^{d}$ denote the displacement field and $\theta:[0, T] \times \Omega \rightarrow \mathbb{R}$ the temperature. To impose Dirichlet and Neumann boundary conditions, we let $\Gamma_{D}^{u}$ and $\Gamma_{N}^{u}$ denote two disjoint segments of the boundary such that $\Gamma:=\partial \Omega=\Gamma_{D}^{u} \cup \Gamma_{N}^{u}$. In addition, we assume meas $\left(\Gamma_{D}^{u}\right)>0$. The segments $\Gamma_{D}^{\theta}$ and $\Gamma_{N}^{\theta}$ are defined similarly.

We use $(\cdot, \cdot)$ to denote the inner product in $L_{2}(\Omega)$ and $\|\cdot\|$ for the corresponding norm. Let $H^{1}(\Omega)$ denote the classical Sobolev space with norm $\|v\|_{H^{1}(\Omega)}^{2}=\|v\|^{2}+\|\nabla v\|^{2}$ and let $H^{-1}(\Omega)$ denote the dual space to $H^{1}$. Furthermore, we adopt the notation $L_{p}([0, T] ; X)$ for the Bochner space with the norm

where $X$ is a Banach space equipped with the norm $\|\cdot\|_{X}$. The notation $v \in H^{1}([0, T] ; X)$ is used to denote $v, \dot{v} \in L_{2}([0, T] ; X)$. The dependence on the interval $[0, T]$ and the domain $\Omega$ is frequently suppressed and we write, for instance, $L_{2}\left(L_{2}\right)$ for $L_{2}\left([0, T] ; L_{2}(\Omega)\right)$. We also define the following subspaces of $H^{1}$

Under the assumption that the displacement gradients are small, the (linearized) strain tensor is given by:

Assuming further that the material is isotropic, Hooke's law gives the (total) stress tensor, see e.g. [23] and the references therein,

where $I$ is the $d$-dimensional identity matrix, $\alpha$ is the thermal expansion coefficient, and $\mu$ and $\lambda$ are the so called Lamé coefficients given by:

where $E$ denotes Young's elastic modulus and $\nu$ denotes Poisson's ratio. The materials of interest are strongly heterogeneous which implies that $\alpha, \mu$, and $\lambda$ are rapidly varying in space.

The linear quasistatic thermoelastic problem takes the form

where $\kappa$ is the heat conductivity parameter, which is assumed to be rapidly varying in space.
Remark 2.1. For simplicity we have assumed homogeneous boundary data (2.3)-(2.6). However, using techniques similar to the ones used in $[12,14]$ the analysis in this paper can be extended to non-homogeneous situations.

Assumption 2.2. We make the following assumptions on the data
(A1) $\kappa \in L_{\infty}\left(\Omega, \mathbb{R}^{d \times d}\right)$, symmetric,

Similarly, the constants $\lambda_{1}, \lambda_{2}, \alpha_{1}$, and $\alpha_{2}$ are used to denote the corresponding upper and lower bounds for $\lambda$ and $\alpha$.
(A3) $f, \dot{f} \in L_{\infty}\left(L_{2}\right), \ddot{f} \in L_{\infty}\left(H^{-1}\right), g \in L_{\infty}\left(L_{2}\right), \dot{g} \in L_{\infty}\left(H^{-1}\right)$, and $\theta_{0} \in V^{2}$.
To pose a variational form we multiply the equations (2.1) and (2.2) with test functions from $V^{1}$ and $V^{2}$ and using Green's formula together with the boundary conditions (2.3)-(2.6) we arrive at the following weak formulation [11]. Find $u(t, \cdot) \in V^{1}$ and $\theta(t, \cdot) \in V^{2}$, such that,

and the initial value $\theta(0, \cdot)=\theta_{0}$ is satisfied. Here we use $\sigma$ to denote the effective stress tensor $\sigma(u):=$ $2 \mu \varepsilon(u)+\lambda(\nabla \cdot u) I$ and : to denote the Frobenius inner product of matrices. Using Korn's (first) inequality we have the following bounds, see, e.g., $[7,8]$,

where $c_{\sigma}$ (resp. $C_{\sigma}$ ) depends on $\mu_{1}$ (resp. $\mu_{2}$ and $\lambda_{2}$ ). Similarly, there are constants $c_{\kappa}$ (resp. $C_{\kappa}$ ) depending on the bound $\kappa_{1}$ (resp. $\kappa_{2}$ ) such that

Furthermore, we use the following notation for the energy norms induced by the bilinear forms

Existence and uniqueness of a solution to (2.8) and (2.9) have been proved in [24, 27]. There are also some papers on the solution to contact problems, see $[2,25]$.

Theorem 2.3. Assume that (A1)-(A3) hold and that $\partial \Omega$ is sufficiently smooth. Then there exist $u$ and $\theta$ such that $u \in L_{2}\left(V^{1}\right), \nabla \cdot \dot{u} \in L_{2}\left(H^{-1}\right), \theta \in L_{2}\left(V^{2}\right)$, and $\dot{\theta} \in L_{2}\left(H^{-1}\right)$ satisfying (2.8) and (2.9) and the initial condition $\theta(0, \cdot)=\theta_{0}$.

Remark 2.4. We remark that the equations (2.1)-(2.7) also describe a poroelastic system and, hence, the method proposed in this paper also applies to problems in poroelasticity. In this case $\theta$ denotes the fluid pressure, $\kappa$ the permeability and viscosity of the fluid.

## 3. NumERICAL APPROXIMATION

In this section we first recall some properties of the classical finite element method for (2.8) and (2.9). In Section 3.2 we propose a new numerical method built on the ideas from [18]. The localization of this method is treated in Section 4.

### 3.1. Classical finite element

First, we need to define appropriate finite element spaces. For this purpose we let $\left\{\mathcal{T}_{h}\right\}_{h>0}$ be a family of shape regular triangulations of $\Omega$ with the mesh $\operatorname{size} h_{K}:=\operatorname{diam}(K)$, for $K \in \mathcal{T}_{h}$. Furthermore, we denote the largest diameter in the triangulation by $h:=\max _{K \in \mathcal{T}_{h}} h_{K}$. We now define the classical piecewise affine finite element spaces

and $V_{h}^{1}=S_{h}^{1} \cap V^{1}, V_{h}^{2}=S_{h}^{2} \cap V^{2}$.
For the discretization in time we consider, for simplicity, a uniform time step $\tau$ such that $t_{n}=n \tau$ for $n \in\{0,1, \ldots, N\}$ and $N \tau=T$. The classical finite element method with a backward Euler scheme in time reads; for $n \in\{1, \ldots, N\}$ find $u_{h}^{n} \in V_{h}^{1}$ and $\theta_{h}^{n} \in V_{h}^{2}$, such that

where $\bar{\partial}_{t} \theta_{h}^{n}:=\left(\theta_{h}^{n}-\theta_{h}^{n-1}\right) / \tau$ and similarly for $\bar{\partial}_{t} u_{h}^{n}$. The right hand sides are evaluated at time $t_{n}$, that is, $f^{n}:=f\left(t_{n}\right)$ and $g^{n}:=g\left(t_{n}\right)$. Given initial data $u_{h}^{0}$ and $\theta_{h}^{0}$ the system (3.1) and (3.2) is well posed [11]. We assume
that $\theta_{h}^{0} \in V_{h}^{1}$ is a suitable approximation of $\theta_{0}$. For $u_{h}^{0}$ we note that $u(0)$ is uniquely determined by (2.8) at $t=0$, that is, $u(0)$ fulfills the equation

The following theorem is a consequence of ([11], Thm. 3.1). The convergence rate is optimal for the two first norms. However, it is not optimal for the $L_{2}$-norm $\left\|\theta^{n}-\theta_{h}^{n}\right\|$. In [11] this is avoided by using second order continuous piecewise polynomials for the displacement ( $\mathrm{P} 2-\mathrm{P} 1$ elements). It is, however, noted that the problem is still stable using P1-P1 elements. In this paper we use P1-P1 elements and derive error bounds in the $L_{\infty}\left(H^{1}\right)$-norm, of optimal order, for both the displacement and the temperature.
Theorem 3.1. Let $u$ and $\theta$ be the solution to (2.8) and (2.9) and $\left\{u_{h}^{n}\right\}_{n=1}^{N}$ and $\left\{\theta_{h}^{n}\right\}_{n=1}^{N}$ be the solution to (3.1) and (3.2). For $n \in\{1, \ldots, N\}$ we have

where $C_{\epsilon^{-1}}$ is of order $\epsilon^{-1}$ if the material varies on a scale of size $\epsilon$.
Note that the constant $C_{\epsilon^{-1}}$ involved in this error bound contains derivatives of the coefficients. Hence, convergence only takes place when the mesh size $h$ is sufficiently small $(h<\epsilon)$. Throughout this paper, it is assumed that $h$ is small enough and $V_{h}^{1}$ and $V_{h}^{2}$ are referred to as reference spaces for the solution. Similarly, $u_{h}^{n}$ and $\theta_{h}^{n}$ are referred to as reference solutions. In Section 5 this solution is compared with the generalized finite element solution. We emphasize that the generalized finite element solution is computed in spaces of lower dimension and hence not as computationally expensive. It should also be noted that there, of course, is an initial cost of generating the generalized finite element space itself, but this space can be reused in each time step.

Remark 3.2. The classical linear elasticity equation can suffer from (Poisson) locking effects when using continuous piecewise linear polynomials (P1 elements) and $\nu$ is close to $1 / 2$. In [14], the GFEM that this paper is based on is applied to linear elasticity equations and it is shown that the Poisson locking effects is reduced. It is reasonable to believe that this property is transferred to the method presented here, but we shall, to simplify the analysis, refrain from investigating this. Instead we assume that the Lamé coefficients are of moderate size, such that the reference solution is a good approximation.

Furthermore, the coupled time-dependent problem can suffer from another type of locking, occurring if $\dot{\theta}$ is neglected in (2.2) and P1 elements are used in both spaces (P1-P1). The locking produces artificial oscillations in the numerical approximation of the temperature (or pressure) for early time steps. However, when $\dot{\theta}$ is not neglected, numerical observations indicate that this locking effect does not occur. See [21, 22] and references therein for a further discussion. Hence, we shall consider a P1-P1 discretization for the reference solution in this paper.

In the following theorem we prove some regularity results for the finite element solution.
Theorem 3.3. Let $\left\{u_{h}^{n}\right\}_{n=1}^{N}$ and $\left\{\theta_{h}^{n}\right\}_{n=1}^{N}$ be the solution to (3.1) and (3.2). Then the following bound holds

Proof. From (3.1) and (3.2) and the initial data (3.3) we deduce that the following relation must hold for $n \geq 1$

\left(\bar{\partial}_{t} \theta_{h}^{n}, v_{2}\right)+\left(\kappa \nabla \theta_{h}^{n}, \nabla v_{2}\right)+\left(\alpha \nabla \cdot \bar{\partial}_{t} u_{h}^{n}, v_{2}\right) & =\left(g^{n}, v_{2}\right), & & \forall v_{2} \in V_{h}^{2} \tag{3.8}
\end{align*}
$$

By choosing $v_{1}=\bar{\partial}_{t} u_{h}^{n}$ and $v_{2}=\bar{\partial}_{t} \theta_{h}^{n}$ and adding the resulting equations we have

\frac{c_{\sigma}}{2}\left\|\bar{\partial}_{t} u_{h}^{n}\right\|_{H^{1}}^{2}+\frac{1}{2}\left\|\bar{\partial}_{t} \theta_{h}^{n}\right\|^{2}+\left(\kappa \nabla \theta_{h}^{n}, \nabla \bar{\partial}_{t} \theta_{h}^{n}\right) \leq C\left(\left\|g^{n}\right\|^{2}+\left\|\bar{\partial}_{t} f^{n}\right\|_{H^{-1}}^{2}\right) \tag{3.9}
\end{equation*}

Note that the coupling terms cancel. By using Cauchy-Schwarz and Young's inequality we can bound

which is bounded by the right hand side in (3.4).
For the bound (3.5) we note that the following relation must hold for $n \geq 2$

\left(\bar{\partial}_{t}^{2} \theta_{h}^{n}, v_{2}\right)+\left(\kappa \nabla \bar{\partial}_{t} \theta_{h}^{n}, \nabla v_{2}\right)+\left(\alpha \nabla \cdot \bar{\partial}_{t}^{2} u_{h}^{n}, v_{2}\right) & =\left(\bar{\partial}_{t} g^{n}, v_{2}\right), & \forall v_{2} \in V_{h}^{2} \tag{3.11}
\end{align*}

Now choose $v_{1}=\bar{\partial}_{t}^{2} u_{h}^{n}$ and $v_{2}=\bar{\partial}_{t} \theta_{h}^{n}$ and add the resulting equations to get

$$

Multiplying by $\tau$ and using Cauchy-Schwarz and Young's inequality gives

$$

Summing over $n$ and using (2.10) now gives

$$

Here we use summation by parts to get

& \leq C\left(\max _{1 \leq j \leq n}\left\|\bar{\partial}_{t} f^{j}\right\|_{H^{-1}}+\sum_{j=2}^{n} \tau\left\|\bar{\partial}_{t}^{2} f^{j}\right\|_{H^{-1}}\right) \max _{1 \leq j \leq n}\left\|\bar{\partial}_{t} u_{h}^{j}\right\|_{H^{1}}
\end{aligned}

and $\max _{1 \leq j \leq n}\left\|\bar{\partial}_{t} u_{h}^{j}\right\|_{H^{1}}$ can now be kicked to the left hand side.
To estimate $\bar{\partial}_{t} \theta_{h}^{1}$ and $\bar{\partial}_{t} u_{h}^{1}$ we choose $v_{1}=\bar{\partial}_{t} u_{h}^{1}$ and $v_{2}=\bar{\partial}_{t} \theta_{h}^{1}$ in (3.7) and (3.8) for $n=1$. We thus have, since $\theta_{h}^{0}=0$,

Now assume $f=0$ and $g=0$ and note that the following holds for $n \geq 2$,

\end{aligned}
$$

Choosing $v_{1}=\bar{\partial}_{t}^{2} u_{h}^{n}, v_{2}=\bar{\partial}_{t}^{2} \theta_{h}^{n}$ and adding the resulting equations gives

where, again, the coupling terms cancel. The two first terms on the left hand side are positive and can thus be ignored. Multiplying by $\tau$ and $t_{n}^{2}$ gives after using Cauchy-Schwarz and Young's inequality

Note that $t_{n}^{2}-t_{n-1}^{2} \leq 3 \tau t_{n-1}$, where we use that $t_{n} \leq 2 t_{n-1}$ if $n \geq 2$. Summing over $n$ now gives

Multiplying by $\tau$ and $t_{n}$ gives after using Cauchy-Schwarz inequality

\frac{t_{n}}{2}\left\|\bar{\partial}_{t} u_{h}^{n}\right\|_{\sigma}^{2}+\frac{t_{n}}{2}\left\|\bar{\partial}_{t} \theta_{h}^{n}\right\|^{2}+c_{\kappa} \tau t_{n}\left\|\bar{\partial}_{t} \theta_{h}^{n}\right\|_{H^{1}}^{2} \leq \frac{t_{n-1}}{2}\left\|\bar{\partial}_{t} u_{h}^{n-1}\right\|_{\sigma}^{2}+\frac{t_{n-1}}{2}\left\|\bar{\partial}_{t} \theta_{h}^{n-1}\right\|^{2}+\frac{\tau}{2}\left\|\bar{\partial}_{t} u_{h}^{n-1}\right\|_{\sigma}^{2}+\frac{\tau}{2}\left\|\bar{\partial}_{t} \theta_{h}^{n-1}\right\|^{2} .
$$

Summing over $n$ and using (2.10) thus gives

& +C \sum_{j=2}^{n} \tau\left(\left\|\bar{\partial}_{t} u_{h}^{j-1}\right\|_{H^{1}}^{2}+\left\|\bar{\partial}_{t} \theta_{h}^{j-1}\right\|^{2}\right)
\end{aligned}
$$

To bound the last sum in this estimate we choose $v_{1}=\bar{\partial}_{t} u_{h}^{n}, v_{2}=\bar{\partial}_{t} \theta_{h}^{n}$ in (3.7)-(3.8) and multiply by $\tau$ to get

It remains to bound $t_{1}^{2}\left\|\bar{\partial}_{t} \theta_{h}^{1}\right\|_{H^{1}}^{2}, t_{1}\left\|\bar{\partial}_{t} \theta_{h}^{1}\right\|^{2}$, and $t_{1}\left\|\bar{\partial}_{t} u_{h}^{1}\right\|_{H^{1}}$. For this purpose we recall that $t_{1}=\tau$ and use (3.12) for $n=1$ to get

$$

Finally, we have that

and thus (3.6) follows.

### 3.2. Generalized finite element

In this section we shall derive a generalized finite element method. First we define $V_{H}^{1}$ and $V_{H}^{2}$ analogously to $V_{h}^{1}$ and $V_{h}^{2}$, but with a larger mesh size $H>h$. In addition, we assume that the family of triangulations $\left\{\mathcal{T}_{H}\right\}_{H>h}$ is quasi-uniform and that $\mathcal{T}_{h}$ is a refinement of $\mathcal{T}_{H}$ such that $V_{H}^{1} \subseteq V_{h}^{1}$ and $V_{H}^{2} \subseteq V_{h}^{2}$. Furthermore, we use the notation $\mathcal{N}=\mathcal{N}^{1} \times \mathcal{N}^{2}$ to denote the free nodes in $V_{H}^{1} \times V_{H}^{2}$. The aim is now to define a new (multiscale) space with the same dimension as $V_{H}^{1} \times V_{H}^{2}$, but with better approximation properties. For this purpose we define an interpolation operator $I_{H}=\left(I_{H}^{1}, I_{H}^{2}\right): V_{h}^{1} \times V_{h}^{2} \rightarrow V_{H}^{1} \times V_{H}^{2}$ with the property that $I_{H} \circ I_{H}=I_{H}$ and for all $v=\left(v_{1}, v_{2}\right) \in V_{h}^{1} \times V_{h}^{2}$

$$
\begin{equation*}
H_{K}^{-1}\left\|v-I_{H} v\right\|_{L_{2}(K)}+\left\|\nabla I_{H} v\right\|_{L_{2}(K)} \leq C_{I}\|\nabla v\|_{L_{2}\left(\omega_{K}\right)}, \quad \forall K \in \mathcal{T}_{H} \tag{3.13}
\end{equation*}
$$

where

$$
\omega_{K}:=\operatorname{int}\left\{\hat{K} \in \mathcal{T}_{H}: \hat{K} \cap K \neq \emptyset\right\}
$$

Note that $I_{H}^{1}$ is vector-valued. Since the mesh is assumed to be shape regular, the estimates in (3.13) are also global, i.e.,

where $C$ is a constant depending on the shape regularity parameter, $\gamma>0$;

\gamma:=\max _{K \in \mathcal{T}_{H}} \gamma_{K}, \text { with } \gamma_{K}:=\frac{\operatorname{diam} B_{K}}{\operatorname{diam} K}, \text { for } K \in \mathcal{T}_{H} \tag{3.15}
\end{equation*}
$$

where $B_{K}$ is the largest ball contained in $K$.
One example of an interpolation that satisfies the above assumptions is $I_{H}^{i}=E_{H}^{i} \circ \Pi_{H}^{i}, i=1,2$. Here $\Pi_{H}^{i}$ denotes the piecewise $L_{2}$-projection onto $P_{1}\left(\mathcal{T}_{H}\right)\left(\left(P_{1}\left(\mathcal{T}_{H}\right)\right)^{d}\right.$ if $\left.i=1\right)$, the space of functions that are affine on each triangle $K \in \mathcal{T}_{H}$. Furthermore, $E_{H}^{1}$ is an averaging operator mapping $\left(P_{1}\left(\mathcal{T}_{H}\right)\right)^{d}$ into $V_{H}^{1}$, by (coordinate wise)

\left(E_{H}^{1, j}(v)\right)(z)=\left.\frac{1}{\operatorname{card}\left\{K \in \mathcal{T}_{H}: z \in K\right\}} \sum_{K \in \mathcal{T}_{H}: z \in K} v_{j}\right|_{K}(z), \quad 1 \leq j \leq d
$$

where $z \in \mathcal{N}^{1} . E_{H}^{2}$ mapping $P_{1}\left(\mathcal{T}_{H}\right)$ to $V_{H}^{2}$ is defined similarly. For a further discussion on this interpolation and other available options we refer to [20].

Let us now define the kernels of $I_{H}^{1}$ and $I_{H}^{2}$

V_{\mathrm{f}}^{1}:=\left\{v \in V_{h}^{1}: I_{H}^{1} v=0\right\}, \quad V_{\mathrm{f}}^{2}:=\left\{v \in V_{h}^{2}: I_{H}^{2} v=0\right\}
$$

The kernels are fine scale spaces in the sense that they contain all features that are not captured by the (coarse) finite element spaces $V_{H}^{1}$ and $V_{H}^{2}$. Note that the interpolation leads to the splits $V_{h}^{1}=V_{H}^{1} \oplus V_{\mathrm{f}}^{1}$ and $V_{h}^{2}=V_{H}^{2} \oplus V_{\mathrm{f}}^{2}$, meaning that any function $v_{1} \in V_{h}^{1}$ can be uniquely decomposed as $v_{1}=v_{1, H}+v_{1, \mathrm{f}}$, with $v_{1, H} \in V_{H}^{1}$ and $v_{1, \mathrm{f}} \in V_{\mathrm{f}}^{1}$, and similarly for $v_{2} \in V_{h}^{2}$.

Now, we introduce a Ritz projection onto the fine scale spaces. For this we use the bilinear forms associated with the diffusion in (2.8) and (2.9). The projection of interest is thus $R_{\mathrm{f}}: V_{h}^{1} \times V_{h}^{2} \rightarrow V_{\mathrm{f}}^{1} \times V_{\mathrm{f}}^{2}$, such that for all $\left(v_{1}, v_{2}\right) \in V_{h}^{1} \times V_{h}^{2}, R_{\mathrm{f}}\left(v_{1}, v_{2}\right)=\left(R_{\mathrm{f}}^{1} v_{1}, R_{\mathrm{f}}^{2} v_{2}\right)$ fulfills

\begin{array}{ll}
\left(\sigma\left(v_{1}-R_{\mathrm{f}}^{1} v_{1}\right): \varepsilon\left(w_{1}\right)\right)=0, & \forall w_{1} \in V_{\mathrm{f}}^{1} \\
\left(\kappa \nabla\left(v_{2}-R_{\mathrm{f}}^{2} v_{2}\right), \nabla w_{2}\right)=0, & \forall w_{2} \in V_{\mathrm{f}}^{2} \tag{3.17}
\end{array}
$$

Note that this is an uncoupled system and $R_{\mathrm{f}}^{1}$ and $R_{\mathrm{f}}^{2}$ are classical Ritz projections.
For any $\left(v_{1}, v_{2}\right) \in V_{h}^{1} \times V_{h}^{2}$ we have, due to the splits of the spaces $V_{h}^{1}$ and $V_{h}^{2}$ above, that

V_{\mathrm{ms}}^{1}:=\left\{v-R_{\mathrm{f}}^{1} v: v \in V_{H}^{1}\right\}, \quad V_{\mathrm{ms}}^{2}:=\left\{v-R_{\mathrm{f}}^{2} v: v \in V_{H}^{2}\right\} \tag{3.18}
\end{equation*}
$$

Clearly $V_{\mathrm{ms}}^{1} \times V_{\mathrm{ms}}^{2}$ has the same dimension as $V_{H}^{1} \times V_{H}^{2}$. Indeed, with $\lambda_{x}^{1, i}$ denoting a basis function in $V_{H}^{1}$ with a hat function at the $i$ th position at node $x, 1 \leq i \leq d$, and $\lambda_{y}^{2}$ the hat function in $V_{H}^{2}$ at node $y$, such that

V_{H}^{1} \times V_{H}^{2}=\operatorname{span}\left\{\left(\lambda_{x}^{1, i}, 0\right),\left(0, \lambda_{y}^{2}\right): 1 \leq i \leq d,(x, y) \in \mathcal{N}\right\}
$$

a basis for $V_{\mathrm{ms}}^{1} \times V_{\mathrm{ms}}^{2}$ is given by:

$$
\begin{equation*}
\left\{\left(\lambda_{x}^{1, i}-R_{\mathrm{f}}^{1} \lambda_{x}^{1, i}, 0\right),\left(0, \lambda_{y}^{2}-R_{\mathrm{f}}^{2} \lambda_{y}^{2}\right): 1 \leq i \leq d,(x, y) \in \mathcal{N}\right\} \tag{3.19}
\end{equation*}
$$

Finally, we also note that the splits $V_{h}^{1}=V_{\mathrm{ms}}^{1} \oplus V_{\mathrm{f}}^{1}$ and $V_{h}^{2}=V_{\mathrm{ms}}^{2} \oplus V_{\mathrm{f}}^{2}$ hold, which fulfill the following orthogonality relations

\begin{align*}
\left(\sigma\left(v_{1}\right): \varepsilon\left(w_{1}\right)\right) & =0, \tag{3.20}
\end{align*} \quad \forall v_{1} \in V_{\mathrm{ms}}^{1}, w_{1} \in V_{\mathrm{f}}^{1}, ~ 子 \quad, ~\left(\kappa \nabla v_{2}, \nabla w_{2}\right)=0, \quad \forall v_{2} \in V_{\mathrm{ms}}^{2}, w_{2} \in V_{\mathrm{f}}^{2} .
$$

### 3.2.1. Stationary problem

For the error analysis in Section 5 it is convenient to define the Ritz projection onto the multiscale space using the bilinear form given by the stationary version of (2.8) and (2.9). We thus define $R_{\mathrm{ms}}: V_{h}^{1} \times V_{h}^{2} \rightarrow V_{\mathrm{ms}}^{1} \times V_{\mathrm{ms}}^{2}$, such that for all $\left(v_{1}, v_{2}\right) \in V_{h}^{1} \times V_{h}^{2}, R_{\mathrm{ms}}\left(v_{1}, v_{2}\right)=\left(R_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right), R_{\mathrm{ms}}^{2} v_{2}\right)$ fulfills

$$
\begin{align*}
\left(\sigma\left(v_{1}-R_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)\right): \varepsilon\left(w_{1}\right)\right)- & \left(\alpha\left(v_{2}-R_{\mathrm{ms}}^{2} v_{2}\right), \nabla \cdot w_{1}\right)=0, \quad \forall w_{1} \in V_{\mathrm{ms}}^{1}  \tag{3.22}\\
& \left(\kappa \nabla\left(v_{2}-R_{\mathrm{ms}}^{2} v_{2}\right), \nabla w_{2}\right)=0, \quad \forall w_{2} \in V_{\mathrm{ms}}^{2} \tag{3.23}
\end{align*}
$$

Note that we must have $R_{\mathrm{ms}}^{2}=I-R_{\mathrm{f}}^{2}$, but $R_{\mathrm{ms}}^{1} \neq I-R_{\mathrm{f}}^{1}$ in general.
The Ritz projection in (3.22) and (3.23) is upper triangular. Hence, when solving for $R_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)$ the term $\left(\alpha R_{\mathrm{ms}}^{2} v_{2}, \nabla \cdot w_{1}\right)$ in (3.22) is known. Since this term has multiscale features and appears on the right hand side,
we impose a correction on $R_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)$ inspired by the ideas in [12] and [16]. The correction is defined as the element $\tilde{R}_{\mathrm{f}} v_{2} \in V_{\mathrm{f}}^{1}$, which fulfills

$$
\begin{equation*}
\left(\sigma\left(\tilde{R}_{\mathrm{f}} v_{2}\right): \varepsilon\left(w_{1}\right)\right)=\left(\alpha R_{\mathrm{ms}}^{2} v_{2}, \nabla \cdot w_{1}\right), \quad \forall w_{1} \in V_{\mathrm{f}}^{1} \tag{3.24}
\end{equation*}
$$

and we define $\tilde{R}_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)=R_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)+\tilde{R}_{\mathrm{f}} v_{2}$.
Note that the Ritz projections are stable in the sense that

\left\|\tilde{R}_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)\right\|_{H^{1}} \leq C\left(\left\|v_{1}\right\|_{H^{1}}+\left\|v_{2}\right\|_{H^{1}}\right), \quad\left\|R_{\mathrm{ms}}^{2} v_{2}\right\|_{H^{1}} \leq C\left\|v_{2}\right\|_{H^{1}} \tag{3.25}
\end{equation*}
$$

Remark 3.4. The problem to find $\tilde{R}_{\mathrm{f}} v_{2}$ is posed in the entire fine scale space and is thus computationally expensive to solve. The aim is to localize these computations to smaller patches of coarse elements, see Section 4.

To derive error bounds for this projection we define two operators $\mathcal{A}_{1}: V_{h}^{1} \times V_{h}^{2} \rightarrow V_{h}^{1}$ and $\mathcal{A}_{2}: V_{h}^{2} \rightarrow V_{h}^{2}$ such that for all $\left(v_{1}, v_{2}\right) \in V_{h}^{1} \times V_{h}^{2}$ we have

\left(\mathcal{A}_{1}\left(v_{1}, v_{2}\right), w_{1}\right) & =\left(\sigma\left(v_{1}\right): \varepsilon\left(w_{1}\right)\right)-\left(\alpha v_{2}, \nabla \cdot w_{1}\right), \quad \forall w_{1} \in V_{h}^{1}  \tag{3.26}\\
\left(\mathcal{A}_{2} v_{2}, w_{2}\right) & =\left(\kappa \nabla v_{2}, \nabla w_{2}\right), \quad \forall w_{2} \in V_{h}^{2} \tag{3.27}
\end{align*}
$$

Lemma 3.5. For all $\left(v_{1}, v_{2}\right) \in V_{h}^{1} \times V_{h}^{2}$ it holds that

$$
\begin{align*}
\left\|v_{1}-\tilde{R}_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)\right\|_{H^{1}} & \leq C\left(H\left\|\mathcal{A}_{1}\left(v_{1}, v_{2}\right)\right\|+\left\|v_{2}-R_{\mathrm{ms}}^{2} v_{2}\right\|\right)  \tag{3.28}\\
& \leq C H\left(\left\|\mathcal{A}_{1}\left(v_{1}, v_{2}\right)\right\|+\left\|v_{2}\right\|_{H^{1}}\right) \\
\left\|v_{2}-R_{\mathrm{ms}}^{2} v_{2}\right\|_{H^{1}} & \leq C H\left\|\mathcal{A}_{2} v_{2}\right\| \tag{3.29}
\end{align*}
$$

Proof. It follows from [18] that (3.29) holds, since (3.23) is an elliptic equation of Poisson type. Using an Aubin-Nitsche duality argument as in, e.g., [17], we can derive the following estimate in the $L_{2}$-norm

which proves the second inequality in (3.28).
It remains to bound $\left\|v_{1}-\tilde{R}_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)\right\|_{H^{1}}$. Recall that any $v \in V_{h}^{1}$ can be decomposed as

v=v-R_{\mathrm{f}}^{1} v+R_{\mathrm{f}}^{1} v=\left(I-R_{\mathrm{f}}^{1}\right) v+R_{\mathrm{f}}^{1} v
$$

where $\left(I-R_{\mathrm{f}}^{1}\right) v \in V_{\mathrm{ms}}^{1}$. Using the orthogonality (3.20) and that $(\sigma(\cdot): \varepsilon(\cdot))$ is a symmetric bilinear form we get

\left(\sigma\left(\tilde{R}_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)\right): \varepsilon(v)\right) & =\left(\sigma\left(R_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)+\tilde{R}_{\mathrm{f}} v_{2}\right): \varepsilon\left(\left(I-R_{\mathrm{f}}^{1}\right) v+R_{\mathrm{f}}^{1} v\right)\right) \\
& =\left(\sigma\left(R_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)\right): \varepsilon\left(\left(I-R_{\mathrm{f}}^{1}\right) v\right)\right)+\left(\sigma\left(\tilde{R}_{\mathrm{f}} v_{2}\right): \varepsilon\left(R_{\mathrm{f}}^{1} v\right)\right)
\end{aligned}
$$

Due to (3.22) and (3.24) we thus have

$$
\begin{aligned}
& \left(\sigma\left(R_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)\right): \varepsilon\left(\left(I-R_{\mathrm{f}}^{1}\right) v\right)\right)+\left(\sigma\left(\tilde{R}_{\mathrm{f}} v_{2}\right): \varepsilon\left(R_{\mathrm{f}}^{1} v\right)\right) \\
& =\left(\sigma\left(v_{1}\right): \varepsilon\left(\left(I-R_{\mathrm{f}}^{1}\right) v\right)\right)-\left(\alpha\left(v_{2}-R_{\mathrm{ms}}^{2} v_{2}\right), \nabla \cdot\left(I-R_{\mathrm{f}}^{1}\right) v\right)+\left(\alpha R_{\mathrm{ms}}^{2} v_{2}, \nabla \cdot R_{\mathrm{f}}^{1} v\right) \\
& \quad=\left(\mathcal{A}_{1}\left(v_{1}, v_{2}\right),\left(I-R_{\mathrm{f}}^{1}\right) v\right)+\left(\alpha R_{\mathrm{ms}}^{2} v_{2}, \nabla \cdot v\right)
\end{aligned}
$$

Define $e:=v_{1}-\tilde{R}_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)$. Using the above relation together with (3.26) we get the bound

$$
\begin{aligned}
c_{\sigma}\|e\|_{H^{1}}^{2} & \leq(\sigma(e): \varepsilon(e))=\left(\sigma\left(v_{1}\right): \varepsilon(e)\right)-\left(\mathcal{A}_{1}\left(v_{1}, v_{2}\right),\left(I-R_{\mathrm{f}}^{1}\right) e\right)-\left(\alpha R_{\mathrm{ms}}^{2} v_{2}, \nabla \cdot e\right) \\
& =\left(\mathcal{A}_{1}\left(v_{1}, v_{2}\right), R_{\mathrm{f}}^{1} e\right)+\left(\alpha\left(v_{2}-R_{\mathrm{ms}}^{2} v_{2}\right), \nabla \cdot e\right) \\
& \leq\left\|\mathcal{A}_{1}\left(v_{1}, v_{2}\right)\right\|\left\|R_{\mathrm{f}}^{1} e\right\|+C\left\|v_{2}-R_{\mathrm{ms}}^{2} v_{2}\right\|\|e\|_{H^{1}}
\end{aligned}
$$

Since $R_{\mathrm{f}}^{1} e \in V_{\mathrm{f}}^{1}$ we have due to (3.13)

$$
\left\|R_{\mathrm{f}}^{1} e\right\|=\left\|R_{\mathrm{f}}^{1} e-I_{H}^{1} R_{\mathrm{f}}^{1} e\right\| \leq C H\left\|R_{\mathrm{f}}^{1} e\right\|_{H^{1}} \leq C H\|e\|_{H^{1}}
$$

where we have used the stability $\left\|R_{\mathrm{f}}^{1} v\right\|_{H^{1}} \leq C\|v\|_{H^{1}}$ for $v \in V_{h}^{1}$. The first inequality in (3.28) now follows.

Remark 3.6. Without the correction $\tilde{R}_{\mathrm{f}}$ the error bound (3.28) would depend on the derivatives of $\alpha$,

$$
\left\|v_{1}-R_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)\right\|_{H^{1}} \leq C_{\alpha^{\prime}}\left(H\left\|\mathcal{A}_{1}\left(v_{1}, v_{2}\right)\right\|+\left\|v_{2}-R_{\mathrm{ms}}^{2} v_{2}\right\|\right),
$$

where $\alpha^{\prime}$ is large if $\alpha$ has multiscale features.

### 3.2.2. Time-dependent problem

A generalized finite element method with a backward Euler discretization in time is now defined by replacing $V_{h}^{1}$ with $V_{\mathrm{ms}}^{1}$ and $V_{h}^{2}$ with $V_{\mathrm{ms}}^{2}$ in (3.1) and (3.2) and adding a correction similar to (3.24). The method thus reads; for $n \in\{1, \ldots, N\}$ find $\tilde{u}_{\mathrm{ms}}^{n}=u_{\mathrm{ms}}^{n}+u_{\mathrm{f}}^{n}$, with $u_{\mathrm{ms}}^{n} \in V_{\mathrm{ms}}^{1}, u_{\mathrm{f}}^{n} \in V_{\mathrm{f}}^{1}$, and $\theta_{\mathrm{ms}}^{n} \in V_{\mathrm{ms}}^{2}$, such that

$$
\begin{align*}
\left(\sigma\left(\tilde{u}_{\mathrm{ms}}^{n}\right): \varepsilon\left(v_{1}\right)\right)-\left(\alpha \theta_{\mathrm{ms}}^{n}, \nabla \cdot v_{1}\right) & =\left(f^{n}, v_{1}\right), & & \forall v_{1} \in V_{\mathrm{ms}}^{1},  \tag{3.30}\\
\left(\bar{\partial}_{t} \theta_{\mathrm{ms}}^{n}, v_{2}\right)+\left(\kappa \nabla \theta_{\mathrm{ms}}^{n}, \nabla v_{2}\right)+\left(\alpha \nabla \cdot \bar{\partial}_{t} \tilde{u}_{\mathrm{ms}}^{n}, v_{2}\right) & =\left(g^{n}, v_{2}\right), & & \forall v_{2} \in V_{\mathrm{ms}}^{2},  \tag{3.31}\\
\left(\sigma\left(u_{\mathrm{f}}^{n}\right): \varepsilon\left(w_{1}\right)\right)-\left(\alpha \theta_{\mathrm{ms}}^{n}, \nabla \cdot w_{1}\right) & =0, & & \forall w_{1} \in V_{\mathrm{f}}^{1} . \tag{3.32}
\end{align*}
$$

where $\theta_{\mathrm{ms}}^{0}=R_{\mathrm{ms}}^{2} \theta_{h}^{0}$. Furthermore, we define $\tilde{u}_{\mathrm{ms}}^{0}:=u_{\mathrm{ms}}^{0}+u_{\mathrm{f}}^{0}$, where $u_{\mathrm{f}}^{0} \in V_{\mathrm{f}}^{1}$ is defined by (3.32) for $n=0$ and $u_{\mathrm{ms}}^{0} \in V_{\mathrm{ms}}^{1}$, such that

$$
\begin{equation*}
\left(\sigma\left(\tilde{u}_{\mathrm{ms}}^{0}\right): \varepsilon\left(v_{1}\right)\right)-\left(\alpha \theta_{\mathrm{ms}}^{0}, \nabla \cdot v_{1}\right)=\left(f^{0}, v_{1}\right), \quad \forall v_{1} \in V_{\mathrm{ms}}^{1} . \tag{3.33}
\end{equation*}
$$

Lemma 3.7. The problem (3.30) and (3.31) is well-posed.
Proof. Given $u_{\mathrm{ms}}^{n-1}, \theta_{\mathrm{ms}}^{n-1}$, and $u_{\mathrm{f}}^{n-1}$, equations (3.30)-(3.32) yields a square system. Hence, it is sufficient to prove that the solution is unique. Let $v_{1}=u_{\mathrm{ms}}^{n}-u_{\mathrm{ms}}^{n-1}$ in (3.30) and $v_{2}=\tau \theta_{\mathrm{ms}}^{n}$ in (3.31) and add the resulting equations to get

\left(\sigma\left(u_{\mathrm{ms}}^{n}\right): \varepsilon\left(u_{\mathrm{ms}}^{n}-u_{\mathrm{ms}}^{n-1}\right)\right)+\left(\sigma\left(u_{\mathrm{f}}^{n}\right): \varepsilon\left(u_{\mathrm{ms}}^{n}-u_{\mathrm{ms}}^{n-1}\right)\right)+\tau\left(\bar{\partial}_{t} \theta_{\mathrm{ms}}^{n}, \theta_{\mathrm{ms}}^{n}\right) & +c_{\kappa} \tau\left\|\theta_{\mathrm{ms}}^{n}\right\|_{H^{1}}^{2}+\left(\alpha \nabla \cdot\left(u_{\mathrm{f}}^{n}-u_{\mathrm{f}}^{n-1}\right), \theta_{\mathrm{ms}}^{n}\right) \\
& \leq\left(f^{n}, u_{\mathrm{ms}}^{n}-u_{\mathrm{ms}}^{n-1}\right)+\tau\left(g^{n}, \theta_{\mathrm{ms}}^{n}\right) .
\end{aligned}
$$

Using the orthogonality (3.20) and (3.32) this simplifies to

$$
\begin{aligned}
\left(\sigma\left(u_{\mathrm{ms}}^{n}\right): \varepsilon\left(u_{\mathrm{ms}}^{n}-u_{\mathrm{ms}}^{n-1}\right)\right)+\tau\left(\bar{\partial}_{t} \theta_{\mathrm{ms}}^{n}, \theta_{\mathrm{ms}}^{n}\right) & +c_{\kappa} \tau\left\|\theta_{\mathrm{ms}}^{n}\right\|_{H^{1}}^{2}+c_{\sigma}\left\|u_{\mathrm{f}}^{n}\right\|_{H^{1}}^{2} \\
& \leq\left(f^{n}, u_{\mathrm{ms}}^{n}-u_{\mathrm{ms}}^{n-1}\right)+\tau\left(g^{n}, \theta_{\mathrm{ms}}^{n}\right)+\left(\sigma\left(u_{\mathrm{f}}^{n}\right): \varepsilon\left(u_{\mathrm{f}}^{n-1}\right)\right) .
\end{aligned}
$$

Now, using that $(\sigma(\cdot): \varepsilon(\cdot))$ is a symmetric bilinear form we get the following identity

$$
\begin{equation*}
(\sigma(v): \varepsilon(v-w))=\frac{1}{2}(\sigma(v): \varepsilon(v))+\frac{1}{2}(\sigma(v-w): \varepsilon(v-w))-\frac{1}{2}(\sigma(w): \varepsilon(w)) \tag{3.34}
\end{equation*}
$$

and using Cauchy-Schwarz and Young's inequality we derive

$$
\left(f^{n}, u_{\mathrm{ms}}^{n}-u_{\mathrm{ms}}^{n-1}\right) \leq C\left\|f^{n}\right\|_{H^{-1}}+\frac{1}{2}\left(\sigma\left(u_{\mathrm{ms}}^{n}-u_{\mathrm{ms}}^{n-1}\right): \varepsilon\left(u_{\mathrm{ms}}^{n}-u_{\mathrm{ms}}^{n-1}\right)\right) .
$$

This, together with the estimate $\tau\left(\bar{\partial}_{t} \theta_{\mathrm{ms}}^{n}, \theta_{\mathrm{ms}}^{n}\right) \geq \frac{1}{2}\left\|\theta_{\mathrm{ms}}^{n}\right\|^{2}-\frac{1}{2}\left\|\theta_{\mathrm{ms}}^{n-1}\right\|^{2}$ and (2.10), leads to

\frac{c_{\sigma}}{2}\left\|u_{\mathrm{ms}}^{n}\right\|_{H^{1}}^{2}+\frac{1}{4}\left\|\theta_{\mathrm{ms}}^{n}\right\|^{2} & +c_{\kappa} \tau\left\|\theta_{\mathrm{ms}}^{n}\right\|_{H^{1}}^{2}+\frac{c_{\sigma}}{2}\left\|u_{\mathrm{f}}^{n}\right\|_{H^{1}}^{2} \\
& \leq C\left(\left\|f^{n}\right\|_{H^{-1}}^{2}+\tau\left\|g^{n}\right\|^{2}+\left\|\theta_{\mathrm{ms}}^{n-1}\right\|^{2}+\left\|u_{\mathrm{ms}}^{n-1}\right\|_{H^{1}}^{2}+\left\|u_{\mathrm{f}}^{n-1}\right\|_{H^{1}}^{2}\right)
\end{aligned}
$$

Hence, a unique solution exists.

## 4. LOCALIZATION

In this section we show how to truncate the basis functions, which is motivated by the exponential decay of (3.19). We consider a localization inspired by the one proposed in [12], which is performed by restricting the fine scale space to patches of coarse elements defined by the following; for $K \in \mathcal{T}_{H}$

\begin{aligned}
& \omega_{0}(K):=\operatorname{int} K \\
& \omega_{k}(K):=\operatorname{int}\left(\cup\left\{\hat{K} \in \mathcal{T}_{H}: \hat{K} \cap \overline{\omega_{k-1}(K)} \neq \emptyset\right\}\right), \quad k=1,2, \ldots
\end{aligned}
$$

Now let $V_{\mathrm{f}}^{1}\left(\omega_{k}(K)\right):=\left\{v \in V_{\mathrm{f}}^{1}: v(z)=0\right.$ on $\left.\left(\bar{\Omega} \backslash \Gamma_{N}^{u}\right) \backslash \omega_{k}(K)\right\}$ be the restriction of $V_{\mathrm{f}}^{1}$ to the patch $\omega_{k}(T)$. We define $V_{\mathrm{f}}^{2}\left(\omega_{k}(K)\right)$ similarly.

The localized fine scale space can now be used to approximate the fine scale part of the basis functions in (3.19), which significantly reduces the computational cost for these problems. Let $(\cdot, \cdot)_{\omega}$ denote the $L_{2}$ inner product over a subdomain $\omega \subseteq \Omega$ and define the local Ritz projection $R_{\mathrm{f}, k}^{K}: V_{h}^{1} \times V_{h}^{2} \rightarrow V_{\mathrm{f}}^{1}\left(\omega_{k}(K)\right) \times V_{\mathrm{f}}^{2}\left(\omega_{k}(K)\right)$ such that for all $\left(v_{1}, v_{2}\right) \in V_{h}^{1} \times V_{h}^{2}, R_{\mathrm{f}, k}^{K}\left(v_{1}, v_{2}\right)=\left(R_{\mathrm{f}, k}^{K, 1} v_{1}, R_{\mathrm{f}, k}^{K, 2} v_{1}\right)$ fulfills

$$
\begin{array}{ll}

\left(\kappa \nabla\left(R_{\mathrm{f}, k}^{K, 2} v_{2}\right), \nabla w_{2}\right)_{\omega_{k}(K)}=\left(\kappa \nabla v_{2}, \nabla w_{2}\right)_{K}, & \forall w_{2} \in V_{\mathrm{f}}^{2}\left(\omega_{k}(K)\right) \tag{4.2}
\end{array}

Note that if we replace $\omega_{k}(K)$ with $\Omega$ in (4.1) and (4.2) and denote the resulting projection

### 4.1. Stationary problem

In this section we define a localized version of the stationary problem (3.22) and (3.23). Let $R_{\mathrm{ms}, k}: V_{h}^{1} \times V_{h}^{2} \rightarrow$ $V_{\mathrm{ms}, k}^{1} \times V_{\mathrm{ms}, k}^{2}$, such that for all $\left(v_{1}, v_{2}\right) \in V_{h}^{1} \times V_{h}^{2}, R_{\mathrm{ms}, k}\left(v_{1}, v_{2}\right)=\left(R_{\mathrm{ms}, k}^{1}\left(v_{1}, v_{2}\right), R_{\mathrm{ms}, k}^{2} v_{2}\right)$. The method now reads; find

Note that the Ritz projection is stable in the sense that

& \left\|\tilde{R}_{\mathrm{f}, k} v_{2}-\tilde{R}_{\mathrm{f}} v_{2}\right\|_{H^{1}}^{2} \leq C k^{d} \xi^{2 k} \sum_{K \in \mathcal{T}_{H}}\left\|\tilde{R}_{\mathrm{f}}^{K} v_{2}\right\|_{H^{1}}^{2} . \tag{4.12}

The bounds (4.10) and (4.11) are direct results from [14] and [12,18] respectively, while (4.12) follows from [14] by a slight modification of the right hand side. We omit the proof here.

The next lemma gives a bound for the localized Ritz projection.
Lemma 4.2. For all $\left(v_{1}, v_{2}\right) \in V_{h}^{1} \times V_{h}^{2}$ there exist $\xi \in(0,1)$ such that

& +\left(\alpha\left(v_{2}-R_{\mathrm{ms}, k}^{2} v_{2}\right), \nabla \cdot e\right) .
\end{aligned}
$$

Now, using Cauchy-Schwarz and Young's inequality we get

& \leq\left\|v_{1}-\tilde{R}_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)\right\|_{H^{1}}+\left\|R_{\mathrm{f}}^{1} v_{H}-R_{\mathrm{f}, k}^{1} v_{H}\right\|_{H^{1}}+\left\|\tilde{R}_{\mathrm{f}} v_{2}-\tilde{R}_{\mathrm{f}, k} v_{2}\right\|_{H^{1}}
\end{aligned}

where the first term on the right hand side is bounded in Lemma 3.5. For the second term we use Lemma 4.1 to get

& =C k^{d} \xi^{2 k}\left\|I_{H} R_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)\right\|_{H^{1}}^{2} \leq C k^{d} \xi^{2 k}\left\|R_{\mathrm{ms}}^{1}\left(v_{1}, v_{2}\right)\right\|_{H^{1}}^{2}
\end{aligned}

We can bound this further by using (3.25) and (3.26), such that

Remark 4.3. To preserve linear convergence, the localization parameter $k$ should be chosen such that $k=$ $c \log \left(H^{-1}\right)$ for some constant $c$. With this choice of $k$ we get $k^{d / 2} \xi^{k} \sim H$ and we get linear convergence in Lemma 4.2.

Remark 4.4. It is possible to consider different patch sizes $k_{u}, k_{\theta}$, and $k_{\mathrm{f}}$ in (4.1), (4.2), and (4.8), corresponding to the displacement $u$, the temperature $\theta$, and the additional correction, respectively. This would give us three different values of $\xi$, say $\xi_{u}, \xi_{\theta}$, and $\xi_{\mathrm{f}}$, in Lemma 4.1. To achieve linear convergence, the patch sizes should be chosen such that $k_{u}^{d / 2} \xi_{u}^{k_{u}}, k_{\theta}^{d / 2} \xi_{\theta}^{k_{\theta}}, k_{\mathrm{f}}^{d / 2} \xi_{\mathrm{f}}^{k_{\mathrm{f}}} \sim H$, see Remark 4.3. This may be advantageous if one equation requires significantly larger patches. However, we shall, for simplicity, consider the same patch size $k$ in all instances.

We note that the orthogonality relation (3.20) does not hold when $V_{\mathrm{ms}}^{1}$ is replaced by $V_{\mathrm{ms}, k}^{1}$. However, we have that $V_{\mathrm{ms}, k}^{1}$ and $V_{\mathrm{f}}^{1}$ are almost orthogonal in the sense that

\end{aligned}
$$

where we have used that $v_{H, k}-R_{\mathrm{f}}^{1} v_{H, k} \in V_{\mathrm{ms}}^{1}$ and the orthogonality (3.20). Due to Lemma 4.1 we now have

& =C k^{d} \xi^{2 k}\left\|v_{H, k}\right\|_{H^{1}}^{2}=C k^{d} \xi^{2 k}\left\|I_{H}\left(v_{H, k}-R_{\mathrm{f}, k}^{1} v_{H, k}\right)\right\|_{H^{1}}^{2} \\
& =C k^{d} \xi^{2 k}\left\|I_{H} v\right\|_{H^{1}}^{2} \leq C k^{d} \xi^{2 k}\|v\|_{H^{1}}^{2}
\end{aligned}
$$

and (4.15) follows.

### 4.2. Time-dependent problem

A localized version of (3.30)-(3.32) is now defined by replacing $V_{\mathrm{ms}}^{1}$ with $V_{\mathrm{ms}, k}^{1}$ and $V_{\mathrm{ms}}^{2}$ with $V_{\mathrm{ms}, k}^{2}$. The method thus reads; for $n \in\{1, \ldots, N\}$ find

\left(\sigma\left(\tilde{u}_{\mathrm{ms}, k}^{n}\right): \varepsilon\left(v_{1}\right)\right)-\left(\alpha \theta_{\mathrm{ms}, k}^{n}, \nabla \cdot v_{1}\right) & =\left(f^{n}, v_{1}\right), & & \forall v_{1} \in V_{\mathrm{ms}, k}^{1}  \tag{4.16}\\
\left(\bar{\partial}_{t} \theta_{\mathrm{ms}, k}^{n}, v_{2}\right)+\left(\kappa \nabla \theta_{\mathrm{ms}, k}^{n}, \nabla v_{2}\right)+\left(\alpha \nabla \cdot \bar{\partial}_{t} \tilde{u}_{\mathrm{ms}, k}^{n}, v_{2}\right) & =\left(g^{n}, v_{2}\right), & & \forall v_{2} \in V_{\mathrm{ms}, k}^{2}  \tag{4.17}\\
\left(\sigma\left(u_{\mathrm{f}, k}^{n, K}\right): \varepsilon\left(w_{1}\right)\right)-\left(\alpha \theta_{\mathrm{ms}, k}^{n}, \nabla \cdot w_{1}\right)_{K} & =0, & & \forall w_{1} \in V_{\mathrm{f}}^{1}\left(\omega_{k}(K)\right) \tag{4.18}
\end{align*}
$$

where $\theta_{\mathrm{ms}, k}^{0}=R_{\mathrm{ms}, k}^{2} \theta_{h}^{0}$. Furthermore, we define $\tilde{u}_{\mathrm{ms}, k}^{0}=u_{\mathrm{ms}, k}^{0}+\sum_{K \in \mathcal{T}_{H}} u_{\mathrm{f}, k}^{0, K}$, where $u_{\mathrm{f}, k}^{0, K} \in V_{\mathrm{f}}^{1}\left(\omega_{k}(K)\right)$ is defined by (4.18) for $n=0$ and $u_{\mathrm{ms}, k}^{0} \in V_{\mathrm{ms}}^{1}$ such that

where $z_{\mathrm{f}}^{n}=\sum_{K \in \mathcal{T}_{H}} z_{\mathrm{f}}^{n, K}$ such that

(A4) $H \leq \min \left(\frac{1}{4 C_{\mathrm{co}}}, \frac{c_{\sigma}}{\left(C_{\mathrm{co}}+C_{\mathrm{ort}}\right)}\right)$, where $C_{\mathrm{co}}$ is the constant in Lemma 4.5 and $C_{\text {ort }}$ is the constant in the almost orthogonal property (4.15).

Lemma 4.7. Assuming (A4) the problem (4.16)-(4.18) is well-posed.
Proof. This proof is similar the proof of Lemma 3.7, but we need to account for the lack of orthogonality and the fact that (3.32) is not satisfied.

Given $u_{\mathrm{ms}, k}^{n-1}, \theta_{\mathrm{ms}, k}^{n-1}$, and $u_{\mathrm{f}, k}^{n-1}=\sum_{K} u_{\mathrm{f}, k}^{n-1, K}$, the equations (4.16)-(4.18) yields a square system, so it is sufficient to prove that the solution is unique. Choosing $v_{1}=u_{\mathrm{ms}, k}^{n}-u_{\mathrm{ms}, k}^{n-1}$ in (4.16) and $v_{2}=\tau \theta_{\mathrm{ms}, k}^{n}$ in (4.17) and adding the resulting equations we get

\leq & C\left\|f^{n}\right\|_{H^{-1}}^{2}+\frac{\tau}{2}\left\|g^{n}\right\|^{2}+\frac{C_{\sigma}}{2}\left\|u_{\mathrm{ms}, k}^{n-1}\right\|_{H^{1}}^{2}+\frac{1}{2}\left\|\theta_{\mathrm{ms}, k}^{n-1}\right\|^{2} \\
& +\left(\sigma\left(\tilde{u}_{\mathrm{f}, k}^{n}\right): \varepsilon\left(u_{\mathrm{ms}, k}^{n-1}\right)\right)+\left(\alpha \nabla \cdot u_{\mathrm{f}, k}^{n-1}, \theta_{\mathrm{ms}, k}^{n}\right)
\end{aligned}
$$

Using Lemma 4.5 we have

where Assumption 4.6 guarantees that the coefficients are positive. Hence, a unique solution exists.

## 5. Error analysis

In this section we analyze the error of the generalized finite element method. The results are based on Assumption 4.6. In the analysis we utilize the following property, which is similar to Lemma 4.5.

Lemma 5.1. Let $\tilde{e}_{\mathrm{f}, k}^{n}:=\tilde{R}_{\mathrm{f}, k} \theta_{h}^{n}-u_{\mathrm{f}, k}^{n}$ and $\eta_{\theta}^{n}:=R_{\mathrm{ms}, k}^{2} \theta_{h}^{n}-\theta_{\mathrm{ms}, k}^{n}$. Then, for $w_{1} \in V_{\mathrm{f}}^{1}$, it holds that

\end{aligned}

The proof of Theorem 5.2 is based on two lemmas.

\left(\sigma\left(\eta_{u}^{n}\right): \varepsilon\left(\bar{\partial}_{t} \eta_{u}^{n}\right)\right)+\left(\bar{\partial}_{t} \eta_{\theta}^{n}, \eta_{\theta}^{n}\right)+\left(\kappa \nabla \eta_{\theta}^{n}, \nabla \eta_{\theta}^{n}\right)=\left(-\bar{\partial}_{t} \rho^{n}, \eta_{\theta}^{n}\right)-\left(\sigma\left(\tilde{e}_{\mathrm{f}, k}^{n}\right): \varepsilon\left(\bar{\partial}_{t} \eta_{u}^{n}\right)\right)-\left(\alpha \nabla \cdot \bar{\partial}_{t} \tilde{e}_{\mathrm{f}, k}^{n}, \eta_{\theta}^{n}\right) \tag{5.5}

\tau\left(\kappa \nabla \eta_{\theta}^{n}, \nabla \bar{\partial}_{t} \eta_{\theta}^{n}\right) \geq \frac{1}{2}\left(\left\|\eta_{\theta}^{n}\right\|_{\kappa}^{2}-\left\|\eta_{\theta}^{n-1}\right\|_{\kappa}^{2}\right)

and $t_{n}^{2}-t_{n-1}^{2} \leq 3 \tau t_{n-1}$, for $n \geq 2$, now give

Note that this inequality also holds for $n=1$, since $\eta_{\theta}^{0}=0\left(\right.$ recall $\left.\theta_{\mathrm{ms}, k}^{0}=R_{\mathrm{ms}, k}^{2} \theta_{h}^{0}\right)$. Summing over $n$ gives and using (2.11)

Multiplying by $\tau t_{n}$ and using that $t_{n}-t_{n-1}=\tau$ we get

& \quad \leq C t_{n}^{2} \tau\left\|\bar{\partial}_{t} \rho^{n}\right\|^{2}+C_{y} t_{n}^{2} \tau k^{d} \xi^{2 k}\left(\left\|\bar{\partial}_{t} \eta_{u}^{n}\right\|_{H^{1}}^{2}+\left\|\bar{\partial}_{t} \tilde{e}_{\mathrm{f}, k}^{n}\right\|_{H^{1}}^{2}\right)+C \tau\left(\left\|\tilde{\eta}_{u}^{n-1}\right\|_{\sigma}^{2}+\left\|\tilde{e}_{\mathrm{e}, k}^{n-1}\right\|_{\sigma}^{2}+\left\|\eta_{\theta}^{n-1}\right\|^{2}+\left\|\eta_{\theta}^{n}\right\|^{2}\right),

where we have used Young's (weighted) inequality on the form, $\tau t_{n} a b \leq \tau t_{n}^{2} a^{2}+\tau b^{2} / 4$, in the last step. For the second term we have used the inequality with an additional $C_{y}$, i.e. $\tau t_{n} a b \leq C_{y} \tau t_{n}^{2} a^{2}+\left(4 C_{y}\right)^{-1} \tau b^{2}$. Note that $C_{y}$ can be made arbitrarily small. Summing over $n$ and using (2.10) now gives

Since $C_{y}$ now can be made arbitrarily small the term $C_{y} k^{d} \xi^{2 k} \sum_{j=1}^{n} \tau t_{j}\left\|\eta_{\theta}^{j}\right\|_{H^{1}}^{2}$ can be moved to the left hand side. To estimate the last sum on the right hand side in (5.16) we multiply (5.4) by $\tau$ and sum over $n$ to get

& +C_{\mathrm{co}} k^{d / 2} \xi^{k}\left\|\tilde{e}_{\mathrm{f}, k}^{n}\right\|_{H^{1}}\left\|\eta_{\theta}^{n}\right\|-c_{\sigma}\left\|\tilde{e}_{\mathrm{f}, k}^{n}\right\|_{H^{1}}^{2}
\end{aligned}

where we have used the almost orthogonal property (4.15) and Lemma 4.5. We conclude that

and Assumption 4.6 guarantees positive coefficients. Now, note that we have the bound

Here we have used the Aubin-Nitsche duality argument, Lemma 4.2 and Theorem 3.3 to deduce

where $\bar{u}_{h}^{n}$ and $\bar{\theta}_{h}^{n}$ solves (3.1) and (3.2) with $f=0$ and $g=0$ and $\hat{u}_{h}^{n}$ and $\hat{\theta}_{h}^{n}$ solves (3.1) and (3.2) with $\theta_{h}^{0}=0$. The theorem now follows by applying Lemmas 5.3 and 5.4.

## 6. NuMERICAL EXAMPLES

In this section we perform two numerical examples. For a discussion on how to implement the type of generalized finite element efficiently described in this paper we refer to [10].

The first numerical example models a composite material which is preheated to a fix temperature and at time $t_{0}=0$ the piece is subject to a cool-down.

The domain is set to be the unit square $\Omega=[0,1] \times[0,1]$ and we assume that the temperature has a homogeneous Dirichlet boundary condition, that is $\Gamma_{D}^{\theta}=\partial \Omega$ and $\Gamma_{N}^{\theta}=\emptyset$. For the displacement we assume the bottom boundary to be fix and for the remaining part of the boundary we prescribe a homogeneous Neumann condition, that is $\Gamma_{D}^{u}=[0,1] \times 0$ and $\Gamma_{N}^{u}=\partial \Omega \backslash \Gamma_{D}^{u}$.

The composite is assumed to be built up according to Figure 1. The white part in the figure denotes a background material and the black parts an insulated material. The black squares are of size $2^{-5} \times 2^{-5}$. We assume that the Lamé coefficients $\mu$ and $\lambda$ take the values $\mu_{1}$ and $\lambda_{1}$ on the insulated material, and $\mu_{2}$ and $\lambda_{2}$ on the background material. In this experiment we have set $\mu_{1} / \mu_{2}=10$ and $\lambda_{1} / \lambda_{2}=50$. Similarly, using subscript 1 for the insulated material and subscript 2 for the background material, we set $\alpha_{1} / \alpha_{2}=10$ and $\kappa=\kappa_{i} \cdot I$, for $i=1,2$, where $I$ is the 2-dimensional identity matrix and $\kappa_{1} / \kappa_{2}=10$. Furthermore, we have chosen to set $f=[0,0]^{\top}$ (no external body forces) and $g=-10$.


Figure 1. Composite material on the unit square. One black square is of size $2^{-5} \times 2^{-5}$.

The initial data must be zero on the boundary $\Gamma_{D}^{\theta}$, so we have chosen to put $\theta^{0}=500 x(1-x) y(1-y)$ and $\theta_{h}^{0}$ to the $L_{2}$-projection of $\theta^{0}$ to $V_{h}^{2}$. For the generalized finite element solution we have chosen $\theta_{\mathrm{ms}, k}^{0}=R_{\mathrm{ms}, k}^{2} \theta_{h}^{0}$ and $\tilde{u}_{\mathrm{ms}, k}^{0}$ is given by (4.19).

The domain is discretized using a uniform triangulation. The reference solution is computed on a mesh of $h=\sqrt{2} \times 2^{-6}$ which resolves the fine parts (the black squares) in the material. The generalized finite element method (GFEM) in (4.16)-(4.18) is computed for five decreasing values of the mesh size, namely, $H=\sqrt{2} \times 2^{-1}, \sqrt{2} \times 2^{-2}, \ldots, \sqrt{2} \times 2^{-5}$, with the patch sizes $k=1,1,2,2,3$. For comparison, we also compute the corresponding classical finite element (FEM) solution on the coarse meshes using continuous piecewise affine polynomials for both spaces (P1-P1). The solutions satisfies (3.1) and (3.2) with $h$ replaced by $H$ and are denoted $u_{H}^{n}$ and $\theta_{H}^{n}$ respectively for $n=1, \ldots, N$. When computing these solutions we have evaluated the integrals exactly to avoid quadrature errors.

We have chosen to set $T=1$ and $\tau=0.05$ for all values of $H$ and for the reference solution. The solutions are compared at the time point $N$.

Note that the implementation of the corrections $u_{\mathrm{f}, k}^{n, K}$ in (4.18) given by

should not be computed explicitly at each time step. It is more efficient to compute $x_{y}^{K}$, given by

where $\left\{(\cdot, y) \in \mathcal{N}: \lambda_{y}^{2}-R_{\mathrm{f}, k}^{2} \lambda_{y}^{2}\right\}$ is the basis for $V_{\mathrm{ms}, k}^{2}$. Now, since $\theta_{\mathrm{ms}, k}^{n}=\sum_{y} \beta_{y}^{n}\left(\lambda_{y}^{2}-R_{\mathrm{f}, k}^{2} \lambda_{y}^{2}\right)$, we have the identity

u_{\mathrm{f}, k}^{n}=\sum_{K} u_{\mathrm{f}, k}^{n, K}=\sum_{K} \sum_{y} \beta_{y}^{n} x_{y}^{K} .
$$

With this approach, we only need to compute $x_{y}^{K}$ once before solving for the system (4.16) and (4.17) for $n=1, \ldots, N$.

The relative errors in the $H^{1}$-seminorm $\|\nabla \cdot\|$ are shown in Figure 2. The left graph shows the relative errors for the displacement, $\left\|\nabla\left(\tilde{u}_{\mathrm{ms}, k}^{N}-u_{h}^{N}\right)\right\| /\left\|\nabla u_{h}^{N}\right\|$ and $\left\|\nabla\left(u_{H}^{N}-u_{h}^{N}\right)\right\| /\left\|\nabla u_{h}^{N}\right\|$. The right graph shows the error

for the temperature $\left\|\nabla\left(\theta_{\mathrm{ms}, k}^{N}-\theta_{h}^{N}\right)\right\| /\left\|\nabla \theta_{h}^{N}\right\|$ and $\left\|\nabla\left(\theta_{H}^{N}-\theta_{h}^{N}\right)\right\| /\left\|\nabla \theta_{h}^{N}\right\|$. As expected the generalized finite element shows convergence of optimal order and outperforms the classical finite element.

The second example shows the importance of the additional correction (4.18), which is designed to handle multiscale behavior in the coefficient $\alpha$. The computational domain, the spatial and the time discretization, and the patch sizes remain the same as in the first example. However, we let $\Gamma_{D}=\partial \Omega$ and $\Gamma_{N}=\emptyset$ in this case.

To test the influence of $\alpha$ we let the other coefficients be constants, $\mu=\lambda=1$ and $\kappa=I$, where the $I$ is the 2 -dimensional identity matrix. The coefficient $\alpha$ takes values between 0.1 and 10 according to Figure 3. The boxes are of size $2^{-5} \times 2^{-5}$ and, hence, the reference mesh of size $h=\sqrt{2} \cdot 2^{-6}$ is sufficiently small to resolve the variations in $\alpha$.

The initial data is set to $\theta^{0}=x(1-x) y(1-y)$ and $\theta_{h}^{0}$ is the $L_{2}$-projection of $\theta^{0}$ onto $V_{h}^{2}$. For the generalized finite element solution we have chosen $\theta_{\mathrm{ms}, k}^{0}=R_{\mathrm{ms}, k}^{2} \theta_{h}^{0}$ and $\tilde{u}_{\mathrm{ms}, k}^{0}$ is given by (4.19), as in our first example. Furthermore, we have chosen to set $f=\left[\begin{array}{ll}1 & 1\end{array}\right]^{\top}$ and $g=10$.

The generalized finite element method (GFEM) in (4.16)-(4.18) is computed for the five decreasing values of the mesh size used in the first example. For comparison, we compute the generalized finite element without the additional correction on $u_{\mathrm{ms}, k}^{n}$. In this case the system (4.16)-(4.18) simplifies to

\begin{aligned}
\left(\sigma\left(u_{\mathrm{ms}, k}^{n}\right): \varepsilon\left(v_{1}\right)\right)-\left(\alpha \theta_{\mathrm{ms}, k}^{n}, \nabla \cdot v_{1}\right) & =\left(f^{n}, v_{1}\right), & \forall v_{1} \in V_{\mathrm{ms}, k}^{1} \\
\left(\bar{\partial}_{t} \theta_{\mathrm{ms}, k}^{n}, v_{2}\right)+\left(\kappa \nabla \theta_{\mathrm{ms}, k}^{n}, \nabla v_{2}\right)+\left(\alpha \nabla \cdot \bar{\partial}_{t} u_{\mathrm{ms}, k}^{n}, v_{2}\right) & =\left(g^{n}, v_{2}\right), & \forall v_{2} \in V_{\mathrm{ms}, k}^{2}
\end{aligned}
$$

The relative errors in the $H^{1}$-seminorm are shown in Figure 2. The graph shows the errors for the displacement with correction for $\alpha,\left\|\nabla\left(\tilde{u}_{\mathrm{ms}, k}^{N}-u_{h}^{N}\right)\right\| /\left\|\nabla u_{h}^{N}\right\|$ and the error without correction for $\alpha\left\|\nabla\left(u_{\mathrm{ms}, k}^{N}-u_{h}^{N}\right)\right\| /\left\|\nabla u_{h}^{N}\right\|$. As expected the GFEM with correction for $\alpha$ shows convergence of optimal order and outperforms the GFEM without correction for $\alpha$. This is due to the fact that, in the case when the correction for $\alpha$ is neglected, the constant in (4.13) (and hence also the constant in Thm. 5.2) depends on the variations in $\alpha$ (see Rem. 3.6).
