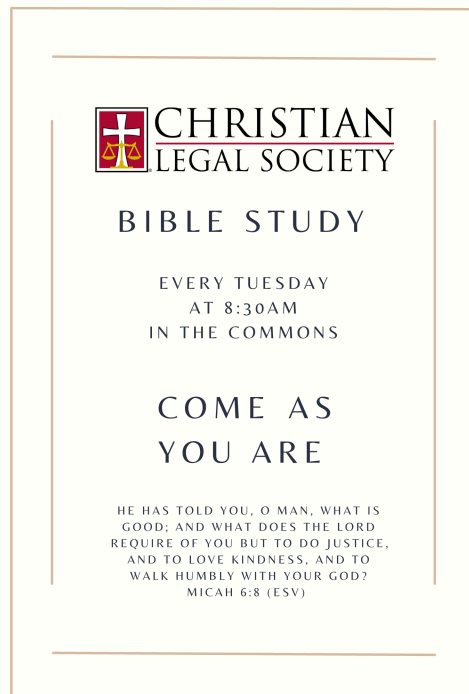

## **Saint of the Week: St. Thérèse of Lisieux with Patti McLaughlin**

St. Thérèse is one of only 4 women recognized as Doctors of the Church because her philosophy is considered so valuable. Although she died at 24, she revolutionized our understanding of the way in which to attain holiness. Through her smallness and insignificance, she learned to ask God for help, and she trusted God to carry her to sanctity. Greatness in God's eyes required doing the smallest deed with great love.

She wrote, "Love proves itself by deeds, so how am I to show my love? Great deeds are forbidden me. The only way I can prove my love is by scattering flowers and these flowers are every little sacrifice, every glance and word, and the doing of the least actions for love."

St. Thérèse's "Little Way" shows us a simple and practical way to approach our spirituality. Do all things with love--We can do that!

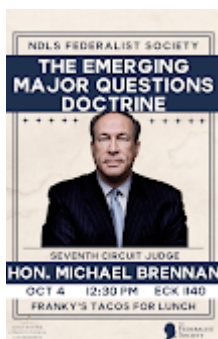
