## REPORTS RELATING TO THE FIFTY-SIXTH ANNUAL MEETING OF THE SOCIETY

The 56th annual meeting of the Evangelical Theological Society had the second highest attendance on record with 2284 persons registered. The record was nearly 2400 in Atlanta in 2003. The meetings were held at the spacious Marriott Rivercenter and Riverwalk Hotels in downtown San Antonio, TX, right next to the historic Alamo. Participating publishers offered generous discounts on their books and other products from one hundred booths in the Henry B. Gonzales Convention Center. The program theme, "What Is Truth?" was explored in four excellent plenary sessions, which are published in the present issue of the *Journal*, and by many of the more than 450 hundred individual papers. Participants gathered from four continents and the islands of the seas to fellowship, exchange ideas, critique one another, and to keep abreast of the most recent scholarship in their disciplines. More than twenty study groups also met as part of the overall program.

President-Elect Craig Blasing served as program chairman and put together a superb array of plenary speakers. On Wednesday afternoon, *JETS* Editor Andreas J. Köstenberger of Southeastern Baptist Theological Seminary addressed the society on the conference theme "What Is Truth? Pilate's Question in its Johannine and Larger Biblical Context," adeptly exploring the historicity of Jesus' trial before Pilate, the major themes of judgment, kingship, and the notion of truth, and examining the major characters—Jesus, Pilate, and the Jewish leaders. That evening, R. Albert Mohler, Jr., writer, radio host, columnist, denominational leader, and president of Southern Baptist Theological Seminary, spoke powerfully on "Truth and Contemporary Culture," emphasizing a declining emphasis on doctrine and truth in our culture and even among some evangelicals who cater to postmodern thought.

On Thursday morning attendees heard a third ETS member, J. P. Moreland, distinguished professor of philosophy at Talbot School of Theology in La Mirada, CA. He addressed "Truth and Contemporary Philosophy," carefully explaining the meaning of the correspondence theory of truth, and telling why postmodernism is a relative theory awash in subjectivity. He identified postmodernism's five "confusions" and challenged those holding such a position to admit its bankruptcy.

The fourth and final plenary was an insightful session titled "Lost in Interpretation? Truth, Scripture, and Hermeneutics," delivered on Friday morning by Kevin J. Vanhoozer of Trinity Evangelical Divinity School.

More than twenty parallel sessions ran concurrently on such disciplines as Old Testament, New Testament, biblical, historical, and systematic theology, church history, archaeology, philosophy, hermeneutics, evangelism and missions, pastoral ministry, and psychology and theology. Parallel programs

were also conducted by the Evangelical Philosophical Society, the Near East Archaeological Society, and the Adventist Theological Society. In addition, twenty-one separate ETS study groups also presented programs. Tables and a large bulletin board were provided for members to display resumes and for institutions to advertise available positions.

The first business session was called to order by ETS President Greg Beale at 8 a.m. on Wednesday, November 17. He introduced ETS Vice-President Edwin Yamauchi, who gave a brief devotional on the ancient Greek Olympic Games and Paul's references to athletics in his epistles, pointing out that Paul may have attended the Isthmian games. It was moved, seconded and carried (MSC) to adopt an amended agenda, that is, the meeting program which had been printed and distributed to all members previously, plus a single addition to the program—the consideration of a proposed resolution on inerrancy. The Secretary-Treasurer James Borland then presented both the membership and financial reports.

The financial report was audited by Geoffrey R. Mather, CPA, Lynchburg, VA.

Five members were then nominated for three slots to serve on the nominating committee along with the two most recent ETS past presidents, Millard Erickson and David Howard, Jr. It was MSC to close the nominations and to vote for three persons each. The three selected to serve were Wayne House, Russ Bush, and Paige Patterson.

Elected to serve by acclamation on the resolutions committee were Leland Ryken, George Joseph Gatis, and Aida Spencer.

On Wednesday evening, President Greg Beale called to order a special business meeting at 7:15 p.m. to discuss the resolution on inerrancy unanimously proposed by the Executive Committee. This resolution was called

for by a motion passed at the final business session in 2003 which stated, "That the ETS Executive Committee consider and recommend to the Society appropriate ways to clarify our Society's understanding of our doctrinal basis." The proposed resolution was: "For the purpose of advising members regarding the intent and meaning of the reference to biblical inerrancy in the ETS Doctrinal Basis, the Society refers members to the Chicago Statement on Biblical Inerrancy (1978). The case for biblical inerrancy rests on the absolute trustworthiness of God and Scripture's testimony to itself. A proper understanding of inerrancy takes into account the language, genres, and intent of Scripture. We reject approaches to Scripture that deny that biblical truth claims are grounded in reality."

Comments, both pro and con, were expressed about the resolution, but the vote was scheduled for Friday morning's business session.

On Thursday evening, ETS President Greg Beale of Wheaton College Graduate School spoke at the fellowship banquet on "The Use of Old Testament Prophecy in the New Testament: 'Literal' Fulfillment, Allegory or Analogy?" Nearly 1,000 members were in attendance.

The final business session was called to order on Friday morning at 7:50 a.m. by ETS President Greg Beale who then asked ETS President-Elect Craig Blaising to lead in prayer. James Borland, ETS Secretary-Treasurer, mentioned that full reports of the ETS regional meetings would appear in the January Newsletter and then presented brief memorials for the seven members who had passed away during the year. Andreas Köstenberger, Editor of *JETS*, gave his report on the journal, pointing out that the last eight years of *JETS* are now accessible at our website, [www.ETSJETS.org](http://www.ETSJETS.org), and that each issue of the *Journal* would be increased from 192 to 224 pages in 2005.

The Resolutions Committee of the Annual Meeting of the Evangelical Theological Society, composed of Leland Ryken, Aida Besancon Spencer, and George Joseph Gatis, having convened, respectfully proffered the following resolution which was read by George Gatis.

1. WHEREAS the hotel staff, managers, and hosts of the Marriott International Rivercenter and Riverwalk of San Antonio, Texas have provided warm hospitality, gracious conveniences, and helpful assistance in the hosting of the annual meeting;
2. WHEREAS the facilities have provided a beautiful and restive environment for the holding of the annual meeting;

BE IT THEREFORE RESOLVED that the hotel staff, managers, and hosts of the Marriott International Rivercenter and Riverwalk of San Antonio, Texas be thanked and commended.

The Resolutions Committee respectfully proffered this second following resolution:

1. WHEREAS the President, Gregory Beale, President-Elect, Craig Blaising, and Secretary-Treasurer, James Borland, have demonstrated tireless zeal, indefatigable energy, and faithful service to the benefit, well-being, and functionality of our Society;
2. WHEREAS the Executive Committee members have demonstrated Christian commitment, conscientiousness, initiative, and due diligence to provide leadership for our Society;
3. WHEREAS the annual meeting of the Evangelical Theological Society has proved to be a blessing, challenge, and opportunity to exchange edifying information and forge life-long fellowship and collegiality;
4. WHEREAS the Editors of the *Journal of the Evangelical Theological Society* have maintained remarkably low overhead, providing an outlet for scholarship, and timely publications;

BE IT THEREFORE RESOLVED that the Officers, Executive Committee Members, and Editors of the *Journal of the Evangelical Theological Society* be thanked, commended, and recognized for their remarkable dedication and outstanding service.

To our beloved colleagues we commend the following verses of Scripture:  
1 Corinthians 4:2: "Moreover, it is required of stewards, than they be found faithful."

1 Corinthians 15:58: "Therefore, my beloved, be steadfast, immovable, always excelling in the work of the Lord, because you know that your labor is not in vain in the Lord."

Hebrew 6:10: "For God is not unrighteous to forget your work of love, which ye have showed toward his name, in that ye have ministered to the saints, and do minister."

The above resolutions were passed unanimously by voice vote.

Russ Bush moved the report of the nominations committee, that the following persons be elected:

The motion carried to elect the above slate of officers.

President Beale had tellers pass out blank paper ballots so that ETS full members could vote on the proposed resolution that was introduced and discussed at the special business session on Wednesday evening. The vote was 234 in favor and 58 opposed. Thus, the motion carried by an 80% to 20%

margin. The leadership of ETS was then transferred from Greg Beale to incoming President Craig Blaising, and the meeting was adjourned at 8:25 a.m.
