The second meeting of the lecture and study group of younger members and associates of the Institute in the metropolitan area of New York will take place on Tuesday, January 21, 1936, in the Sun Room of the Edison Hotel, 47th St., west of Broadway, New York.

The subject of discussion will be accounting problems related to form 10-K of the Securities and Exchange Commission. Discussion will be led by C. Oliver Wellington, George Cochrane and Philip N. Miller.

The discussion will be wholly informal—no reporter, no publication of what is said. All present may participate. Exchange of ideas is the chief purpose.

The meeting will be of interest to all younger accountants, regardless of whether or not they have participated or expect to participate in engagements under S. E. C. requirements. The effect of S. E. C. rules on accounting practice in general is considerable, and all practitioners should be familiar with the requirements. It would be well to read form 10-K before attending the meeting. Copies may be obtained at the Institute's office.

The west-side subway, Grand Central and Penn Station are readily accessible from the Edison Hotel, and an early hour for adjournment has been fixed for the benefit of commuters.
