



Introduction

Recognizing the crucial role of universities in implementing the 2030 Agenda, the Pablo de Olavide University (UPO) has conducted a comprehensive assessment to evaluate its alignment and contribution towards achieving the Targets defined within the 17 Sustainable Development Goals (SDGs).

The 2030 Agenda presents a dual mandate for universities. Firstly, they are tasked with integrating the SDGs into their educational and research programs. Secondly, they are expected to act as catalysts for societal transformation and promote a governance model in higher education that aligns with the Agenda's objectives.

In light of these responsibilities, UPO has recognized the need to equip itself with the necessary tools to effectively assess the fulfillment of these mandates. This accountability is crucial for demonstrating UPO's commitment to the SDGs and for enhancing the effectiveness of its actions within the framework of the Agenda.

This document provides a summary of the process undertaken by UPO, in collaboration with Periferia Social Consulting, between November 2022 and May 2023. The objective was to design a set of indicators that can measure UPO's contribution to the 2030 Agenda.

The first section describes the methodology and various phases involved in the process. Following that, the document presents the system of indicators developed and provides information on UPO's contribution to the 2030 Agenda for the academic year 2021-2022.

In the annexes, two posters are included, displaying the complete set of indicators and the measurements made for the 2021-2022 academic year.





Process

Objectives

The primary objective of this process was to provide the Pablo de Olavide University (UPO) with a comprehensive set of indicators that assess its contribution to the 2030 Agenda. It also aimed to diagnose the Strengths, Opportunities, Weaknesses, and Threats (SWOT) related to UPO's objectives, priorities, and actions. This diagnostic step is crucial in preparing an Action Plan within the framework of the 2030 Agenda.

This undertaking has yielded several important outcomes, including:

• Development of a robust set of indicators that gauges UPO's alignment with the 2030 Agenda.

• Identification of key stakeholders and crucial areas within UPO for contributing to the 2030 Agenda.

• Enhanced accountability, transparency, and communication with key stakeholders of UPO.

• Creation of tools to support future planning processes.

• Establishment of a Shared Vision and collaborative framework.

• Definition of a common set of indicators in collaboration with other universities.

• Increased visibility of universities' contribution to advancing the Sustainable Development Goals (SDGs).

• Promotion of alignment with the 2030 Agenda.

By accomplishing these objectives, this process has paved the way for UPO to effectively monitor and improve its engagement with the 2030 Agenda, fostering sustainable development and societal progress.





Methodology

The work undertaken was divided into three distinct phases:



In the initial stage, a joint consultancy follow-up committee was established, comprising the Periferia team and the Internal Group of the UPO consisting of six individuals. This phase involved compiling and analyzing various documents related to the UPO's areas of work, such as Strategic Frameworks, Action Plans, Activity Reports, Project Reports, and Management Reports for the 2021/2022 academic year.

Additionally, documents analyzing the role of universities in contributing to the SDGs, good practices, and lessons learned were taken into consideration.

This review enabled the identification of the SDGs and targets to which the UPO was already contributing within its institutional approach.

The second phase focused on designing and validating the indicator system, as well as developing data collection tools. The 2030 Agenda itself served as the foundation for this process, supplemented by a review of indicator systems proposed by similar institutions in Spain and Europe¹.

Subsequently, the Periferia Consultancy presented a list of indicators based on the SDGs and selected targets, along with an analysis of their quality and feasibility, and methodological sheets for each indicator.

The UPO work team reviewed and validated these products, providing valuable contributions that facilitated necessary adjustments to the system, particularly in the final selection of indicators and corresponding methodological sheets.

The final stage, DIAGNOSIS, focused on measuring the indicators, drawing conclusions, and systematizing the diagnosis using a SWOT analysis. In this stage, information pertaining to the 2021/2022 academic year was analyzed using a specifically designed data collection form. Initially, reports on activities and management reports from various UPO services and departments were reviewed to extract essential figures and data. For indicators requiring additional information, the Internal Group made specific requests to the relevant UPO services or areas. Drawing on the insights and learnings gathered throughout the process, a systematic analysis of Strengths, Opportunities, Weaknesses, Threats, and Limitations was conducted. This analysis, presented in a different report, will serve as a foundation for the subsequent development of an Action Plan that will guide the UPO towards 2030.

Participants

An important aspect of this process was the active participation of individuals from different areas within the University.

Initially, a core group of six project members, together with the Periferia team, was formed, and their involvement spanned all three phases of the process. Over time, individuals from other areas and fields of the University also joined the project. To facilitate collaboration and information sharing, a virtual workspace was established at the outset, enabling participants from the University to contribute their insights and review the generated information.

Three face-to-face workshops took place at the conclusion of each phase (in January, March, and May 2023), with participation ranging from 10 to 13 individuals.

In addition to those already mentioned, there have been other areas of the University that have also participated in the preparation of the diagnostic report of the UPO's contribution to the 2030 AGENDA for the 2021-2022 academic year, providing specific and relevant data for the process. These areas have been: Human Resources, PDI and PAS, Quality Area, Scholarships and Grants Service, Functional Diversity Support Service and the Infrastructure, Maintenance and Energy efficiency Service.





Set of indicators on the contribution of the UPO to the 2030 Agenda

The Pablo de Olavide University sustainable development indicator system has been built based on the 2030 Agenda, covering the set of 17 SDGs from a comprehensive approach, given their interrelation and feedback. Out of 169 targets in which the SDGs are deployed, the UPO contributes to 34 of them, with a distribution according to the main areas of intervention of the University.

If we distribute the Indicators around the five spheres in which the 2030 Agenda is organized, "The 5 P's of Development": People, Planet, Prosperity, Peace and Partnerships, we find that it is the People sphere, followed by the Prosperity, the one that accumulates more number of indicators, as shown in the graph presented below.




Number of indicators for the 5 Ps of Development





The breakdown of the set of indicators according to the areas of the University shows that 38 of the 85 established indicators refer to issues related to Management, to the UPO understood as an organization, which represents 46% of the indicators of the system. The fields of teaching and research, key elements in this institution, have 18 and 9 indicators respectively, which represents 32% of the indicators of the system; finally, the indicators related to the social leadership of the University represent 22% of the set of indicators.

A more detailed analysis of the system, such as the distribution of the indicators by area of action presented in the following graph, allows us to observe that it is the reduction of the Gender Gap where the greatest number of indicators is concentrated, with 12 related indicators. Other characteristics of the system is its clear environmental focus with an approach oriented towards environmental sustainability, with more than 35% of the indicators intended to provide information in this regard.


