Soldiers' Board of Relief, 1861-1864

1. Organization and Duties, 1861-1864

The Act which established the "Soldiers' Board of Re-"lief" was passed on December 21,1861. According to the provisions of this Act, the General Assembly was authorized to appoint not less than five nor more than ten freeholders from each tax district who were to be called the "Soldiers' Board of Relief." This organization was to continue during the existence of the War and for four months thereafter. Each district board was authorized to fill up any vacancies which occurred within it. It was authorized also to levy an annual tax, to be collected by the State Tax Collectors on the taxpayers of its district and to direct the Treasurer to distribute the money to families of soldiers who had volunteered in the service of South Carolina or the Confederacy. Each board was required to elect a treasurer and a secretary from among its members, who were to keep a record of all its transactions, to be responsible to the board, and to furnish bond payable to the board. Each board was required also to send returns of its receipts and expenditures to the Court of Common Pleas in its district.

Acts passed on December 18,1862 and on February 6, 1863 revised the organization and duties of the "Soldiers' Board of Relief." According to the provisions of these acts, the General Assembly was required to appoint annually the members of each district board, and the membership of the district boards was changed to consist of not less than three nor more than twelve freeholders. Each district board was required to distribute money appropriated by the State Treasurer to families, residing in its district, of soldiers, sailors and marines who were serving in the Army or Navy of the Confederate States as well as to families of soldiers who had been killed or wounded. It was required also to send returns of its receipts and expenditures to the General Assembly and the State Treasurer and to report the names and addresses of its officers to the Comptroller General.

Subsequent act further modified the organization and increased the duties of the "Soldiers' Board of Relief." An act passed on December 17, 1863 provided that the membership of each district board be increased to consist of not less than three nor more than twenty-four members. This act directed each district board to divide its district into sections equal to the number of members on its board so that each member could be assigned to one section. Besides providing relief to families of Confederate soldiers, each member of the board was directed to ascertain and to collect taxes in kind of rice, corn and wheat from every producer or manufacturer in the section assigned to him. 3 passed on December 23, 1864 provided that the district boards continue to operate as they had in 1863-64. It provided, however, that they send their reports of receipts and expenditures to the State Auditor. Relief was extended to include families of free Negroes who were employed by the Confederate States.

2. Appointment of Members, 1861-1864

On December 21, 1861, the General Assembly passed a resolution_appointing the original members of the district boards of relief.

On January 22,1863, the General Assembly passed a resolution which reorganized the procedure for appointing the members of the "Soldiers' Board of Relief." The members of both houses of the General Assembly from each election district were required to nominate the members of the boards of relief in their respective districts and to report their names to the House Committee on vacant offices and officers. This Committee was required to report the nominations for the entire State to the General Assembly for confirmation. The pames of appointees were to be listed in the Columbia newspapers. This procedure was continued annually through December 20,1864.

Names of appointees do not appear in the report of the House Committee for vacant offices and officers of 1865, and there is no mention of the "Soldiers' Board of Relief" in the Reports and Resolutions or the Statutes of 1865.
