



Dear Members of the NYMC Community:

Members of the SOM Class of 2027 marked a milestone in their medical education as they donned their white coats for the first time during the White Coat Ceremony, which took place at SUNY Purchase on July 28. A long-held tradition at NYMC, the White Coat Ceremony began in 1993 at Columbia University College of Physicians and Surgeons to emphasize the importance of professionalism and humanism in

medicine at the beginning of medical school.

The 219 members of the Class processed into the auditorium with their white coats draped over their arms as their families and friends looked on with pride. During the ceremony, several faculty and student speakers spoke of the enormous responsibility they would carry as physicians, symbolized by their white coats, and emphasizing the importance of maintaining their humanism throughout their careers.

Dr. Pamela Ludmer Appointed Dean for Undergraduate Medical Education

Pamela Ludmer, M.D., M.M.E.L., associate dean for curriculum integration and clinical assistant professor of pediatrics and medicine, has been appointed as dean for undergraduate medical education in the SOM. Dr. Ludmer has served as interim dean for undergraduate medical education since July. She also serves as faculty lead for the SOM's accreditation by the Liaison Committee on Medical Education (LCME).

Dr. Ludmer will lead the Office of Undergraduate Medical Education in the planning, implementation, evaluation and oversight of the M.D. curriculum. She will also head the SOM in ensuring that the medical education program meets the established standards by the LCME accreditation peer-reviewed process.



Dr. Ludmer joined the NYMC community in 2012 as director of the fourth-year curriculum and was promoted to her position as associate dean in 2019. Since her appointment to the faculty, Dr. Ludmer has distinguished herself as a leader and a role model. As chair of the Steering Committee on Curricular Redesign, she played and continues to play an integral role in the development of the new SOM medical education curriculum, which was launched last fall. Dr. Ludmer is also responsible for the creation of the fourth-year Specialty Track curriculum, the Transition to Fourth Year program and the new required curriculum in Health Systems Sciences. For her work on the curriculum, Dr. Ludmer was recognized with the SOM Dean's Award for Excellence in Diversity, Equity and Inclusion in 2022.

SOM Establishes Psychiatry Residency Program at Saint Joseph's Medical Center

The SOM has expanded its NYMC-sponsored residency programs at Saint Joseph's Medical Center in Yonkers, New York, to include a new Psychiatry Residency Program. The program is offered jointly at Saint Joseph's and its St. Vincent's Hospital Westchester division in Harrison, New York. NYMC also sponsors the Family Medicine Residency Program at Saint Joseph's.

Saint Joseph's Medical Center, with its St. Vincent's Hospital Westchester division, is recognized as a major provider of quality psychiatric services in Westchester County. The hospitals have 182



inpatient beds, including specialized geriatric, adolescent, addiction rehabilitation and intermediate care units, and treat more than 4,000 patients in their outpatient mental health programs and over 500 patients in their outpatient substance use disorder programs.

As part of the Psychiatry Residency Program, residents will have clinical rotations in a broad range of areas, including addiction psychiatry, geriatric psychiatry, child and adolescent psychiatry and community psychiatry. Residents will have the opportunity to experience several unique community-based services as part of their required or elective rotations, including the recovery-oriented PROS program, the Crisis Prevention and Response Team and the short-term Intensive Crisis Residence.

Pre-Matriculation Program Prepares Students for Success in Medical School

Members of the SOM Class of 2027 had the opportunity to ease their transition to medical school during the Pre-Matriculation Program, offered in July, just prior to orientation. The program, now in its third year, which included sessions on study techniques, personal wellness and careers and featured faculty and student speakers from across NYMC, has received high marks from students who have participated.



"When I started medical school I had no real guidance or mentors and I found the first year of medical school to be extremely difficult. This program allows for a relaxed introduction to some of the material students will learn in medical school, but more than anything, it provides a safe space to learn different study strategies, about resources that can be effective for individual learning styles and how to foster a sense of community and belonging," said Maziyah Ogarro, SOM Class of 2024, the student director of the program.

The Pre-Matriculation Program, which is sponsored by the Office of Diversity and Inclusion in collaboration with academic support services, student affairs and undergraduate medical education, is open to all incoming medical students though non-traditional students and those from demographics underrepresented in medicine are especially encouraged to participate. During the two-week program, students explored a range of academic topics, including microbiology and anatomy, cultivated early interest in the specialties of emergency medicine, surgery and radiology and participated in sessions designed to promote good study habits and personal wellness. As part of the course of study, students will promote diversity within health care teams and foster inclusivity; engage in practices to eradicate health care inequities; influence decision-makers to advance health equity; and advocate for inclusive health care teams.

Faculty Profile:

Fawaz Al-Mufti, M.D. — War, Migration and Perseverance

Fawaz Al-Mufti, M.D., associate professor of neurology, neurosurgery and of radiology, was one year out of medical school, without a chosen specialty, when war thrust him into emergency medicine. It was 2003 and senior staff at the Nahrain Teaching Hospital in Baghdad, Iraq, where Dr. Al-Mufti had just finished a transitional residency—including six months of surgical training—were fleeing, leaving him and junior colleagues to treat the surge of civilian casualties.

Two years later, Dr. Al-Mufti was delivering urgent care to people in conflict zones around the world for Doctors Without Borders/Médecins Sans Frontières (MSF). Despite all this experience, he would have to repeat his residency to practice emergency medicine in the United States. Instead, he chose not one but three new specialties, becoming a triple, board-certified neurologist, neurointensivist and neuroendovascular surgeon. "War makes life feel so unpredictable—too short to waste doing the same thing again," Dr. Al-Mufti says. "I am who I am today because I did not choose the easier path but rather the road less traveled. Instead of considering adversity a problem, I saw it
