



Dear Madam:

We are in receipt of your letter of May 27th, and in reply would say that the present tenant, Mrs. Small, who occupies your house at #206 West 122nd Street, New York City, is not willing to pay any more than \$160.00 rent per month, and we are endeavoring to obtain a tenant who will pay more, but up to the present writing have been unable to do so.

In the meantime, we are permitting Mrs. Small to remain on the premises at the old rental rather than have the premises vacant. If it is your desire to have this house vacant rather than have Mrs. Small living there at \$160.00 per month let us know, and we shall be pleased to follow your instructions.

Renting conditions in New York are not as brisk as what they were a year or so ago which accounts for the fact that we are not able to obtain a new tenant at a higher rental more easily.
