#### AUDITOR'S REPORT

Alexander, Me., Aug. 29, 1939

Board of Selectmen. Alexander, Maine

Gentlemen :

I submit herewith report showing the result of my examination of your Town records for the fiscal year 1938-1939.

Due to the fact that your books were not closed at

the end of the year, the transactions of the year following (1939-1940) became commingled with those of the year under examination. I have therefore re-written your books in skeleton form on pages 450-493 inclusive of your old Town ledger.

As an opening entry I have placed on these books the balance sheet shown on report of your former Auditor.

Warrant Distribution Book for the year 1938-1939 has been written up and its footings posted to the proper accounts.

Explanatory journal entries have been made in detail on those pages of the Distribution Book preceding the record of Warrants issued.

The re-written books have then been closed, and the resulting overdrawn and unexpended balances carried to Surplus account.

The new B-S becomes the beginning entry for your books of the F. Y. 1939-1940.

Beginning and ending Surplus have been reconciled as shown in the attached schedule.

Treasurer's Account: It was found that Treasurer's cash on March, 1938, differed slightly from the amount shown on Auditors report. His entry correcting this discrepancy I have eliminated and substituted the following: Contingent Account. Debit Treasurer, Credit Discrepancy, March, 1938-9.51 less differences subsequent to March, 1938-36. Net adjustment, 9.15.

Bank Account has been verified and the balance found correct.

Tax Deeds and Liens: It was found that deeds and liens for many successive years were held against certain parcels of Town Real Estate. Journal entries have been made charging these parcels with the liens and deeds. Your selectmen have then fixed what they consider a fair value on this taken over property. Proper entries have been made to set the property on the Town books at this valuation.

Your Board is to be commended for its efforts to close out these lands. Many lots have been sold. Payments are often made partly in cash and partly in secured notes.

School Fund: This fund has been set up on your Town Books. If is invested in note of the Town given in April 1934 and bearing interest at the rate of four and one-half percent. Amt. \$1,744.70.

Note of Melvin Hunnewell (secured by Mortgage) for \$300.00 bearing interest at 6 per cent. Only \$165.00 of this note represents principal, the balance being for accrued interest.

An effort has been made to show on Closing B-S a true pieture of the Towns financial standing. I have however, omitted a small balance due from Melvin Hunnewell which is being paid in small installments.

Distribution Book from March 1939 to date has been written up.

Taxes prior years: Taxes for 1932 have been correct by charge to Surplus of \$17.75 as it was found that nothing was owed on that year.

A set of books have been opened with the initial entry of the closing B-S shown in this report.

To choose three or more Assessors for the ensuing year.

#### Article 6

To choose three or more Overseers of Poor for the ensuing year.

#### Article 7

To choose one or more Surveyors of Lumber, Wood and Bark for the ensuing year.

#### Article 8

To choose one or more Constables for the ensuing year.

#### Article 9

To choose a Town Treasurer for the ensuing year, 25

#### Article 10

To choose a Road Commissioner for the ensuing year.

#### Article 11

To choose a School Committee for a term of three years.

#### Article 12

To see if the town will set up the Collection of Taxes to the lowest bidder.

#### Article 13

To choose a Collector of Taxes for the ensuing year.

Article 14

To choose all other Town Officers.

#### Article 15

To fix Salaries of all Town Officers.

#### Article 16
