Abstract: Sage Hylton-Lemons grew up in Portland, Maine. In high school, Hylton-Lemons found sanctuary as a gay teenager in the youth-

driven group Outright, where his involvement progressed from attending weekly meetings to being a member of the Board, then President of the Board. As an Outright member and activist, Hylton-Lemons spoke at schools and events, became a peer-advisor, and helped other communities organize their own Outrights. He was instrumental in conceiving and organizing Outright's first annual prom in 1998. He was profoundly

influenced by Christian T. Chenard, a nurse practitioner for the

City of Portland Public Health Positive Healthcare Program. The papers include a scrapbook, photographs from the 1998 Outright Prom, a letter from the Maine Assistant Attorney General, a transcript of Hylton-Lemons' testimony at a Portland City Council hearing regarding funding for Outright, and a transcript of his eulogy at the 2007 memorial service for Dr.

Chenard along with other materials from the service.

Biographical / Historical

Sage Hylton-Lemons was born in 1980 and grew up in Portland, Maine. After being outed as gay during his freshman year of high school, Hylton-Lemons was subject to verbal and physical harassment from his classmates. During this time, Hylton-Lemons found support and affirmation through the youth-driven organization Outright, which served as a safe haven for LGBTQ+ youth in the Portland area. His involvement with Outright progressed from attending weekly meetings to being a Board member, to serving as President of the Board. As an Outright member and activist, he served as a peer-advisor, spoke at schools and events, and helped other communities organize their own Outrights. In 1998, Hylton-Lemons and a few other members organized Outright's first gay prom, now an annual event. He was strongly influenced by his former doctor, Christian T. Chenard, a nurse practitioner and HIV/AIDS specialist who worked for the City of Portland Public Health Positive Healthcare Program.

Content Description

The Papers consist of a scrapbook, flyers, photographs, correspondence, speeches, news articles, and ephemera, the majority of which dates from 1996 to 1998. Materials referencing the memorial service of Christian T. Chenard, local nurse practitioner and HIV care specialist, are dated to 2007. Folder 3 contains materials related to Portland Outright, including a written testimony to the Portland City Council and records of Outright events in 1997 and 1998. Folder 4 includes a letter from Maine Assistant Attorney Stephen Wessler regarding Hylton-Lemons' involvement in the Civil Rights Team Project. Folder 5 contains a transcript of Hylton-Lemons' eulogy at the 2007 memorial service for Dr. Chenard along with the service's program and a flyer announcing the 2007 Chris Chenard Walk With The Ones You Love. Three newspaper articles dated between 1996 and 1998 were removed and can be accessed online.
