**Course description:** This course will explore issues related to recreation and tourism in western Montana. This is a field based course designed to get students outside the classroom. Students will have a chance to visit outdoor recreation areas and meet recreation and tourism managers. **Course overview and goals:** The overall objective of this course is to provide a general overview the management of parks, recreation, and tourism. Understanding these roles will help with professional development and personal understanding of career paths in the field. To introduce students to outdoor recreation resources (e.g. state and federal lands, UM Outdoor Recreation Program, Missoula Parks & Recreation) in western MT.

- To ignite a passion for exploration of recreation resources by introducing students to leaders and professionals in the field.
- To develop a cohort of students who are connected and can rely on each other to help solve challenges during their time at UM.
- To provide students with the knowledge of resources on campus to help with learning, health, and personal well-being.

**Class participation and attendance:** Students are required to attend all classes including lectures in the classroom and fieldtrips. There is one multi-day field trip to Glacier National Park. Efforts will be made to reduce the impact of these fieldtrip times on other courses.

If students choose to drive together (carpool), please note the driver is liable for not only themselves but also the passenger (as with any private vehicle). If you have a passenger in your vehicle, we recommend that you follow all safety recommendations for UM group travel:

- 1. Face masks required in all shared vehicles.
- 2. If running heat or air conditioning, recirculating vehicle air should be disabled.
- 3. All occupants of shared vehicles should travel in the same vehicle for the duration of the trip. In cases where driver fatigue occurs, wipe down high touch areas in both seating areas with appropriate disinfectant before switching drivers.

#### **Glacier National Park Reflection Assignment** (3 pages):

The purpose of this assignment is to have students reflect upon their experiences during the field trip to Glacier National Park. Students will write a 3 page (double-spaced, 12 point font) paper that addresses the following:

- Provide a brief description of the park staff we met with during the trip and their role in park, tourism, and conservation management.
- Provide a reflection on your experience in the park as a tourist- what was positive about your experience? What could be changed based on negative impacts you observed to your experience or to wildlife/trails/etc.?
- Provide a brief reflection about how this experience has encouraged you to grow as a student in PTRM and a future professional in this field.

#### **Book Reflection Assignment** (3 pages):

We will have a Book Club over the course of the semester. Students will write a 3 page (double-spaced, 12 point font) paper that addresses themes from the book and class discussions. More details will be provided once the Book Club begins.
