GENERAL COURSE PURPOSE, OBJECTIVES, AND ORIENTATION:

This course is designed to support your professional development and understanding of counselor the identity and roles, a variety of service delivery modalities, and working knowledge of current public policy and ethical considerations. We will use a combination of asynchronous learning via Moodle and synchronous virtual and in-person class meeting platforms to deliver brief lectures, host guest speakers, and engage in class discussions.

GRADING PROCEDURES AND COURSE ASSIGNMENTS: Grades will be based on completion of course assignments, quiz scores, and class participation/attendance. Course assignments include:

ATTENDANCE, PARTICIPATION, CLASS DISCUSSION: (75 points)

If you miss one in-person class, you lose 0 points; you lose 10 points for the second class missed, 25 more for missing a third class, and all 75 for missing four classes. There are no excused absences. However, because life happens and there are legitimate absences, you can talk with me about making up assignments if you are unable to attend class because of an illness, injury, weddings, family obligations, or a host of other reasons. In each of these cases you're expected to communicate with me directly with a clear explanation for your absence, in advance of or ASAP after class.

(c) Student's Choice: C.1. or C.2 (100 pts)

*C.1 Agency Selection, Interview, and In-class Snapshot Report

Visit a mental health agency and interview a counselor to increase your understanding of what day-to-day life is like for a licensed clinical professional counselor (LCPC) who works with a population and in a setting of interest to you.

- Following are some potential questions:
 - When someone asks you how being a mental health counselor is different from being a social worker or psychologist, what do you tell them?
 - Can you describe what a normal day looks like for you as you do your job?
 - What ethical and legal issues do you have to keep in mind each day?
 - What theory (or theories) inform your practice and why?
 - How does understanding and respecting multiculturalism help you as a counselor?
 - How does your knowledge of human growth and development inform your practice?
 - How do you use assessments to help you with client case conceptualization?
 - Talk about your experiences with referring clients for psychotropic medications. What advice might you give me?
 - \circ $\,$ How you determine when you need to seek consultation or supervision.
 - How have you engaged in social justice advocacy with, and on behalf of, clients outside the office setting?
 - What do you do to maintain self-care and wellness?
 - What are the most significant professional issues you face as a counselor?
- Gather enough information to provide a **15-minute slide presentation snapshot** of this job to your peers in class

*C.2 Mental health Issues Presentation or Paper

For this assignment, you will either provide an in-class presentation or write an APA formatted paper to address an issue that you will face as a mental health counselor. Explore your chosen topic by addressing the following:

- The potential causes and potential impact on clients
- How the issue relates to ethical or legal considerations for counselors
- Current methods for addressing the issue and their effectiveness
- Educational programs or trainings that are available in order to better address your topic
- Identify the steps you (or one of your peers) will need to take in order to deal with the issue

• 15-minute slide presentation or 5-page paper

*Either method will be supported by a minimum of five references.
