BLOOMINGTON, Ill. -- In the Illinois Wesleyan University freshman class of 578 students, eight members of the class of 2005 are National Merit Scholars.

The students - who come from Illinois and Indiana - plan to major in biology, psychology, English, music, and pre-medicine curriculum.

The National Merit Scholars enrolled at IWU as first-year students are:
