## Appendix 3A: What snopes.com Said About 9/11 Rumors and Legends

The following table provides a summary of 176 legends and rumors related to the 9/11/2001 terrorist attacks (and related topics about terrorists) that have been discussed on the snopes website and are archived there today.

(http://www.snopes.com/category/facts/september-11/) Most of the wording in this table is taken verbatim from the snopes site. In particular, the name of the legend (column 1) and the evaluation (column 2) are almost always taken verbatim, while the description (column 3) is generally taken verbatim but occasionally amplified or slightly modified. To avoid clutter, single or double quotation marks are not used in these columns unless they were used in the snopes original. The notes (column 4) are primarily summaries of the detailed analysis given by snopes; quotation marks are used in this column in the few occasions where snopes is quoted verbatim and not simply summarized. On rare occasion some material or commentary from the author is given that did not appear in the snopes analysis. The chapter on 9/11 Legends (Chapter 3) provides analysis that is partly based on this appendix. The value of this appendix primarily is that it summarizes and pulls into one place the snopes analysis, which would otherwise require examining 176 web pages.
