David Chandler (2009) "Hollow hegemony"

The global ideology is an ideological framework which naturalize and reifies its subject matter, posing the globalisation of politics as a matter of imposed necessity rather than a social construct which is open to critique.

Saskia Sassen (2008) "Unsettling Master Categories"

Master categories have the power of illuminating a complex issue with great efficiency. BUT they do so with clarity that is blinding. They produce a vast penumbra around the center of light.






## WE HAVE NEVER BEEN 'GLOBAL'

According to Latour, the word 'modern' is defined by:


- our careful distinctions (purification) between nature and society, between human and things, distinctions that were never made.

# WHAT IS PENUMBRA OF THE GLOBAL?

- 1. Global study concludes with policy implication for global community and governance.
- 2. Dichotomy between local and global perpetuates the same narrative told at different geographical scale
- 3. This reinforce the global a master category rather than a platform for hybrid.
- 4. Global studies would withdraw from the discussion of implementation of policies to tackle hybrid ocean issues.

#### FROM GLOBAL STUDIES TO IMPLEMENTATION SCIENCE

#### 1) Recognize that we need to leave the dichotomy between global or local 'mechanisms'

 Policies operates in a 'hybrid' of scales, research must also operate in a 'hybrid' in its conceptualization.

#### 2) Think implementation in your global studies

 Make sure that our understanding is relevant beyond the 'global policy community'.

#### 3) Provide policy performance measures

Present implementation pathways, how do we measure implementation fidelity.
