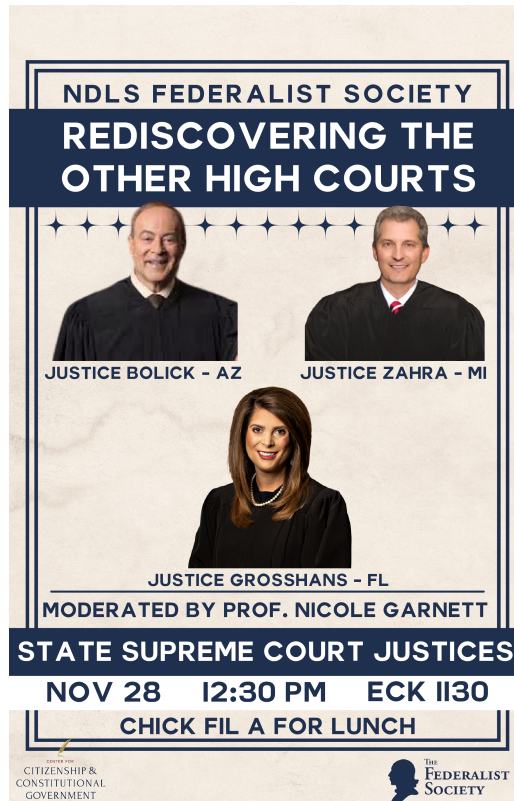

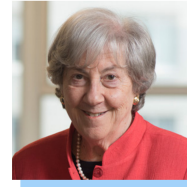

Saint of the Week: St. Catherine Labouré with Ellie Augustine

Over the summer, I went on pilgrimage to France and visited the shrine of St. Catherine Labouré. Though not as well known as other St. Catherines, I grew up well acquainted with her.

Catherine Labouré was born in France in 1806. Moved by her love for the sick, she entered the Daughters of Charity in 1830. One night, Catherine awoke to the voice of a child calling her name. The child brought her to the convent chapel, where the Virgin Mary was waiting. Our Lady urged Catherine to forge a medal displaying Our Lady as she appeared before her – in an oval frame, standing upon a globe, rays of light coming out of her hands, twelve stars surrounding her, and the words, "O Mary, conceived without sin, pray for us who have recourse to thee," surrounding her. Though met at first with disbelief, Catherine succeeded in her mission of forging the medal. Today we know it as "the Miraculous Medal."

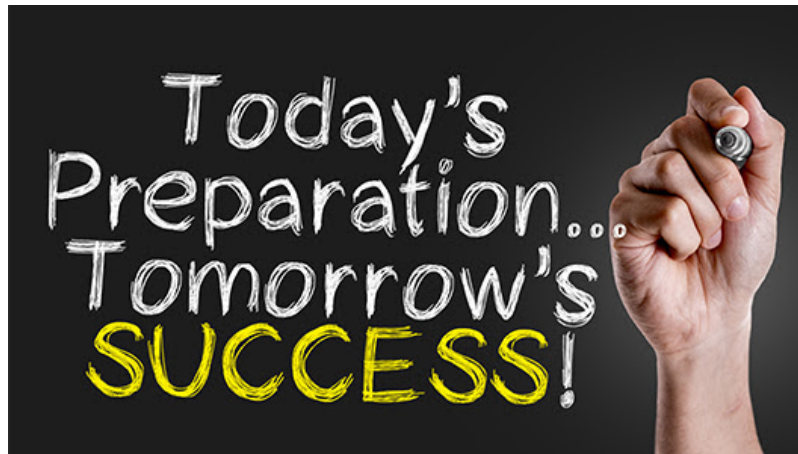


Fast forward 170 years. My mother was pregnant. Prenatal testing revealed that the baby had Down Syndrome and a number of heart problems. My mother turned immediately to Our Lady of the Miraculous Medal, praying for her baby's health.

Though due on December 12, I was born on November 28, the feast of St. Catherine Labouré, with no health complications. My mother's prayers were answered. Growing up, I was frequently told the miraculous story of my mother's pregnancy.

St. Catherine is one of the incorruptible saints, which means that her body is preserved just as it was when she died 150 years ago. This summer, I was able to visit her convent in Paris, and see the saint who, along with Our Blessed Mother, intervened in my life so personally. St. Catherine Labouré, pray for us!
