Mortgage Deed

Made and executed by John B. Cornell of the County of Franklin Ohio, in consideration of Two Thousand Dollars paid by Stephen Brinkerhoff of the same County & State, have and do by these presents grant bargain sell and convey unto him said Stephen Brinkerhoff, and unto his heirs and assigns forever, The following described premises with their appurtenances; in Pelindow Township, Franklin County, Ohio, in the second quarter, second township seventeenth Range United States Military land, and bounded as follows To Wit,

Beginning at the South West corner of the Cheever Farm, Thence North Seventy nine poles & 9 links to the Old Peter Westervelt line, Thence West One hundred poles 20/4 links along said Westervelt line, or so far as to make Fifty acres, Thence South to the Brinkerhoff, or Wagoner, Farm, Thence East to the place of beginning, to contain as aforesaid Fifty acres.

To Have and To Hold, said premises with their appurtenances unto said Stephen Brinkerhoff, and unto his heirs and assigns forever.

Provided Always, And these presents are upon this express condition, that whereas said John B. Cornell hath executed to said Stephen Brinkerhoff his promissory Notes of even date herewith for the following sums of money, To wit,

One Note for two hundred dollars due and payable

on the first day of April AD 1859. without interest until due,
One Note for two hundred dollars due and payable on the
first day of April AD 1860. with interest from and
after the first day of April 1859. at six per cent,

One Note for two hundred dollars due and payable on the
first day of April AD 1861. with interest from and after
the first day of April 1859. at six per cent,

One Note for two hundred dollars due and payable
on the first day of April AD 1862. with interest from and
after the first day of April 1859. at six per cent,

One Note for two hundred dollars due and payable on
the first day of April AD 1863. with interest from and
after the first day of April 1859. at six per cent


One Note for Five hundred Dollars. due and payable on
the first day of April AD 1864. with interest from and
after the first day of April 1859. at six per cent,

And One Note for Five hundred Dollars due and payable
on the first day of April AD 1865. with interest from and
after the first day of April. 1859. at six per cent,

Now, if the said John B. Cornell shall pay said several sums
of money to said Stephen Brinkerhoff, or his assigns, when the same
respectively become due, with the interest, then this presents to
be void; otherwise to be and remain in full force,
