I will maintain the highest standards of moral and ethical conduct.

I take these vows voluntarily with the full realization of the trust and responsibility with which I am empowered by the public.



A SHORT HISTORY OF THE SCHOOL OF PHARMACY

Pharmacy

A School of Pharmacy at the University of the Pacific was suggested in 1951 to Mr. Jess Rudkin, Director of Development, by Mr. Jacob Rehfus, a former official of the Philadelphia College of Pharmacy and Science.

A year or so later, Dr. Robert Burns, President of the University of the Pacific, Dr. Lloyd Bertholf, Academic Vice President and Mr. Jess Rudkin agreed to have a small group of community pharmacists gather for a discussion of the project. The Chairman of the Chemistry Department, Dr. Emerson Cobb, was then added to the University group and was assigned the job to confer with a number of local pharmacists to determine interest. Included in the early discussions were Angelo Sanguinetti, Edna Gleason and Leon Happell.

At the 1953 Convention of the California Pharmaceutical Association, a committee was appointed by the President of the Association, John P. Creighton, to survey the necessity for an additional School of Pharmacy in California.

By 1954, the committee had made a survey of existing California Pharmacy education facilities and had determined that existing facilities could not be expanded to handle the Pharmacy students expected in the next decade.

The University of the Pacific was reported to be one of several educational institutions in northern California which seemed to have the necessary physical facilities, staff, and interest in developing a public health facility.

In July, 1954, Dr. Burns, Mr. Angelo Sanguinetti and Dr. Emerson Cobb met in San Francisco with Mr. George Bohlken, Secretary to the Northern California Pharmaceutical Association. Out of this meeting came a motion offered by Mr. Martin Winton of Fresno, that the Association give encouragement and support to the University in the development of the School of Pharmacy. The motion was passed and Mr. Winton then pledged his personal interest and support to the project with the first monetary contribution. Enthusiasm for the new school to be located in Stockton increased rapidly and financial support from the local pharmacists and their friends was immediate.

By August 1955, President Robert E. Burns and Academic Vice President Lloyd Bertholf completed a national search for a Dean and selected Ivan W. Rowland, Dean of the College of Pharmacy at Idaho State University to lead



California's new School of Pharmacy. Former Dean of the College of Pharmacy at Idaho State University, Emmons E. Roscoe, resigned his Idaho teaching position and accepted the first teaching position in Pacific's School of Pharmacy.

The first classroom and laboratory for the new School began operating

in the Fall of 1956 in Weber Hall.

The first graduation ceremony for 16 seniors was held in June, 1959. By 1960, the School had reached the peak enrollment of 250 students. The first grant for research support came from the office of the U.S. Department of Navy and the first graduate student was Mrs. C. Kihara who completed the

work for an M.S. Degree in Physiology-Pharmacology in 1961.

Mr. Henry Herold, a member of the Pfeiffer Research Foundation came to Stockton to see Pacific's School of Pharmacy. He visited with Dean Rowland and out of this conversation, there developed a \$150,000 challenge grant from the Pfeiffer Research Foundation to build a new School of Pharmacy at Pacific. In August of 1964, the U.S. Department of Health, Education and Welfare of the Public Health Service, was asked to furnish funds for a new School of Pharmacy estimated to cost 3½ million dollars. An H.E.W. grant of \$1,624,683 to assist in the building of the new School of Pharmacy was announced on July 22, 1965.

Construction got under way in January 1968 and the buildings were completed on schedule by September, 1969. In April, 1971, the Pharmacy School

was dedicated and accepted by the Board of Regents.

Dean Ivan W. Rowland announced his retirement as of September 1, 1980. Dr. Louis C. Martinelli, Pharm.D., Ph.D. was selected as the new dean of the School of Pharmacy effective September 1, 1980.

He came to Pacific from the Creighton University School of Pharmacy

in Omaha, Nebraska where he was Dean.

On March 1, 1983, Dean Martinelli concluded his service to the School of Pharmacy and Dr. Warren J. Schneider was named Acting Dean of the School of Pharmacy.

Dr. Schneider was appointed to the faculty of the School of Pharmacy in 1972 as Professor of Physiology-Pharmacology after serving for 25 years in the Army Veterinary Corps. He was appointed Assistant Dean for Pharmaceutical Sciences in 1981. He was named Dean on August 1, 1983.

Upon the death of Dean Warren J. Schneider on February 11, 1984, Dr. Oscar Jarvis, Academic Vice President, named Associate Dean Robert B. Supernaw as Acting Dean of the School of Pharmacy. Dr. Supernaw was



appointed to the faculty of the School of Pharmacy in 1974. In 1983, Dr. Supernaw was appointed Associate Dean for Academic Affairs. He is a graduate of the University of the Pacific Schol of Pharmacy receiving his doctorate in 1972.

In 1984, the University of the Pacific selected Donald L. Sorby, Ph.D. to head its School of Pharmacy, beginning November 1, 1984. Dr. Sorby was Dean of the University of Missouri School of Pharmacy for 10 years, and has been a pharmacy educator for 27 years. Dean Sorby has been President of the American Association of Colleges of Pharmacy. He has been a consultant to pharmacy schools and governmental agencies.

Dean Sorby received his Bachelor of Science degree in Pharmacy from University of Nebraska in Lincoln, and received his Master of Science degree

and Ph.D. degree from the University of Washington.

Physical Therapy

In the spring of 1985, the University of the Pacific established a program of study leading to the Master of Science degree in Physical Therapy. Responsibility for the program was assigned jointly to the School of Pharmacy and the Graduate School. A Department of Physical Therapy was established in the School of Pharmacy at that time. Jean I. Baldwin, Ph.D., was appointed as the Founding Chairperson of the Department of Physical Therapy in June, 1985.

Additional faculty were recruited in 1986 and 1987 until full staffing of the department was achieved. The first complement of 30 students enrolled in the Physical Therapy program in the fall semester of 1986. The Department of Physical Therapy received Candidate Status for Accreditation from the American Physical Therapy Association in the fall of 1986. Full accreditation was awarded by the American Physical Therapy Association in March of 1988. Graduation from this fully accredited program enables the graduate to sit for the licensure examination in Physical Therapy.

Dr. Baldwin retired in September, 1990. Appointed to succeed her in January, 1992, after serving in an interim capacity are Chairperson Carolyn Hultgren, M.P.H., P.T., and Darcy Umphred, Ph.D., P.T., Vice-

Chairperson.



HISTORICAL BACKGROUND OF THE MACE

The University Mace — Originally a weapon of offense used in medieval warfare by a king or a noble, the mace has been refined to a symbolic device used on ceremonial occasions. The mace, as an academic symbol, dates back to 16th century England when Queen Elizabeth I presented a replica of her own royal mace to the corporation of the University of Oxford. She ordered that it be used in all ceremonies to represent the royal presence and the authority given to the university to grant degrees under the royal insignia. King Charles I made a similar gift to Cambridge University in 1625.

Robert E. Burns, president from 1946-1971, commissioned Stuart Devlin, an internationally known London silver designer, to create the University of the Pacific Mace. It was commissioned in recognition of the University's transition from a college to a university with several colleges and professional schools that were to be modeled after Oxford and Cambridge. It was first used at a Founder's Day ceremony on March 6, 1966.

The Mace is constructed entirely of silver with a gold plated seal of the University in its head. The Mace is approximately four feet long and weighs 15 pounds. It was a gift to the University by Mrs. Winifred Olson Raney, a Regent of the University.

The Mace is displayed at all official University functions and generally is carried by the Chair of the Academic Council at University-wide Commencement Ceremonies.

BACKGROUND OF THE SCHOOL'S BANNER - PHARMACY

The green field depicts the pharmacy profession. It surrounds a new emblem for the School of Pharmacy which consists of the Bowl of Hygeia. Hygeia is the Greek Goddess of Health and is the traditional emblem of pharmacy much as the caduceus represents medicine. The School's modernized version is an adaptation of the official emblem of the American Pharmaceutical Association.



SIGNIFICANCE OF ACADEMIC REGALIA

Distinctive academic dress can be traced back to the universities of the middle ages when students and faculty of universities wore the robes of the clergy. Today three ranks of degrees are distinguished through variations in the robes, which also indicate the discipline and the university that awarded the degree.

In the United States, gowns generally are black, although a few universities have adopted other colors for their doctoral gowns: Harvard, crimson: Yale, blue: Chicago, maroon: Dartmouth, forest green.

The field of learning in which the degree is awarded is shown by the color of the edging of the hood, and in some cases by the color of the facing and crossbars on the doctoral gown.

Some of the more frequently seen colors are: white (Arts and Letters), pink (Music), dark blue (Philosophy), light blue (Education), scarlet (Divinity), golden yellow (Science), lilac (Dentistry), olive green (Pharmacy), and purple (Law).

The colors of the lining of the hood are those of the institution awarding the degree. For example, the University of California colors are gold and blue; Stanford University, cardinal; University of Michigan, maize and azure blue; University of the Pacific, burnt orange and black. An olive green tassel is often worn on the cap to signify the field of Pharmacy, although generally bachelor's and master's tassels are black. Doctoral tassels generally are gold. The left side of the mortarboard is the proper side to wear the tassel after graduation.

An individual's degree is revealed by the type of gown and width of the edging on the hood. These are the designs:

BACHELOR'S GOWNS have full, pointed sleeves with no trimming and the hoods have a two-inch edging.

MASTER'S GOWNS prior to 1960 had full, closed sleeves with the arm emerging through a slit at the elbow. The gown has been the despair of wearers because, no matter how hot the day, a coat must be worn under the gown. In 1960, however, the gown was modified. In place of the elbow slit, an opening was made at the wrist and the gown was made to close. The hoods have a three-inch edging.

DOCTOR'S GOWNS are of silk, have rounded sleeves, velvet facing down the front, and three velvet crossbars on each sleeve. The hoods have side panels and a five-inch facing.
