I

In reply to your above-mentioned telefax of 4 June 1993, I wish to inform you of the following:

(i) You will shortly receive by overnight express mail, the bulletins that were requested and received from UNPROFOR on 14 June. As regards UNPROFOR and CIVPOL reports, Mr. Kalshoven will raise the question with Mr. Annan in New York to ensure that the Commission Secretariat receives them on a regular basis.

(ii) UNHCR has been submitting all relevant information re the conflict in the former Yugoslavia to the Commission Secretariat on a regular basis. Lt-col Kempnaars has been informed by UNHCR that it will also submit to the Commission Secretariat its weekly reports on the said conflict;

(iii) Information on the Bratunac mass grave has been requested from the Permanent Representative of Yugoslavia to UNOG;

(iv) LT-Col Kempnaars met on 15 June with Mr. Miserez, ICRC. Mr. Miserez has informed LT-Col Kempnaars that he is ready to answer any specific questions concerning the geographical and infrastructural characteristics of camps. Also, Mr. Miserez will update and correct the list of camps that you sent to us and which was submitted to him.

(v) LT-Col Kempenaars has contacted the Council of Europe and UNESCO requesting their reports on Dubrovnik. The said reports will be forwarded to you upon receipt by the Commission Secretariat.

Please note that, together with the bulletins mentioned at (i) above, I will also send to you a list of the organizations or entities that have submitted information relating to the issue of rape, as requested. In addition, we are returning to you herewith the map of the former Yugoslavia showing places of detention in Sarajevo, Prijedor and Brcko that you had given to Lt-col Kempenaars.

## II

As regards your telefax of 14 June 1993, you will also receive by overnight express mail the text of General Assembly resolution 47/133 of 18 December 1992.

The CEDAW Secretariat in Vienna confirmed to me by telephone on 14 June that no report has been prepared by CEDAW on the status of woman in the former Yugoslavia. Instead, CEDAW has requested the Government of Yugoslavia to submit such a report, which has not been done as yet.

Lastly, I would greatly appreciate it if you could send to us a brief paragraph on "the impressions" of the group during the mission to the capitals of the former Yugoslavia, as discussed, for insertion in the mission report.
