
# Abstract

Women in Iran are not allowed representation in government and do not have legal rights in many aspects. According to studies, Iranian women lack rights regarding family matters and are required to wear a hijab or face prison time. They have little protection from violence including capital and corporal punishments, which are still used on women who defy these policies in Iran.
