An Exploration of Pediatric Occupational Therapist's Perspectives of **Functional and Assistive Mobility**

BACKGROUND

- Early independent functional mobility can positively affect the development of psychological, social, and physical functions (Anderson et al., 2013).
- Assistive mobility devices support development and enhance play and social participation in children with limited mobility (Arps, et al., 2021; Bradbury, et al., 2021; Livingstone, et al., 2022).
- OTs have an important role in addressing the ability to engage in occupations and developmental needs associated with occupational participation.
- Research is limited on pediatric OTs' perceptions of their role in functional mobility and assistive mobility and whether or not they are incorporating these skills into practice

PURPOSE




METHODS


- Exploratory study using a mixed-method research design.
- Online survey sent to licensed occupational therapists working in pediatric settings in California (N=20) and an option follow-up interview (N-4).
- Descriptive statistics and thematic analysis were used to analyze and summarize trends and differences in the data.
