



The enrollment in the school at the opening in September was: Grade I, 1; Grade II, 1.

In submitting his first Annual Report the Superintendent wishes to state that it has been a pleasure to work in a school union where he formerly attended the public schools.

The school financial statement shows total credits of \$1,100.76 with expenditures of \$891.05 and an unexpended balance of \$209.71. The unexpended balance is due to a combination of several things, the most important of which is the fact that your teacher, Mrs. Torrey, was willing to accept a contract for less than the minimum salary law required. The Town of Beddington was also exceptionally fortunate in being able to secure special permission through the State Department of Education to operate the school on a halftime basis because of the small enrollment. These two facts alone enabled your School Committee to operate your school at a greater saving. Under present conditions there is no Equalization for the Town of Beddington to maintain their school.

The budget estimates for the coming school year have been carefully prepared. The amount of money recommended by your Superintendent and School Committee should take care of the school expenses for the year 1948-49 providing we operate this coming year with a similar set-up. You will notice that the estimated expenditures for next year calls for \$847.00 with anticipated credits of \$576.77. This makes a necessary appropriation for the citizens of Beddington to raise \$270.23. Your Superintendent and School Committee are recommending an appropriation of \$300 in order that they may have a little extra to work with in case of need. This figure of \$300 is considerably less than last year's appropriation. Another year it will of necessity be greater as the budget has been figured at a minimum and there will probably be very little in an unexpended balance left to carry forward to another year. If it is your desire to ease the tax burden over a period of years, you would do well to

appropriate as much in exc. s of \$300 that you would feel able to therby accumulating an anticipated unexpended balance for another year of a sizable amount.

In closing, I wish to express my appreciation to the members of the School Committee, teacher, school employees, citizens, and pupils for the cooperation they have accorded me during the year.
