Scholarly Publication "Crisis"

- Electronic licensing of journals prohibitively expensive for many libraries
- Concentration of academic publishers monopoly over scholarly knowledge production
- Increasing commodification of knowledge/information

Scholarly Publishing Context

- Pricing and permissions crisis
- "Vanity factor" in academic publishing
- Social impact of research and knowledge dissemination
- Changes in technology
- Financial incentives in scholarly publishing

The Access Principle

"A commitment to the value and quality of research carries with it a responsibility to extend the circulation of this work as far as possible, and ideally to all who are interested in it and all who might profit by it..." (p. 5)

Open Access in an International Context

- Access for scholars and students in the Global South
- Development of new knowledge
- North-South / South-North / South-South knowledge exchanges
- Addressing inequities in both access and scholarly knowledge production
- Majority of scholarly knowledge production in Global North

- New discoveries
- Progress in health
- Economic development
- Increased global knowledge sharing and collaboration
