COURSE AIM: *To understand the connections between production planning and production process, to demonstrate directorial practice through production, in generating dramaturgical materials for the development of a full understanding of the script by designers and actors, planning and running an appropriate rehearsal process and bringing the work to its audience.*

COURSE OUTCOMES: *By the end of the semester, you will demonstrate*

- *An ability to interpret, analyze, and conceptualize scripts as appropriate to the graduate student's production assignment*
- *An ability to coach actors in the areas of speech, movement and method according to the required styles*
- *An appreciation of the heightened performance levels and staging/aesthetic possibilities of the period/s*
- *A knowledge of the scripts, playwrights, theory, context, and history of the period/s*
- *An ability to also directorially re-envision or reinterpret the relevant play through a contemporary staging lens*
