Society for Hindu-Christina Studies Book Award

An early meeting of the Society decided to offer a book award every three years to an author for an outstanding publication in Hindu-Christian studies. The first such award was given at the 1997 annual meeting to Francis X. Clooney for his most recent book, Seeing Through Texts: Doing Theology Among the Srīvaisnavas of South India (SUNY, 1995). One session of the annual meeting was a discussion of Professor Clooney's book with his response.

Over a dozen texts were evaluated by the awards committee (William Cenkner, Daniel Sheridan, Judson Trapnell) with three texts moving into a final round of selection at which time the committee was increased (Anuttama Dasa, Anant Rambachan).

The committee saw Clooney's book much in line with his previous work in comparative theology, both in articles and his recent book, *Theology After the Vedānta*. He attempts to study a tradition from both the inside and outside, that is, the capacity to speak out of another tradition while committed to his own tradition. His profound

reading of Śatakōpan's *Thiruvāymoli* gives him the capacity to "see through a text" to a new reading of his own tradition. The awards committee noted his passion for the text, the excitement with which he engages it, and the unique construction of a new biblio-biographical self that results.

The next book award will be given in the year 2000, covering the preceding three years, 1997-99. The Society appointed Clooney as the chair of the awards committee for this evaluation.

Report on the 1997 Annual General Meeting

The 1997 annual meeting of the Society was held on Friday-Saturday, 21-22 November, in San Francisco. This year for the first time the meeting was expanded to two sessions. At the first session, Friday evening, John B. Carman (Harvard Divinity School) presented a paper, "Extending the Christian Doctrine

of the Logos to Interpret Hindu Bhakti". Respondents were William Cenkner (The Catholic University of America) and Vasudha Narayanan (University of Florida). The Saturday morning session began with the presentation to Francis X. Clooney, S.J., (Boston College) of the Society's "Best Book in Hindu-Christian Studies, 1994-96" award. Vasudha Narayanan, the Society's president, was the presenter. There followed a panel discussion of the book, Clooney's Seeing Through Texts: Doing Theology Among the Srivaisnavas of South India. Panelists were Harold Coward (University of Victoria), T. S. Rukmani (Concordia University), and M. Thomas Thangaraj. Professor Clooney responded. At the business meeting, which followed the discussion of Clooney's book, Laurie Patton (Emory University) and Selva Raj (Albion College) were elected to the Society's Board of Directors.
