Administrative history:

Kimberly, Clark & Company was founded in Wisconsin in 1872. The founding partners were John A. Kimberly, Havilah Babcock, Charles B. Clark, and Frank C. Stattuck. That same year, the company built the Globe Mill, which made newsprint from linen and cotton rags. The company soon established a reputation for developing new and innovative paper products and processes. In the 1920s, Kimberly-Clark opened a Canadian Pulp Mill and Power plant known as the Spruce Falls Power and Paper Company, in Kapuskasing, Ontario. Other branches of Kimberly-Clark were established in Ontario at Huntsville and Terrace Bay.

Scope and content:

The records contain material about Kimberly Clark Canada and their operations in Canada. The bulk of the material is correspondence and media releases. Some news clippings, invoices and promotional material are also included. Duplicates were removed and discarded. Many of the original file names were retained. Within folders, material is arranged chronologically.

The records were organized into three series:

Series III: Promotional material, 1969-1986

- 2.43-2.53 Promotional material, 1969-1986. Includes brochures, booklets, newsletters, news clippings and photographs about the Huntsville mill, Terrace Bay mill, Kapuskasing mill, and pollution. There is also a media package about a new Kimberly-Clark product, Depend undergarments (1986).
