# Fertilizer Inspection and Analysis; Spring, 1949

This bulletin is published semi-annually to familiarize manufacturers, dealers, and users of commercial fertilizer with the results of the fertilizer inspection and analysis work carried on by the Missouri Agricultural Experiment Station. This issue covers the period January 1 to June 30, 1949.

The Missouri Fertilizer Law requires the seller to take certain steps before his fertilizers may legally be offered for sale in this state. Briefly these requirements may be summarized into three major classifications: (1) registration with the Experiment Station which must state the name of the manufacturer, the brand name, and the guaranteed chemical analysis, (2) the attachment of a dated registration tag to each container (tags must be purchased from the Experiment Station in the current year), (3) proper labeling or identification of the bag or container.

Though the law protects the manufacturer from competition of inferior goods, which often are not properly labeled, its primary purpose is the protection of the purchaser. The intent of this law is to make available to the purchaser complete information concerning the contents of fertilizers being offered for sale in Missouri. Since this effort is made to protect the buyer, it is highly recommended that he accept only those materials that are fully labeled as to manufacturer, brand name, and guaranteed analysis.

## INSPECTION

The inspection work covered by this bulletin began March 1 and was carried on throughout the 1949 spring fertilizer season. Inspectors traveled a total of 10,754 miles calling on 520 dealers located in 273 Missouri cities, towns, and communities. Each county in the state is represented by at least two of the 1011 official samples collected. An effort was made to obtain samples of every brand and analysis of fertilizer offered for sale in Missouri. The number of samples collected of a particular brand does not necessarily indicate the proportion of that fertilizer sold in the state. However, an attempt was made to secure a large number of samples of those brands and grades which were sold more extensively. This resulted in the collection of one sample for approximately every 216 tons of commercial fertilizer sold during this period.

**VIOLATIONS REPORT FOR SPRING 1949****1. SALE OF NON-REGISTERED FERTILIZER**

### 3. VIOLATIONS WITH RESPECT TO LABELING

**M. F. A. Muriate of Potash 60%.** This material was registered and offered for sale by Missouri Farmers Association, Columbia, Missouri. When found at several of the Missouri Farmers Cooperative stores it bore the label of the original manufacturer which did not agree with the registration certificate. The Missouri Fertilizer Law provides that the labels must make the same statements as made on the registration.

**20% Granulated Superphosphate and 4-24-12.** These fertilizers were being offered for sale by the Farm Bureau Service Company of Missouri and found at two of the above named company's stores. The only identifying labels to be found on the bags were tags which specified that the contents was 20% Granulated Superphosphate in the case of that material. The bags containing the 4-24-12 were not labeled in any manner. The law provides that each package or container shall have stamped or affixed to it a plainly printed statement which shall certify the brand name, the name and address of the manufacturer, and the guaranteed chemical composition of the fertilizer. These fertilizers were being marketed in violation of the above provisions.

**25% Manure Salts.** This material was found on sale at Burchfield Milling Company, Marshfield, and Kennett Grain and Seed Company, Kennett. In each case the manure salts was purchased in bulk through Lange Bros., St. Louis, Missouri, and was bagged by the dealer. The bags used for this purpose were devoid of labels. For the protection of the consumer the Missouri fertilizer law specifies that each container must be properly labeled as set forth in the preceding paragraph.

**Pulverized Phosphate Rock.** This material was marketed by Schrock Fertilizer Service, Congerville, Illinois. It was registered as Schrock Natural Phosphate and labeled Pulverized Phosphate Rock. On the registration certificate the company guaranteed 3 per cent available and 29 per cent insoluble phosphoric acid. However, the bags were labeled and sold only as containing 32 per cent total phosphoric acid. The law provides that only a bone fertilizer may be sold under a guarantee of total phosphoric acid.

### ANALYSIS OF SAMPLES

Each official sample collected was analyzed by the Experiment Station laboratories located at the University of Missouri, Columbia. These results are set forth in this bulletin by the use of three tables. Tables 1 and 2 summarize the analyses in order that the reader may tell at a glance the relative manner in which manufacturers have met guarantees. Table 3 presents in greater detail a description of each individual sample.

Table 1 compares, by the use of an index number, the amount of plant food present in the sample with that of the guarantee of the manufacturer. If the found value and the guarantee are the same the number 100 is used; should the guarantee be exceeded by the found value the number used is greater than 100; and in the event the guarantee is not equalled by the found value the number used is less than 100.

Table 2 summarizes and expresses as a percentage the deficient nutrients to total analyzed. In this table each of the three primary elements is considered as a sample so that the grand total in this table is greater than the actual number of samples collected.

Table 3 includes the brand name, place of collection, analytical results, and guarantee of each official sample. Where there are two or more like samples of any brand the average analysis is given. If the guarantee is not equalled by an element that figure is underlined and such a sample is classed as deficient.

### FERTILIZERS REGISTERED FOR SALE IN MISSOURI IN 1950

Table 4 is a list of companies, brand names, and guaranteed analyses of those fertilizers registered for sale in Missouri for 1950 as this bulletin goes to press.
