Prohibits employers from interfering with this right and provides an enforcement mechanism through the Administrator of the Wage and Hour Division of the Employment Standards Administration of the Department of Labor. A "flexible work program" provides full- or part- time flexible work schedules and full pension and health care benefits. They would not be considered employees for the purposes of retirement and would receive no additional retirement benefits based on a limited time appointment.
